Data Show National Coal Corporation's Tennessee Mine Emits Toxic Selenium

The Sierra Club, Tennessee Clean Water Network (TCWN) and Save Our Cumberland Mountains (SOCM) last month put the National Coal Corporation on notice for allegedly dumping harmful amounts of toxic selenium pollution into Tennessee waterways from its Zeb Mountain coal mine.

Data show that the huge mountaintop removal coal mine, located in Campbell and Scott Counties, Tennessee, has been discharging unlawfully high levels of selenium into nearby bodies of water. Indeed, National's own most recent samples show that they are discharging selenium from 12 sediment basins in the permit area.

"Anyone who eats fish caught near this area risks exposure to toxic levels of selenium," said Ann League of Save Our Cumberland Mountains. "The Zeb Mountain mine's toxic dumping threatens our health and well-being; they need to be held accountable."

Selenium can be extremely toxic to people, causing hair and fingernail loss, kidney and liver damage, and damage to the nervous and circulatory systems. It also bioaccumulates in fish, causing severe impacts including reproductive failure, birth defects and damage to gills and internal organs.

The Environmental Protection Agency (EPA) currently sets the standard for selenium at 5 micrograms per liter, although many experts recommend that the standard be set even lower. Studies have shown that concentrations of 10 micrograms per liter can cause complete reproductive failure in reservoirs and a 40% reduction in streams.

On April 29, 2008, Sierra Club and Save Our Cumberland Mountains obtained a water sample showing that one of the sediment basins on Zeb Mountain was discharging 47 micrograms per liter of selenium. National's own sample taken on June 12, 2008 shows a concentration of 100 micrograms per liter at the same basin.

The Sierra Club, TCWN and SOCM sent National Coal Corporation and National Coal Corp. a formal notice of intent to sue on July 9, 2008. The organizations are represented by Gena Lewis and Joe Lovett with the Appalachian Center for the Economy and the

Environment, Jim Hecker with Public Justice and attorney Mary Mastin.

National Coal Corp. also has applied for a NPDES (National Pollutant Discharge Elimination System) permit from the Tennessee Department of Environment and Conservation (TDEC), which has jurisdiction over water quality and pollutant discharges from mines.

TDEC must now decide whether to grant National Coal a permit that takes into consideration the selenium discharges, which exceed Tennessee's water quality standards. TDEC can either force National Coal to treat its mine discharges to bring the selenium levels into compliance with state standards, with a compliance schedule; or decide to simply monitor the discharges; or deny the permit application.

"The ball is now in TDEC's court. What they decide to do about the permit application will determine our course of action in litigating this issue," said Axel Ringe, chair of the TN Chapter's Water Quality Committee.

Wilderness First Aid Training October 17-19, 2008

The Tennessee Chapter Sierra Club is sponsoring a second wilderness first aid training (WFA) course on October 17-19, 2008 at Laurel Fork Lodge on the Appalachian Trail near Hampton, TN. Landmark Learning, LLC, our training provider for the previous five years, will provide the training again this year, teaching the National Outdoors Leadership School (NOLS) WFA curriculum. This educational weekend features top notch training in an outdoor setting by field experienced instructors.

Course: WFA - 16 hours / 2-yr certification.

Fast paced and hands-on, this two-day course covers a wide range of wilderness medicine topics for people who travel in the outdoors or who spend time in the backcountry as either a passion or profession. In this course you will learn to prepare for the unexpected. You will acquire knowledge and skills that will help you make sound decisions in emergency situations. This course is ideal for trip leaders, camp staff, outdoor enthusiasts and individuals in remote locations. This NOLS course is pre-approved by such organizations as the American Camping Association and the U.S. Forest Service. Know Nuclear in the TN Valley Saturday, 11:30am - 6pm, September 27 **Keathley University Center** MTSU Campus Murfreesboro, TN

Know Nuclear in the TN Valley is an opportunity for community leaders, environmental advocates and concerned citizens to learn more about nuclear waste and the nuclear industry in Tennessee. Registration for the half-day seminar begins 11:30am and the program begins at noon, Saturday September 27. It will be held in Room 322 of Keathley University Center on the MTSU campus in Murfreesboro, Tennessee. A \$10 registration fee payable at the door covers the cost of refreshments and seminar handouts. Students with ID cards are free.

The seminar will cover nuclear waste processing, burning and dumping in TN; the storage and transport of high level nuclear waste generated in our state; and the concerns for TVA's current nuclear power program. Its purpose is to inform concerned citizens about the need to stop generating nuclear wastes and to responsibly manage the nuclear wastes we already have.

Three panels of community, regional and national activists will speak to these concerns.

- The nuclear industry and the Department of Energy are using Tennessee as an unlicensed nuclear waste dump. A panel will describe the import of nuclear waste into Tennessee from across the nation and world; how nuclear waste is getting into our county and city landfills; what Nuclear Fuel Services is doing in Jonesborough, TN; and how Memphis continues to be a watchdog for lowincome communities living near two companies that process so-called low-level nuclear waste, as well as their victory in stopping a nuclear waste incinerator from coming to downtown Memphis.
 - The nuclear industry is allowed to continue to

make nuclear waste even when we have no way to manage it. A panel will describe why nuclear waste storage of irradiated fuel next to nuclear reactors poses such a serious threat to nearby communities and the risks of transporting high level nuclear waste.

• TVA has reentered a massive nuclear power plant construction campaign. A panel will describe the public health risks of TVA's current operating plants and the growing opposition to the proposed Bellefonte nuclear plant and new plant construction around the Southeast.

After each panel, small groups will identify what they have learned and next-step strategies. Participants will be given a notebook of brief summaries of the panel presentations and other background information.

2008 Legislative Scorecard

A new release for Tennessee Conservation Voters

Every year, the Tennessee Conservation Voters (TCV), a non-profit bipartisan organization of which the Sierra Club is a member, releases a scorecard on our Tennessee state legislators' environmental voting records. TCV selected a number of environmental bills that were introduced into the 2008 legislative session. During the session, the performance of each legislator on each bill is examined. A total score of their actions on all the bills is assigned.

In TCV's scorecard, legislators who sponsored or voted for a pro-environment bill or voted against an anti-environment bill or amendment at any time in this process received a "+1". Legislators who voted for or sponsored an antienvironment bill or voted against a pro-environment bill received a "-1." The numbers in the columns "Positive Environmental Actions" and Negative Environmental Actions" in the scorecard refer to the numbers that were assigned to the bills in the bill description section. In order to see which bills your legislators had the chance to vote on, you must find the bills that are represented by the numbers in the columns. Bills that a legislator sponsored are noted by parentheses. Legislators' net scores are the number of positive actions minus the number of negative

Important note: The opportunities for getting positive or negative points varies because not all legislators were on committees that considered environmental bills. Some legislators who might

well vote for pro-environment bills may not have the opportunity because the bills do not get out of committee. Also, when a good bill gets out of committee and reaches the floor, many will vote in favor because it seems likely to pass. While the scorecard gives a good general sense of how legislators support the environment, legislators' scores should not be directly compared unless they had an opportunity to vote on the same bills.

Index of Actions

- 1. SB 116/HB 348 replaces current minimum energy conservation standards for new residential construction with the more recent 2003 Intl. Energy Conservation Code. Became law as Public Chapter 907. Positive points for House sponsorship. Positive or negative points for House Environment Subcommittee vote and full House vote.
- 2. SB 1408/HB 1829 would enact the TN Beverage Container Act to reduce litter and increase recycling. Bill was deferred in Senate Environment. Positive points for sponsorship. Positive or negative points for Senate & House Government Operations Committee vote.
- 3. SB 2671/HB 2895 would raise tax on coal products, establish an account for the assistance of counties affected by coal mining and reclamation of land/waters damaged by prior mining. Also would provide tax exemptions for renewable energy products. Bill taken off notice in Senate Finance and failed in House Budget Subcommittee due to lack of a motion. Positive points for sponsorship. Positive or negative points for Senate & House Finance Subcommittee votes.
- 4. SB 2716/HB 2794 authorizes low emission and energy-efficient vehicles to drive in high occupancy vehicle (HOV) lanes. Bill has been signed by Governor but hasn't been assigned Public Chapter as of 6/16/08. Positive points for sponsorship.

7. SB 2874/HB 2817 requires participation in energy management programs by state agencies and universities. Became law as Public Chapter 718. Positive points for sponsorship.

8. SB 2979/HB 3482 will improve water quality testing on Pigeon River. Became law as Public Chapter 767. Positive points for sponsorship.

9. SB 3125/HB 3296 would improve protections related to harvesting of timber. Failed in House Agriculture Committee. Positive points for sponsorship. Positive or negative points for amendment vote in House Agriculture Committee.

10. SB 3235/HB 3368 would curtail development of new outdoor advertising. Bill filed but no committee action was taken. Positive points for sponsorship.

11. SB 3310/HB 3789 would implement energy conservation techniques for state building commission projects. Bill referred to Energy Task Force for review. Positive points for sponsorship. Positive or negative points for Senate State & Local Government vote.

12. SB 3565/HB 2615 as amended in the House, would require a study committee to examine the possibility of generating TWRA funding through oil & mineral leases. Sen. L. Finney successfully moved to strip the House amendment; bill passed to create study committee. Bill has been signed by Governor but hasn't been assigned Public Chapter as of 6/16/08. Positive or negative points for vote on amendment on House Floor.

13. SB 3651/HB 3521 would authorize TDEC to issue a stop work order for violations of the Water Quality Control Act. Bill was taken off notice in Senate Environment and failed in House Environment Subcommittee due to lack of a second. Positive points for sponsorship. Negative points for failure to move bill in House Environment Subcommittee.

14. SB 3822/HB 3348 would restrict issuance of coal mining permits relative to altering ridge lines above 2,000 ft. Bill passed Senate Environment and failed in House Environment Subcommittee. Positive points for sponsorship. Positive or negative points for Senate Environment and House Environment Subcommittee vote.

15. SB 3966/HB 2511 would prohibit TDEC from taking action to enforce penalties based on information from anonymous source. Bill filed but no committee action was taken. Negative points for sponsorship.

16. SB 4039/HB 4039 creates the Energy Efficient Schools Initiative of 2008 to establish energy efficient design and technology guidelines for all K-12 facilities. Bill has been sent to Governor but hasn't been assigned Public Chapter as of 6/16/08.. Positive points for sponsorship. Positive or negative points for Senate or House floor votes.

17. SB 4119/HB 4185 would remove intermittently flowing water from regulation under the Water Quality Control Act. Bill did not pass. Negative points for sponsorship. Positive or negative points for House Environment Subcommittee vote.

18. SB 4198/HB 4198 would restrict certain destructive rock harvesting practices. Bill taken off notice in Senate Environment Committee and deferred in the House. Positive points for sponsorship.

19. SJR 612 urged creation of a comprehensive state plan to address climate change and limit greenhouse gas emissions. Resolution taken off notice in Senate Finance. Positive points for sponsorship.

20. HJR 1185 would create the Tennessee Locally Grown and Organic Farming Impact Task Force. Deferred in House. Positive points for sponsorship.

21. SR 259/HR 349 urged Regulatory Commission not to import radioactive waste from Italy due to possible environmental contaminants from transportation and storage. Resolution failed in Senate Finance, deferred in the House. Positive points for sponsorship. Positive or negative points for

Senate Finance vote.

22. HJR 938 urged TVA to approve construction of the Campbell County Lodge at Norris Dam State Park. Resolution passed House unanimously, referred to summer

study in the Senate. Negative points for sponsorship.
