We need to let the Forest Service know about conflicts between skiers and snowmobiles. - <u>Sunday, January 19, Snowshoe Knolls, Scenic Loop Rd. To Shady Rest.</u> A 5-mile leisurely snowshoe hike in the Knolls from the Scenic Loop Road trailhead to the ballpark parking lot at Shady Rest, returning mid-afternoon. The first half is mostly flat to rolling terrain, and the remainder is mostly downhill. Car shuttle required. Adjustments may be made for snow conditions and car availability. Meet ML Union Bank parking lot, 9am, to carpool. Well-behaved dogs OK. Skiers welcome, but group will travel at a snowshoeing pace. • SHADY REST PARK WINTER USE AND RESPONSIBLE DOG OWNERSHIP. The Town of Mammoth Lakes and the Inyo National Forest are reminding residents and visitors about proper dog etiquette and to inform recreation users of the existing laws pertaining to responsible dog ownership in Shady Rest Park and on the Shady Rest Nordic Trails. The prevalence of dogs off leash at Shady Rest Park and the overwhelming amount of dog waste found there is not only a major safety concern for staff, but an escalating environmental issue and significant health risk for the community. Per Inyo National Forest Order 04-93-1, it is prohibited to be on the Shady Rest Designated Cross-Country Ski Trail (those specifically groomed for Nordic skiing) without skis and allowing dogs to be on the trail (36 CFR 261.55(a)). Leave No Trace principles for visitors to national forest lands includes dogs. The Town of Mammoth Lakes Municipal Code "Prohibits dogs and cats on park property unless kept on a leash at all times and under full control of the owner. The removal of feces of animals who defecate on park property is required of the owner or custodian of the animal." The fine for non-compliance is \$150 per violation. Per 36 CFR 261.16 (j) dogs must be on leash within a developed recreation site. U. S. Forest Service fines \$180 for failure to comply with these rules. - Well #385, in the Five Bridges area near Bishop, was shut down more than 30 years ago because of negative impacts. When LADWP announced a drilling project for this well, Sierra Club and the Owens Valley Committee sued. An agreement was reached in December to allow a two-month test operation this winter of any effect of pumping from the deep aquifer on 29 area wells. - The LADWP is studying the possibility of storing large quantities of excess water runoff from the eastern Sierra in the **deep aquifer under Owens Lake**, to be used to mitigate dust pollution.

- The National Park Service has been following up on the Trump administration directive to allow **e-bikes on public lands** trails which allow non-motorized bikes. In California, Death Valley National park is among the units listed for e-bike usage. This has led to a lawsuit supported by various environmental groups challenging the directive. - The new 2019 **Land Management Plan** for the Inyo National Forest (replacing the 1988 plan) received final approval and is in effect as of November 24, 2019. More: https://www.fs.usda.gov/main/inyo/landmanagement/planning.
- Owens Valley Groundwater Basin (OVGB) and the Groundwater sustainability act. The basin was originally listed as a medium priority, requiring the formation of a Groundwater Sustainability Plan with responsibility to develop and administer the plan, leading to the formation of the Owens Valley Groundwater Agency. Subsequently, the OVGB was categorized as low priority, no longer mandated to have either a groundwater agency or plan. See the final prioritization report for all 515 groundwater basins at:

- Winter Travel Planning (e.g., use of Over Snow Vehicles OSV) for the Inyo National Forest. In the final Record of Decision for the 2019 Inyo Forest Management Plan, recreational travel planning will be done through completion of Subpart C of the Travel Management Plan. The scoping process should begin by October 2020. The process was suspended pending completion of the new Forest Management Plan. Development of a plan for winter OSV use is required by the Forest Service's 2015 Over-Snow Vehicle Rule. - Remember the **flooding in 2017** when the spillways at the Oroville Dam crumbled during heavy rains? The US Army Corp of Engineers has been looking at all of its 700 dams for possible dangers due to catastrophic climatic events. Recently the Corp announced that it was changing the risk characterization of the Mojave River Dam from low to high urgency of action, finding

- Although coal CO2 emissions still exceed those of natural gas globally, CO2 emissions from
  natural gas have now surpassed those of coal in the USA and Europe. The irony is that natural
  gas was promoted as a replacement for coal power energy as a means of decreasing coal usage
