Update: Forwarding the Transition to Cleaner, Healthier, All-Electric Homes & Workplaces in Southern Illinois Communities *By Jane Cogie*

On September 27^{th,} 2023, a range of community groups environmental and social justice non-profits, both State-wide and local--co-hosted the first of what are to be many Listen/ Lead /Share (LLS) community events across Illinois, aimed at introducing and gathering feedback on the gradual transition we must collectively and individually make to all-electric, cleaner healthier homes and workplaces.

The takeaways from this meeting are important to highlight, particularly since these same non-profits—Shawnee Group of the Sierra Club, Carbondale NAACP, Faith in Place, Black Graduate Greek Council of Southern Illinois, Citizens Utility Board, Carbondale United, and Natural Resources Defense Council—are planning follow-up events in February 2024 (virtual) and May 2024 (in-person) with the purpose of responding to concerns shared by the 41 participants at the initial Carbondale-based Clean Buildings event in September: **health impacts** linked to emissions from natural gas appliances in our homes (the focus of the February event), and the **support** folks wanting to begin transitioning to clean electricity will have available, both financial and practical solution-based (the focus of the May event).

Again, central to both these upcoming events will be providing a forum for residents from our area to make their voices—questions, concerns and hopes—heard on these important issues. It's worth noting that the feedback from community members at the LLS events in our area and across Illinois will be shared with representatives of environmental and environmental justice groups involved in crafting a Clean Buildings bill for Illinois, one that is responsive to the needs of us all, with equity a foremost concern. While the phasing out natural gas appliances from new buildings will likely be the main push of such a bill, we all benefit from learning how best to plan ahead for the time when our current gas appliances need to be replaced.

Thus, hearing from folks about this transition is hugely important. This issue hits all of us close to home, quite literally, directly involving, as it does how we heat our homes and businesses, heat our water, and cook our food, choices that will want also to be beneficial for our health and the health of our planet. Thursday, January 11, 2024 7 pm

Presentation: Birds of Prey in Southern Illinois

Presenter: Bev Shofstall, Director of Free Again Wildlife Rehabilitation Center

Brief Description: Over 40 years ago, Bev Shofstall brought home a Red-Tailed Hawk in need of medical assistance. Not long after that, she founded the Free Again Wildlife Rehabilitation Center. Literally hundreds of birds later, a few raptors that would not do well if released have been kept for educational purposes. This event will provide an opportunity for attendees to view these remarkable animals up close and learn about the value they provide to our environment.

Thursday, February 8, 2024 7 pm

Presentation: Planting Clues: How Plants Solve Crimes

Presenter: Dr. David Gibson, Emeritus Professor of Plant Biology, SIU School of Biological Sciences **Brief Description:** Dr. David Gibson is an Emeritus Professor of Plant Biology in the School of Biological Sciences at SIUC. For 30 years he taught courses in botany and ecology, including Forensic Botany - the focus of this presentation. He conducted ecological research, publishing over 150 research papers and 4 books including *Planting Clues: How Plants Solve Crimes*. His presentation will focus on the botany behind some famous criminal cases that includes plant evidence such as the baby Lindbergh kidnapping, the Caylee Anthony murder, the arrest of serial killer Ted Bundy, the 'Umbrella assassination,' and more. Copies of his book will be available for purchase and signing following the talk.

Preview of the March 21st, 2024 Shawnee Group Program: Trent Ford, Illinois State Climatologist, will present "Climate Change in Southern Illinois," focusing on climate change impacts and steps our communities can take to mitigate and adapt to those impacts.

WINTER 2023/2024 – SHAWNEE GROUP SIERRA CLUB OUTINGS

Sharp Rock Falls Hike, Sunday, December 3, 2023

Meet in the parking lot at Murphysboro Hardees before 10 am. This hike goes through a scenic, wooded canyon to a beautiful waterfall. It is a moderately difficult hike of 3-4 miles. Be sure to bring water and wear appropriate hiking shoes. You must call Steve Eberhart at 618-967-8690, to register for this hike.

Cove Hollow Trail, Sunday, January 14, 2024

Meet at the trailhead before 10 am. You can get to the trailhead by going south from Murphysboro on 127 and turning left on Boat Dock Road (across from Pomona Road) and then going approximately another mile. This is a moderate hike of 4.4 miles. Wear appropriate hiking shoes and take water and something to eat for lunch. Jon Womack is the leader. You must call Jon at 815-263-9625 to sign up for the hike.

Dutchman Lake Hike, Sunday, February 18, 2024

Meet at the boat dock at Dutchman Lake before 10 am. To get there, go south of Goreville to Tunnel Road, east to Dutchman Lake Road, then south to the boat dock. This will be a moderate hike of 4 miles. Wear appropriate hiking shoes and bring water. You must call Bob Mulcahy at 618-942-6342 to go on the hike.

Piney Creek Ravine Petroglyphs Hike, Sunday, March 10, 2024

Meet at the Murphysboro Hardees parking lot before 10 am. We will then drive together to the site. The hike goes to the Piney Creek Ravine where we will see ancient Indian petroglyphs and rocky bluffs. Bring water, a hiking staff and wear appropriate shoes. Helping our High-Quality Native Plant Communities Survive

We have been pulling invasive plants at Fern Rocks Nature Preserve near the Trillium Trail for close to ten years now and we can see a big difference: more native plants are free to survive without being covered up and choked out by winter creeper and oriental bittersweet. Jennifer Randolph gives many thanks to all the volunteers who have helped pull, saw and chop over the years. There are rare and threatened plants at Fern Rocks that make it all the more important for us to keep up our efforts. We just held two pulls with the help of honor students from SIU-C.

We have also been entrusted to pull invasive plants along Snake Road in LaRue-Pine Hills in cooperation with staff at Shawnee National Forest. In addition, we have battled garlic mustard and multiflora rose in Bald Knob Wilderness along the Godwin Trail. I'm sure it's time to go back there to make sure the garlic mustard hasn't had a resurgence. Garlic mustard is particularly damaging because it produces toxins that kill any other plants, so we want to nip it in the bud – or in the rosette.

Saving these special plant communities is an important effort in the battle to preserve biodiversity and many native plants. At these high-quality areas, we have to do pulling because we do not want to cause collateral damage by using herbicide. Also, did I mention that it is very rewarding to fill a bag full of noxious weeds and know you have done your part. Just look at all the smiling faces of the students in the photo. Health Impacts Associated with Emissions from Natural Gas Home Appliances

Collaborators Rocky Mountain Institute, Physicians for Social Responsibility, Mothers Out Front and Sierra Club recently reported on gas stove impact on indoor air pollution and public health. A primary source of combustion pollution inside the home, cooking with gas, spikes nitrogen dioxide and carbon monoxide emissions to levels violating outdoor pollutant standards (NO2 concentrations are 50-400 percent higher than homes with electric stoves). Children in homes with a gas stove have a 24-42 percent increased risk of asthma, and lowincome populations and communities of color are disproportionately impacted. In addition to NO2, CO2, carbon monoxide, methane, and PM2.5 (exacerbating respiratory problems), gas appliances (e.g., stoves, furnaces, water heaters, fireplaces) also may leak carcinogenic benzene and other volatile organic compounds (VOCs). To reduce air pollution, electric stoves and appliances are recommended.
