# **Conservation Issues Updates**

#### **ET Rover Pipeline**

The ET Rover Pipeline has been approved and some construction has begun in Michigan. There is a tendency to quit fighting once the approval for a pipeline has been granted, however the Pinckney residents, "Over With Rover" have not quit. Check out their website and see where you can help out. <a href="https://sites.google.com/view/overwithrover/home">https://sites.google.com/view/overwithrover/home</a>. Their current campaign is to encourage Michigan residents to contact legislators and ask that FERC (Federal Energy Regulatory Commission) commissioner vacancies not be filled. Without a full commission, additional pipelines cannot be approved. An additional problem is that the foundation shipper for the Rover Pipeline, Ascent Resources, has had their credit rating downgraded below the required level.

#### **Enbridge Line 5**

To date over 60 municipalities have created resolutions asking Governor Snyder and the Attorney General to decommission Enbridge Line 5 under the Straits of Mackinac. The governor established the Pipeline Safety Advisory Board to determine if such decommissioning is practical. Two energy sector companies, including Enbridge, have been given seats on the advisory board. Enbridge Energy was also granted permission to hire a consulting firm to do a risk analysis of the pipeline. On March 13<sup>th</sup> at the Board meeting in Lansing, Sierra Club chairman David Holtz spoke and submitted a letter outlining the fallacies of some of the above issues. # Roundup: Not as Safe as Monsanto Claims

Roundup, with the active ingredient glyphosate, is the most widely used herbicide in the world. It has reached that level of widespread use among homeowners and farmers because it is reportedly relatively safe to use. But new studies by European agencies and the United Nations have reached a different conclusion, making claims that glyphosate coupled with its inert ingredients can cause a host of health problems. Below are some excerpts of an article written by Elizabeth Grossman for National Geographic.

Last month, an international agency declared glyphosate, the primary ingredient in the popular product Roundup, a "probable human carcinogen." The weed killer also has made recent headlines for its widespread use on genetically modified seeds and research that links it to antibiotics resistance and hormone disruption. Several national governments are planning to restrict its use, and some school districts are talking about banning it.

Now the EPA says it will analyze new findings by the UN's International Agency for Research on Cancer, which declared in March that glyphosate probably raises the risk of cancer in people exposed.

The UN studies found glyphosate in farmworkers' blood and urine, chromosomal damage in cells, increased risks of non-Hodgkin's lymphoma in some people exposed, and tumor formation in some animal studies.

What should this mean to you? Use Roundup and other herbicides with glyphosate sparingly and carefully if not at all. Be particularly careful when using such products in environments where children frequent.

### **Building Bridges**

One of the goals adopted by the Sierra Club is to connect with other organizations that are concerned about the environment. By partnering with other community groups we become stronger and more diverse. And, as a result, we also become more effective at protecting the environment.

In the past, the Crossroads Group has worked with a number of groups including the Friends of Island Lake Recreation Area, the Friends of Highland Recreation Area, Community Unitarian Universalists in Brighton, and Big Brothers and Big Sisters.

Recently, the Crossroads Group added Alexander Pushman to its leadership team. Alexander is the vice president of the Foguth Financial Group and a member of the Greater Brighton Area Chamber of Commerce. One might not think of the Chamber of Commerce as being a potential ally of an environmental organization such as the Sierra Club but in fact there are many ways we can work together.

Says Alexander: "I can't say enough good things about the Crossroads Group of the Sierra Club. As a local businessman I've gained great networking and client opportunities from my involvement in the group."

Alexander also serves as the board president for a local nature sanctuary and he says his connections in the business world allow him to create "multiple levels to partner and help out on projects that benefit us all as residents of Livingston County."

Business leaders in Livingston County understand the need to attract younger citizens to live and work here if the county is to continue to thrive. Many of the things that appeal to younger citizens looking to build a career are often the same things the Crossroads Group supports: clean air and water, mass transit to reduce roadway congestion, parks, bike trails and pedestrian-friendly cities. So what is good for the environment can also be good for the Chamber.

"Overall, my wife Tatiana and I have had great experiences of building relationships among folks who care about the environment and also understand the importance of economic development here in the community," said Alexander. "Good things have happened on all fronts from my involvement in the Crossroads Group of the Sierra Club."

#### Pinckney State Recreation Area Bird and Wildflower Hike - Saturday May 6th, 10:00 AM\*\*

**Location**: Pinckney State Recreation Area, Cedar Lake Rd just south of M-36, Pinckney

Skill Level: beginner; Difficulty: easy to moderate; Cost: free

Join us on a scenic 2-3 mile hike through some beautiful wetlands and hilly terrain in Pinckney State Recreation Area. Our guides will point out birds and other interesting flora and fauna.

We will start where the Lakelands Trail crosses Cedar Lake Road just a short distance south of M-36. To get there, take M-36 1 mile west of downtown Pinckney and turn left on Cedar Lake Rd. Park at the trail crossing parking lot, or along Cedar Lake Rd.

#### Huron Meadows Wildflower and Nature Hike - Saturday May 20th, 1 PM\*\*

Location: Huron Meadows Metropark, 8765 Hammel Rd, Brighton;

meet at the Cedar Ridge picnic area / boat launch parking lot

Skill Level: beginner; Difficulty: easy to moderate; Cost: free, but requires Metropark entry fee

We will hike approximately 3 miles on the scenic Moraine Fen and Hidden Lake Bend trails. Our knowledgeable guides will point out wildflowers and other examples of natural beauty along the way.

#### West River Trail Bike Ride & Optional Lunch - Sunday June 4th, 10 AM\*\*

**Location**: Hudson Mills Metropark - 8801 N Territorial Rd, Dexter; meet at the Activity Center parking lot **Skill Level**: beginner; **Difficulty**: moderate; **Cost:** free, but requires Metropark entry fee

Join us for an easy 15 mile pedal on the West River Trail along the Huron River. This is a beautiful paved trail surrounded by trees, wildflowers, and meadows. The trail runs along the west bank of the Huron River, and ends (with our turn-around point) at Dexter-Huron Metropark. HELMETS ARE REQUIRED! For anyone interested, we will have lunch at a local restaurant after our ride.

Location: Island Lake Recreation Area, 6301 Kensington Rd, Brighton; meeting details below

Skill Level: some experience; Difficulty: mild to moderate; family-friendly

Cost: Boat rental (if not bringing your own) – canoes \$20/kayaks \$10, plus state park entry fee or passport Join the Friends of Island Lake Recreation Area on a paddling and pedaling day! Here's how it works: drop your bicycle at Riverbend in our attended bicycle storage area. Drive to the Kent Lake parking lot with your boat, or rent one there. Paddle on one of the finest natural stretches of the Huron River Water Trail, 1-1½ hours, to Riverbend. Bike back to your vehicle at Kent Lake on paved trails; 3, 5, and 12 mile options.
