#### SABAL TRAIL PIPELINE UPDATE

At a time when we know the Administration is looking to cut corners, the Sierra Club's commitment to the full enforcement of environmental protections is more vital than ever.

Last week, the DC Circuit Court of Appeals rejected any review of its precedent-setting decision in its August 2017 case of Sierra Club v. FERC, SC #16-64. The Court ruled then that FERC had failed to fully consider the climate change impact of the \$3 billion-plus Sabal Trail natural gas pipeline.

Since the litigation against FERC was filed, Florida utilities have announced a significant investment in solar power. The Solar

Energy Industry Association now projects Florida will add 1,915 megawatts of solar from 2018-2022 while Georgia will add 1,200 megawatts!
