America Recycles Week November 6<sup>th</sup> -15<sup>th</sup>

The third annual America Recycles Week commences Nov. 6<sup>th</sup> with the kick-off event at Ten Thousand Villages at noon. This joint venture of RGSC and Ten Thousand Villages is scheduled in conjunction with the National America

Recycles Day, Nov. 15<sup>th</sup>. The goals of this event are to raise awareness of and interest in environmental actions through the concepts of reducing, reusing and recycling and to increase residents' opportunities and participation to reduce, reuse and recycle.

How this works: Each participant receives a punch card at the kick-off event or at any participating business. Upon completion of recycling (bringing) the specified item(s) at each business, the card will be punched/marked by the business employee. At the end of the event, the cards are put in a drawing for door prizes. Prizes in the past years have been gift cards for as much as \$25.00, restaurant gift certificates and free services. With each year, this event continues to grow with more businesses participating and more activities planned.

A second card is planned for folks who bring their reusable bag at a participating business in which to put their purchase. These cards will be in a separate drawing with door prizes from these businesses.

At the time of this writing the returning businesses who have confirmed their participation are: Virginia Wine Experience, Cats Closet, Toy Store, VA Runner, Habitat for Humanity and Re-Run Shoppe. New businesses participating this year include Vintage Beaucoup and Fredericksburg Antique Mall. A river clean-up, swap meet, and other "recycled" ideas are planned for this year's event. The planning committee hopes to get the City of Fredericksburg and the schools involved.

There will be morning, afternoon and evening program events during the week. The RGSC website will have the updated list of participating businesses and schedule of events as the plans are completed in mid-October. # **Riparian Lands Stewardship Fund: Lets Keep The Commitment**

It was a tremendous collaborative regional effort to establish the 4000+ acre Rappahannock River conservation easement.

In order to protect and enforce terms of the easement, a watershed property manager (River Steward) position was established. In April 2006, the Fredericksburg City Council created the Riparian Lands Stewardship Fund from proceeds from the sale of the watershed property easement. The Fund was designed as an endowment, and Council's intent at the time was to grow the endowment to the point that interest earnings support the activities in the Fund. Financial support from Stafford and Spotsylvania Counties along with private donations have assisted in the funding.

However, due to a downturn in the economy, the endowment's interest earnings have faced challenging times. Fredericksburg Mayor Tomzak has reached out to RGSC and its members to urge localities to commit donations to the Fund. RGSC members can attend their local Board of Supervisor meetings and speak during open public comment time in support of the Riparian Lands Stewardship Fund. We all worked hard to make the Rappahannock River Easement a success-lets keep the commitment.

Chesapeake Bay Cleaner by Linda C. Muller

Working Together To Keep VA Waterways and the

When it comes to finding the ways and means of keeping Virginia's waterways cleaner, all interested parties need to work together towards solution based action. This year in Virginia, interested parties including homebuilders, conservationists and members of both political parties of the Virginia General Assembly came together to successfully pass SB1055 which regulates the use and application of fertilizer and de-icing agents. Virginia Senator Richard Stuart (VA 28<sup>th</sup> District) was the patron sponsor of the bill and was key in keeping the bill on track for successful passage :(vote: Senate 39-Y,1-N) (House: 95-Y, 0-N)

#### Highlights of SB 1055:

-requires training and certification for professionals and public sector applicators of fertilizers to nonagricultural lands

-prohibits the application of phosphorus to turf grass without a soil test; -prohibits the application of nutrients to impervious surfaces;

-sets standards for soil analysis techniques, equipment calibration, and the timing of the application.

-sellers and appliers of fertilizer will report amounts sold or applied by locality.

-lawn and turf fertilizer bags will carry a statement cautioning against improper application.

-Effective July 1, 2012, and subject to exemptions for newly established turf grass and gardens, no businesses shall sell (a) turf maintenance fertilizer containing phosphorus without point-of-sale limitations; (b) deicing agent containing urea; and (c) fertilizer without prominently displaying cautionary signage regarding excessive use.

#### **Positive Impact of SB1055**

According to the Chesapeake Bay Foundation "Once effective in 2013, the law could reduce phosphorus pollution running off into the Chesapeake Bay from Virginia by at least 230,000 pounds per year, or 22 percent of Virginia's phosphorus reduction goal by 2017. That could save localities millions of dollars by reducing their need to install expensive storm water runoff treatment systems".
