

The Gulf oil spill put a temporary halt to proposals for oil and gas drilling off Virginia's coast, but some politicians remain convinced that drilling offers a new source of revenue for state coffers and potentially some new jobs. Would these benefits outweigh the risks to marine life, wetlands and beaches, and to sectors of our economy dependent on fishing and tourism? And why are the Navy and NASA opposed?

Keep the Ban on Uranium Mining

National Academy of Science Town Hall Meeting 2/7/11 By Linda C. Muller

Concerned citizens from across the state of Virginia turned out for The National Academy of Sciences (NAS) town hall meeting in Richmond on Monday February 7, 2011 to support the moratorium on uranium mining. Virginia Uranium, Inc, which has funded the NAS study, is a Canadian owned company, and seeks to repeal a 25 year statewide ban on the mining of uranium, the milling of yellowcake, and the disposal of radioactive waste in Virginia.

According to the Southern Environmental Law Center "Uranium occurs naturally in the ground, but when exposed to air and water, radiation is released into the environment. Virtually all uranium mining in the U.S. has occurred in the arid, sparsely populated regions of the West. In these areas and other parts of the world, uranium extraction and processing have caused serious problems, such as the contamination of groundwater and surface water and increased cancer risk for workers and the public.

There is no precedent for large-scale uranium mining in eastern states such as Virginia, where the population density puts more people at risk and where a wetter climate increases the chance of radiation contaminating streams and groundwater.

Virginia has no regulations for uranium mining, and the federal government has virtually no experience regulating the activity in a wet climate."

The City of Virginia Beach commissioned its own study on the impact of uranium mining and released its findings on February 1, 2011. (web site here: http://www.vbgov.com/vgn.aspx)From the Executive Summary of the study: "Climatic and geologic conditions surrounding uranium ore deposits in Pittsylvania County make the area prone to extreme rainfall events including tropical storms and hurricanes, some of which have generated substantial flooding. Although presently uranium tailings are required to be stored in specially designed waste disposal facilities called containment cells or structures in compliance with Nuclear Regulatory Commission regulations, there is concern that a failure of uranium tailings containment structures could result in the contamination of down stream drinking water supply sources along the Banister River, Roanoke River, Kerr Reservoir and Lake Gaston." When completed, The National Academy of Science study will make a recommendation to continue or not continue the moratorium on uranium mining. It is ultimately up to the Virginia State Assembly to decide to maintain the moratorium. It is important that Sierra Club members and supporters let their elected officials know that Virginia should keep the moratorium in place.

UDA's Urban Development Areas-Stay Involved by Linda C. Muller


In 2007 the Virginia state legislature passed HB 3202 that mandates high growth communities create Urban Development Areas (UDAs) within their Comprehensive Plan to meet projected residential and commercial growth in the locality for a period of at least ten but not more than twenty years. Urban Development Areas means: an area designated by a locality that is appropriate for higher density development due to proximity to 1)transportation facilities 2)availability of public water and sewer system, 3) developed area, 4) redevelopment or 5)infill development. Embraced by leading Virginia smart growth and conservation groups, UDA's were hailed as a means to save taxpayers money, strengthen our communities, save energy, reduce traffic congestion, and protect farmland and natural resources. The process of actually siting UDA's into a comprehensive plan is unfolding through-out our region and special attention should be paid to proposed placement of sites. While the UDA legislation provides guidelines for siting (items 1-5 above), it does not guaranty that a locality will necessarily follow the guidelines-which makes citizen input and transparency of process very important.

During the December 14, 2010 the Stafford County Board of Supervisors public hearing, the two more environmentally sensitive UDA locations: Stafford Station in Widewater and Brooke Station located in and around the Brooke train station were removed from the proposed comprehensive plan. Both sites are currently without public water and sewer, are designated green fields, and bordered by resource protection areas. The Brooke UDA site has subsequently been placed back into the UDA planning maps for reconsideration and will be subject to another Stafford County Planning Commission public hearing on/before April 1, 2011. Spotsylvania County has taken an early pro-active citizen approach in UDA planning by holding several informational and townhall meetings to draw citizen input on suggested UDA sites. The "take away" is: citizens must remain active in local planning processes. What happens on a local level can have significant environmental impacts on a regional level, such as cumulative run-off that ends up in the Chesapeake Bay. While no planning project is ever perfect, the more concerned citizens are informed and engaged in civil discourse at the local level, the more local planning can reflect citizens interests.
