### Thurs, January 11, 7-9 PM Cooling the Commonwealth: Energy and Climate Change

Did you know that VA ranks 50<sup>th</sup> in spending on energy efficiency and conservation programs? The Virginia Conservation Network (VCN) is a 115-member group organization, including RSG and the SC VA Chapter, devoted to advancing a common, environmentally sound vision for Virginia. VCN's 2007 priority is a "Call to Action on Climate Change." During the upcoming legislative session, members will lobby legislators to make changes in how Virginia manages its energy usage. Nathan Lott, VCN Executive Director, will present our program addressing the issue and show how RSG members can provide input to these policies. Petitions will be available to attendees who want to take part in our "Join Us In a Call for Action on Climate Change" petition drive.

The past few months have seen great progress in RSG's Greenways Initiative, adopted as a major project by the ExCom last year. The goal of Greenways is to promote the development of a regional network of bike and pedestrian paths to connect residential areas with shopping, commuter stations/lots, schools and recreational areas.

We realized that to do this, we needed to work closely with regional governments, VDOT, and bike and walking clubs to identify where paths would do the most good, what funding is available, and how to guide the project through the various governmental approval processes to bring it from vision to reality. RSG representatives have met with a wide range of groups to discuss what projects are currently being considered, what design problems need to be tackled, and how to connect the several path segments already being planned to create a truly regional network.

A major step forward occurred at a Sierra Club-sponsored public forum held on October 19, where Transportation Director for the George Washington Regional Commission Lloyd Robinson announced their intention to develop the regional bike-pedestrian plan. The GWRC is composed of elected officials from Fredericksburg, Spotsylvania, Stafford, King George and Caroline counties. This plan ...see "Forum" on page 2

will form the foundation for the creation of the Greenways network. SC representatives will be working side-by-side with GWRC staff to put the plan together over the next six months.

Also at the October Forum was VDOT statewide bike-ped coordinator David Patton, who expressed an interest in helping fund the program; former VA Delegate and DCR Drector David Brickley, who is working to develop trails from Maine to Florida and who will help us coordinate our planning with a larger, national system; and Fredericksburg Pathways Partners founder George Solley, who is interested in integrating Fredericksburg trails into a regional system.

It is exciting to see this dream move toward reality. We'll keep you posted on important developments as this initiative evolves.

### An Open Letter from RSG's UMW Fall Intern

For once in our lives, our attention and purpose is not centered on books, grades and writing papers. We no longer have adults laying out clear instructions for our next assignment; we are now the adults and WE have to create our own direction. To help ease us into this transition of impending doom, a glorious concept has been created: the "Internship." Unpaid and ingenious, we are offered snapshots of what the "real world" is like and what our future bosses will expect of us.

Like many of my colleagues, at the start of my senior year I was filled with mixed emotions and ideas about graduation. As every guidance counselor

## My Three Weeks as a Butterfly "Mom"

On July 16, at a little country airport in Warwick, NY, my mother noticed a Monarch butterfly laying her eggs on a milkweed plant. My sister and I each took home a few leaves, me to Virginia and she to Maine. When I got home, the first thing I had to do was find milkweed plants, since the eggs had now turned into caterpillars and they were HUNGRY! The only food a Monarch caterpillar will eat is milkweed.

So, as you might guess, I walked around my neighborhood for two hours and couldn't find a single stalk of milkweed! That evening, I drove extra slowly to my yoga class, looking at the roadsides the entire time—I even pulled off a few times and looked around—but no milkweed. The next morning I called a woman who owns an herb shop, and asked if she sold milkweed plants. "No, I don't sell them," she laughed, "but I have some in my garden I was about to pull up and get rid of..." I got in my car right then and drove 70 miles round trip to get the milkweed, put it in water, and was horrified to see how quickly it wilted. No mind, the caterpillars were happily munching away. The next day, while out walking and NOT looking for milk-weed, I found about a dozen large plants, which kept me in milkweed for the entire 2 weeks the caterpillars would need it.

I kept my little "offspring" in a box with a screen over the top, secured with duct tape following clever escape attempts, and two weeks later was the proud expectant "mom" of five fat emerald green chrysalises with golden dots on them. Two I gave to enthusiastic children, and I checked on the remaining three every day, since the adults can emerge in anywhere from 5-15 days. On day 7, two of the chrysalises turned black, and I could actually see the orange butterfly wings inside. The next morning, exactly 3 weeks from when the eggs were laid, the adults emerged. After a few hours of intermittent wing pumping as their wings dried, I watched the first one take its first flight—straight into my garden to a big pink zinnia. Soon after, the second one headed for the trees. A third chrysalis opened a few days later, to less fanfare but no less awe from me.

What a wonderful experience this was: to watch the whole creative cycle of a little white speck on a leaf become a beautiful Monarch butterfly, and inside that speck, the knowledge of how to get to Mexico! ## **Prescription for Pollution?**

Have you ever asked yourself "Just how should I be disposing of my old prescription and OTC drugs?" With no good answer readily available, most of us either flush them down the toilet or dump them in the garbage.

As you may have guessed, neither of these methods of disposal is safe or advisable if humans are to avoid contaminating their own water supply. Pharmaceuticals dumped in the toilet make their way through the sewer to the water treatment plant, which is not equipped to filter out dissolved chemicals. Those dumped at the landfill put scavenging wildlife at risk, as well as pollute our streams, rivers and resident marine life when carried from the dumpsite by stormwater run-off. Clearly, the public remains undereducated on just what to do with unused/outdated medicine, and government and/or health organizations have been slow to address the issue. An EPA press release in February reported that a study done four years ago by the US Geological Survey found that 80% of 139 streams sampled across 30 states had detectable levels of chemicals found in prescription drugs. Those listed as capable of doing the most harm were drugs classified as hormones (estrogens, etc.), cardiac drugs, antibiotics, antidepressants, narcotics and any compound classified as a controlled substance.

As a first stab at tackling the problem, the Department of Environmental Protection in the state of Maine hosted the nation's first ever "take-back" drug program in South Portland last year. Working together with the New England Recycling Council, the EPA, local CVS Pharmacies and the South Portland Police Department, they collected 50 gallons of medications, including 1300 classified as controlled substances. The collected drugs were then transported for incineration.

Although the best way to dispose of unused drugs is to incinerate them, this is not something you want to try at home. As it stands now, most pharmacies have no "take-back" program, and those that do don't publicize it. (The Giant Supermarket in Fredericksburg and Wilderness Pharmacy in Locust Grove do accept unused meds, as long as they are not controlled substances.) Because all drugs are environmental pollutants and classified as hazardous waste, our only solution locally at this time would be to treat them as such, and dispose of them according to your community hazardous waste guidelines.

A better solution would be to start your own community takeback program. A call to your area law enforcement drug task force, establishment of a safe and regularly accessible drop off site, enlisting the support of a local drugstore or chain, and some good publicity could be all that is needed to keep harmful drugs from polluting our water resources. After all, how much of everyone else's medication do we really want to drink?
