The Birth of an Environmental Movement and EPA

The Cuyahoga River was coated with so much garbage and industrial waste that it exploded into flames, chemicals openly dumped into rivers and lakes killed wildlife and imperiled human health, industrial smoke so thick that it choked out entire communities and blocked out the sun. This was America's environmental legacy before President Nixon and Congress stepped in and created the Environmental Protection Agency in December 1970. The 1970's saw the "birth" of the environmental movement with the first Earth Day celebrated April 22, 1970. We became exceedingly aware that in order to protect human health and life, we had to protect our air, water, and natural resources. From the 1970's came The Clean Air Act (1970) the Clean Water Act (1972) Safe Drinking Water Act (1974) Toxic Substance Control Act (1976) Resource Conservation and Recovery Act (1976). Most of these federal regulations have since been updated and amended, and while not all perfect, have served as foundational building blocks for a cleaner and safer environment.

Fast forward 40+ years and we can see how other countries are struggling with unabated pollution problems. In 2008, factories near Bejing China were shut down for weeks in order to "clear the air" for the Summer Olympics and Paralympics. And according to a recently released study(2017), India's toxic air pollution "is causing about 1.1 million people to die

prematurely each year and is now surpassing China's as the deadliest in the world". Hope rests in the development and adoption of clean energy technology like solar and manufacturing processes that reduce pollution emissions. During President Obama's administration, the EPA partnered with both China and India in the development of strategies and processes to address urgent pollution issues.

EPA Now: Forward Into The Past-Shifting to State Attention

President Trump has indicated he wants to reduce EPA's footprint and significantly slash its operating budget. The new EPA administrator, Mr. Pruitt, is the former Attorney General of Oklahoma, is unabashedly supportive of the oil and gas industry and sees environmental regulation as an "impediment" to economic development. In 2015 Oklahoma experienced over 1000 earthquakes (3.0 or higher) attributable to fracking waste water injection wells. In November 2016 Oklahoma experienced a 5.0 magnitude earthquake that hit near Cushing Oklahoma. Cushing, OK is the North American trading hub for stored crude with just under 60 million barrels of stored oil. Environmentalists are rightfully concerned of the potential consequences of Mr. Pruitt's "impediment reduction" approach as head of EPA.

Should federal environmental regulations get "whittled away", it will be incumbent upon everyone to stay engaged at the state and local level. In Virginia, protecting and conserving our natural resources is a nonpartisan issue; citizens of all political stripes want clean air, water, and protected "wild" places. Remain engaged and join us for Earth Day On the Rappahannock on EARTHDAY April 22, 2017 11 am to 4 pm at Old Mill Park. Rain date April 29, 2017.

*December 4, 2016: We held our annual Open House in Fredericksburg. It was well attended. Ms. Desirée De Haven, UMW graduate and former RGSC intern, spoke about her time as an environmental activist in Gabon where she spent a year working in conservation with Organisation Écotouristique du Lac Oguemoué (OELO).

- •February 6, 2017: We participated in a meeting with Secretary of Trade and Commerce, Todd Haymore, preparing a paper on why DMME needs to conduct a Comprehensive Review of Fracking Regulations.

TIP COLUMN:

Beauty Products: Are you trying to go nontoxic with your beauty products? You can start with making your own lotion. Organic virgin coconut oil can be purchased rather cheaply at many stores. Put one cup of softened or grated (not melted) coconut oil and 1 tsp. of tea tree oil or vitamin E oil (both optional) in the bowl of a mixer (Kitchen Aid is ideal) or a blender. Beat on high for 7 minutes. This will produce a "butter." Put in a jar for storage at room temperature. Use a tiny bit and rub on skin. At first, you will be using too much which will make your skin feel too oily. Rub this in and spread it around, and next time, use much less. When you become used to this "oily" feel, you will become addicted to its result. There is a lot of good evidence of coconut oil's benefits.

Organic Gardening: It is time to start planning your garden. Love eggplant, but don't get much yield because flea beetles turn eggplant leaves into a lacy mess? If you start your own seeds, consider planting them directly into large containers, not the tiny seed starters. If you buy the seedlings, as soon as you get them, replant them into larger containers. It does take up a lot more space to do so, but it reduces shocking the plants. If you use large enough pots, you may be able to keep them as container plants.

So how do you minimize flea beetle damage? Large pots allow you to keep the plants in the pots later into the season. Flea beetles move along the ground, so put the pots on a platform about 3 feet above the ground. I use a couple of sawhorses and an old wooden pallet. When the plants have a good quantity of leaves and some flowers, replant them directly into the soil. Keeping the plants high off the ground means the flea beetles can't jump or climb onto the plants. Flea beetles will still attack those replanted eggplants, but the plant should be strong enough to handle the damage. Spray some well diluted organic soapy water on the plants when you see the leaves begin to look like lace. Google organic soap pesticide for some recipes.

Fitted Sheet - Garbage or Salvage? Don't you hate when your fitted sheet loses elasticity? Instead of purchasing a new one and discarding the old, repair it. It's simple and inexpensive. Replacement elastic costs less than \$5 from any fabric store. Use a seam ripper to make a 1 or 2 inch opening in the elastic casing on one side of the sheet. Cut the old elastic and pull it out. Measure the length and width of your bed, double it, then subtract 25%. Don't cut the elastic until the very end, just in case your measurements are off. Measure the elastic and place a large safety pin at the end of the length you just calculated.

Take a safety pin the same width as the elastic and stick it into the beginning end of the elastic. Then tread it through the casing where the old elastic was. When you get to the large pin you don't want to put any more elastic into the casing, but finish feeding the small safety pin through until it is back at the opening. Spread the elastic throughout the sheet making it even all around. Place the sheet on the bed to make sure the sheet is fitted enough. If it is too loose then pull the elastic tighter, if it is too tight then feed more elastic through the casing. When you are sure that the fit is what you need, sew the elastic together. Cut the extra elastic after you are finished. Sew the sheet where you opened it up either by hand or with a sewing machine. There, new sheet for under \$5.
