

NEW LANDFILL BEING PLANNED FOR SHELBY OAKS DRIVE

Shelby Oaks Drive Planned Development has applied to the Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) for a solid waste disposal permit to construct and operate a Class III landfill. The planned location is in Shelby County, at 5559 Shelby Oaks Drive, Memphis, Tennessee (latitude 35°9'45.35" N/longitude 89°52'35.04" W). The waste materials to be accepted are classified as farming wastes, landscaping and land clearing wastes, demolition/construction waste, shredded automotive tires, and/or certain wastes having similar characteristics and approved in writing by TDEC.

Under State law, the applicant must obtain a permit before constructing or operating the proposed facility. DSWM has received a Part I Permit Application indicating Shelby Oaks Drive Planned Development's desire to obtain the required Class III permit.

A complete permit application consists of both a Part I and a Part II, as described in Regulations Governing Solid Waste Processing and Disposal Facilities in Tennessee, Rule 0400-11-01-.02(3)(c). When the facility submits the complete Part II application, DSWM will do an in-depth review to determine if the application meets the technical standards of the Regulations described in Tennessee Rule 0400-11-01-.04(9), Solid Waste Processing and Disposal. Once the technical review is completed, DSWM will make a tentative decision to either grant or to deny the permit and will issue a public notice.

This second notice will provide the public at least 45 days to submit written comments on the proposed action. If there is a significant degree of public interest, DSWM will schedule a public hearing and give at least 15 days' notice. After considering all comments received, the DSWM Director shall issue a final permit decision and a response to comments.

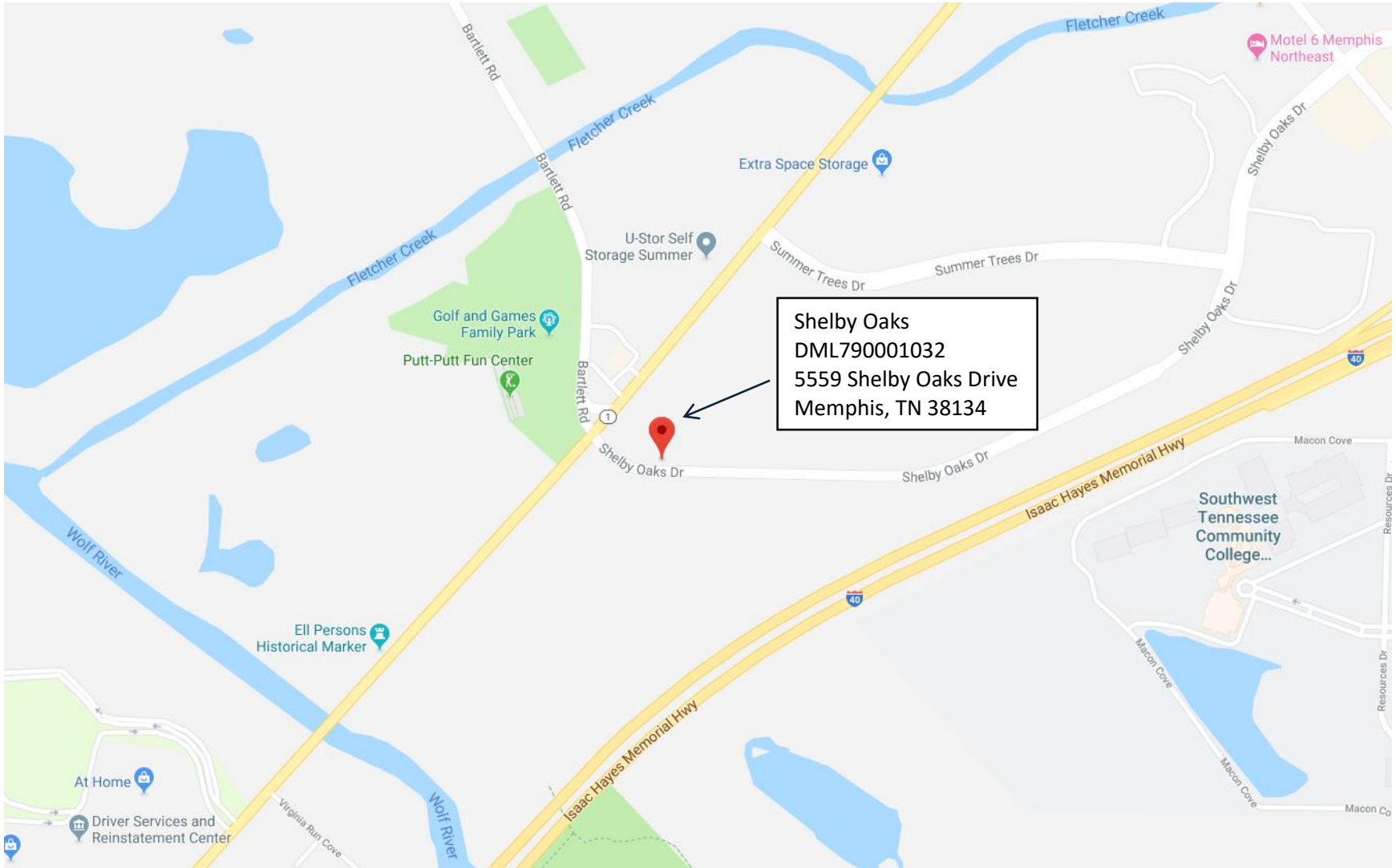
