CONSERVATION CORNER by Roberta Clements

AS we are heading into fall there has been a thankful respite in new proposals for large developments in the area, however we are all aware that although there has been relatively little public activity by developers, inner workings continue to pour money and time into making their projects manifest in our homeland.

The Awosting Reserve development is at a critical juncture where at the time of writing, efforts to rezone the AAR-200 district in Gardiner are under debate. The AR-200 zone was supposed to be rezoned from a now obsolete Master Plan, but the rezoning had never occurred. At the time of writing, the new master plan continues its process. Hopefully, the Town of Gardiner will uphold its own master plan. As for the sewage treatment plant, the Awosting Reserve LLC continues to assert that it is an allowable use on the cliffs of the Shawangunks. Clearly, the power of municipal home rule of the local township should prevail, but this will have to be resolved in court due to the pending legal action by the developers. As you know, Awosting Reserve represents just one of many proposals abutting the Shawangunk Ridge (casinos, the mushroom processing plant, and condominiums to the south). With this in mind, over 30 organizations united at the Shawangunk Ridge Coalition to preserve and protect this fragile and singularly unique geological and ecological terrain so that we can ALL enjoy it for perpetuity. The Mid-Hudson Group is a proud participant in this coalition continuing to pursue our mission to preserve and protect the outdoors so we can continue to enjoy it.

The banks of the Hudson have a new hotspot nightclub on the Rondout in Kingston but the proposed Landing Development of thousands of condo units by AVR remains in question. The Draft Environmental Impact Statement provided by AVR was rejected by the City of Kingston and it may take several months for AVR to present a full environmental assessment of the effects of their proposed construction. Once accepted by the city, the DEIS will be presented for public comment and members will need to respond at the public hearings and in writing. Right next door, several hundred units are proposed on the former brickyard property. These developers want to push these proposals through so they can "move" these units before the "real estate bubble" bursts. If they do, Kingston will be left with overpriced housing units that could remain empty (did I hear someone say "Tech City?") Yes, there is a housing shortage, but not for wealthy out-of-towners. The shortage in housing is in affordable housing for the working people of the Hudson Valley who are not necessarily able to buy, or looking for, \$250,000 condos on the river. These projects could hold some promise if DRAMATICALLY downsized and if traffic, pollution, water, sewer, and economic burdens on the community are considered. The reason the Hudson Valley is so attractive to those in the south is because they are trying to escape the traffic, pollution, strip malls, and poor quality of life that was created by developments such as this. Let's make sure it is not recreated here or soon we will all by applying for Canadian citizenship!

We won't be able to "go west" if Dean Gitter's "Crossroads at Belleayre" occurs because we would be struck in traffic on Route 28. We need to make sure our state legislators know how the majority of residents feel about clearcutting for golf courses and casinos. The construction jobs provided by creating these facilities would most likely go to large contractors outside of the area and the residents who live here will be selling them coffee and gas, so don't be fooled by the promise of economics. Vacationers will not be leaving their "compounds" to shop locally. The Catskill mountains are a place of everlasting beauty and of purity for our water and air. What God has created let no man put asunder.

Those of you who attended our Speaker Social with Don Young regarding National Parks were happy to enjoy some of the most stunning scenery. While we viewed Don's incredible slide show he discussed the Redrock Wilderness Act which is looking to protect some of the most magnificent terrain on earth. And we are lucky enough to have it in the United States of America. This federal Act, sponsored by our own Maurice Hinchey, would protect 9 million acres of land in Utah. This is already federal public land but it is threatened by - guess what? - drilling for oil and gas, mining, and excessive use by off road vehicles. The Sierra Club and 234 other conservation groups support the Act. Please express your support as well. You can write to Hinchey at U.S. House of Representatives, Washington, D.C. 20515

The proposed mining operation in Eddyville was defeated by rezoning the 43 acre area in question. After a highly vocal community opposition, the Town of Ulster appropriately rezoned this as residential property. Predictably, the mining company intends to sue. Wouldn't the money be better spent on creating a useful project? That is like driving an extra 100 miles to buy gas that's two cents cheaper.

Lastly, if I need to say anything about the November elections in this publication, you are too far gone to reach! Peace to all...
