Federal and State Incentives To Improve Energy Efficiency

As part of the 2009 American Recovery and Reinvestment Act, existing tax credits for making your house more energy efficient, by replacing certain appliances with more energy efficient ones, installing insulation, replacing windows and doors, and so on, were extended and enhanced. Improvements to existing homes are eligible for a tax credit of 30% of up to \$5000, for a total credit of \$1500. See http://energystar.gov/taxcredits for more information.

At the New York State level, in order to meet the goal of reducing energy use in the state through energy efficiency improvements, utilities are required to have in place programs to assist with making existing homes more energy efficient, and also to provide incentives to upgrade certain appliances with more energy efficient ones. In order to qualify for the program, you have to go through a state-approved Trade Ally. After paying for a home energy audit with a blower door test, you will be eligible for a rebate for up to 4 hours of air sealing work at up to \$75 an hour. After a duct blaster test, you are eligible for a rebate for up to 3 hours of duct sealing work at up to \$100 an hour. Equipment rebates range from \$25 for a programmable thermostat to \$1000 for purchase and installation of a very efficient water boiler. Rusty has traveled extensively to the Amazon and other parts of the world doing research, videography, and education. He has given over 3,000 lectures to such venues as Princeton University and the American Museum of Natural History. His television credits include appearances on David Letterman and The Today Show, and he has worked as an assistant to Jim Fowler of Mutual of Omaha's Wild Kingdom.

Williams Lake Update

Although the original developer, Canopy, seems to have dissolved, an entity known as Hudson River Valley Resorts, LLC, continues to pursue plans for a massive gated resort community at Williams Lake in Rosendale. With the exception of a few privately-organized events, the area remains closed to the public. The developer is working to fulfill the requirements of the final scoping document, which was released by the DEC on April 1, 2009.

The grassroots opposition group, Save the Lakes, with help from the Sierra Club, continues its mission to inform the public about the adverse consequences of this proposed development. Mid-Hudson Sierra, with funds from the Sierra Club Foundation, has published a two-page study by the hydrologist Paul Rubin which highlights the bountiful natural and cultural resources of the Williams Lake Property. This study is being widely distributed at public gatherings in the region, and can be viewed on the Save the Lakes website or our own. The Summer 2009 issue of the Sierra Atlantic also contains a comprehensive article about the Williams Lake property.

Save the Lakes is planning a series of fundraising events to support their participation in the upcoming SEQR hearings, which will require professional expertise. Directions to the Hudson River Rowing Association's Boat House (Our Meeting Place)

Find Main Street in Poughkeepsie. It runs east-west, and is about two blocks north of the highway bridge over the Hudson. If you are coming across the bridge, turn left at the first traffic light and then turn left again at the next corner. From there, go with the flow until you come to a traffic light, which is Main Street. Turn left (west) onto Main Street.

Travel down Main Street and find North Water Street about a half block before Main Street ends at the river (it's the last side street before the river). Turn right onto North Water Street, traveling north between the river and the railroad. This is an interesting old industrial area. You'll shortly pass the Children's Museum (on your left) and the Walkway-Over-the-Hudson (above you). But just stay on North Water Street to the very end, a distance of about 1.2 miles. At about 0.9 miles there is a gate which should be open during our meeting. Beyond the gate the road descends to the level of the river and then makes a U-turn to double back and so then travels south along the river for the last 0.2 miles to the Boat House. The Boat House is the first building complex on your right after the U-turn. Enter through the first set of double-doors that you come to as you drive into the parking area.

As usual, our programs are free and open to the public.
