# **Conservation** Corner

**So!** It is a new year and the same old topic. **The Private Well Testing Law**, is back in the news. It never really left. Areas of concern keep popping up. A school in Highland needed to bring water into their school for drinking and cooking after elevated levels of the chemical toluene were found in their ground water supply. Did the officials notify home owners using the same aquifer water near the school, that they should test their water?

In Dutchess County the issue was finally voted upon in the county legislature. The law passed by 1 vote, 13-12. All the republicans voted no except for one, East Fishkill Legislator Marge Horton. It is sad that clean drinking water has basically become a party line vote.

By the time you get this newsletter you will know whether the Dutchess County Executive, Steinhaus, vetoed the law or not. His county address this year focused on the environment. But he did not really discuss the new law. It sounded like he wants to make yet another committee so they can keep talking about it. After 20 or so hearings since the year 2000, it is time for action. Talk is expensive. Another committee means just another stalling tactic. I am hopeful that he will not veto the law.

The legislators against this law do not feel people should have to spend \$500 to test a their wells before selling their homes. **Testing would do a few things. It** will make it possible for the county to track groundwater quality using their multi-million dollar GIS system. Neighbors will be alerted if a well is found to be contaminated. The test results are also shared with the prospective buyer.

#### \*Who Pays More?

\*Compare...the amount of money someone pays for a home with a public well. Those people MUST pay a tax of about one thousand dollars per year for the use of water. It is cheaper for a developer of new neighborhoods to build a public system and then over charge for use of that system than it is to drill a new well for each home. So let's see. For example, you live in your home with a private well for 10 years. Most people unfortunately will not test the water which means they have spent nothing. As opposed to someone who has a public well who by now has spent about \$10,000.00! Both decide to move. The person with the private well must do a \$500 water test. The person selling the home with the private well is still ahead by \$9,500.00! Even if someone with a private well tests their water every vear, they are still ahead by 50%. Make sense to you?.

# What You Can Do!

These are the same legislators that saw no problem making taxpayers pay millions of dollars to get water for IBM, a multi-multi billion dollar company that needed water because they contaminated the water supply they have. Isn't that ironic?

**Voters have the power to make a change**. Register to vote and do your research! Take a look at what is really going on and if you do not like what you see, vote for someone new. Vote for someone who does not always tow the party line but understands what they are voting for and makes an educated decision while representing the people. **See you next newsletter!**

# Step It Up on April 14th!

On Saturday, April 14, 2007, thousands of concerned citizens will gather at hundreds of places across the country and raise their voices about climate change, asking Congress to "Step It Up!" and cut carbon emissions 80% by 2050 - a target that experts say is the best hope for avoiding the worst consequences of global warming. The campaign is asking groups of concerned citizens to gather in their communities on April 14, hoist a banner, and take a photo. Campaign organizers will then link the protest pictures together electronically via the web, and "before the weekend is out, we'll have the largest protest the country has ever seen." Neighborhood Earth Watch, a grassroots group started by Hudson Valley parents concerned about global warming is stepping up with an event to gather at a place that is important to the community, and threatened by global warming. 
