Rail Trails in Southern Dutchess

There is much talk of late in the Beacon-Fishkill area of a rail trail along a little used MTA spur. This trail would provide a cost effective greenway running from Beacon on the Hudson River through Fishkill and east out to Hopewell Junction. This trail would link with another rail trail in Hopewell Junction that runs north up to the proposed Hudson River walkway in Poughkeepsie. Eventually another trail will lead from this point out to New Paltz.

Mayor Clara Lou Gould of Beacon likes the idea of a light rail line along the tracks with a trail along side it. Fishkill Town Supervisor Joan Pagones is studying the matter and is reaching out to the MTA to ascertain their plans for the line. The Village of Fishkill has requested information on the plan by Michael Boyajian

What is the definition of stupid? Doing the same thing over and over again expecting a different result!

Since the last Sierra Club newsletter I sat in on a few Dutchess legislature committee meetings. During the last committee meeting I attended, 3 legislators introduced a new, watered down private well testing bill. Who are these three legislators? One is a gas station owner. Another is a builder. And the other has been publicly against a mandatory bill since the beginning.

This new horrible bill is called target testing. They want to test a few homes in an area and conclude that if those wells test clean, therefore the water in the entire neighborhood is clean. I want to tell you a true story. Back in 1994 the Department of Environmental Conservation de-listed the Hopewell Precision contamination site because they concluded we did not have a problem. The reason why they concluded this was they tested 3 monitoring wells and 3 homes and all had good water. This is like the target testing nonsense.

Of course we were found to be contaminated but only after the EPA tested 75 homes right next to each other and of those only 5 were contaminated. What if the EPA only chose to test a few homes again? What if they chose homes with good water?

Why are some legislators deciding that it is alright to do for other neighborhoods what the DEC did in 1994 to the Hopewell Precision residents? Mary Swartz, the legislator representing residents at the Hopewell Precision Site, should be ashamed that she is proposing this.

In the last 25 or so years there have been approximately 6500 chemical spills in Dutchess County. These include gas, oil, cancer causing chemicals and "unknown materials". This amount does not include the spills that were never reported. This amount does not include just recently named superfund sites like Shenandoah and Hopewell Precision. Those spills took place in the mid 70's. Do you still feel safe?

This target program will miss contaminated homes. It will not be effective. Tell your legislators that they must support mandatory testing, not target testing. If you e-mail a short letter to countylegislature@co.dutchess.ny.us, all Dutchess legislators will read your letter.

Conservation
