

CT Local & NY County Ordinances Banning Fracking & Oil & Gas Drilling Wastes - Penalty Per Violation Per Each Action

CT Towns:

- Mansfield** Town may impose any fines deemed necessary.*
- Coventry** Town may impose any fines deemed necessary.*
- Washington** Selectman’s Office may impose any fines deemed necessary.*

NY Counties:

- Albany County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Cayuga County** Unclassified Misdemeanor subject to fine not to exceed \$100,000. and/or 30 days imprisonment
- Clinton County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Erie County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Nassau County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Oneida County** A. Civil Breach of Contract. B. Criminal Penalties. See Ulster County information below*
- Onondaga County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Orange County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 15 days imprisonment
- Putnam County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Rockland County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Schoharie County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment
- Suffolk County** Unclassified Misdemeanor subject to fine not to exceed \$ 5,000. and/or 30 days imprisonment
- Tompkins County** A. Civil Penalty: \$1,000 1st violation, \$5,000 subsequent offense
B. Criminal penalty upon conviction: \$5,000 each day violation continues or imprison not more than 1 year or both.
- Ulster County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 30 days imprisonment*
- Westchester County** Unclassified Misdemeanor subject to fine not to exceed \$ 25,000. and/or 15 days imprisonment

***Ulster County A.** Civil Breach of Contract: Dir. Of Purchasing, County Attorney & other officer deemed necessary shall commence civil Breach of Contract action. Damages shall be determined by Town Attorney but may include but not limited to cost of consequential damages.

A finding that Contractor was not a responsible bidder will be circulated to each other County of NYS.

County Attorney is authorized to commence action to enjoin any violation.

B. Criminal Penalties: In addition to prosecution for Perjury as determined by District Attorney

Unclassified misdemeanor subject to fine not to exceed \$25,000. and/or up to 15 days imprisonment

***Washington, CT:**

The Selectmen's Office is empowered to issue "Cease and Desist" orders in case of any infraction. It is further empowered to require remediation of any damage done to any land, road, building, aquifer, well, water course, air quality or other asset, be it public or private, within the Town of Washington. It may impose fines in any amounts it deems necessary to deal with any and all infractions against this ordinance.

***Coventry & Mansfield, CT have same language, modeled after Washington, CT:**

This Ordinance shall apply to any and all actions occurring on or after the effective date of this ordinance. The Town is empowered to Issue "Cease and Desist" orders in case of any violation of the Prohibitions and Provision stated above in Sections 1 and 2. It is further empowered to require remediation of any damage done to any land, road, building, aquifer, well, water course, air quality or other asset, be it public or private, within the Town of Coventry. It may impose fines in any amounts it deems necessary with any and all infractions against this Ordinance.
