United States has struck an expansive trade agreement, the Trans-Pacific Partnership (TPP), with Canada, Mexico, and nine other Pacific Rim countries.

The Sierra Club is deeply concerned about the lack of transparency during negotiations and the deal's environmental implications including threats to forests, wildlife, food crops, and fish. Environmental regulations in the bill are "toothless ... with no enforcement mechanism." And the TPP may allow for increased fossil fuel exports meaning more sand mining, fracking, and dangerous substances being transported by rail and pipelines.

The TPP gives corporations the right to sue governments for unlimited cash compensation over nearly any law or policy that a corporation alleges will reduce its profits.

A ceremonial signing took place on February 4. Because it received "fast track authority" in Congress, our representatives are not allowed to amend the bill when it comes for a vote this spring. The Sierra Club joins many other environmental, labor, privacy, health, and democracy advocates urging its defeat. Ron Kind who is currently a strong supporter of the TPP, to oppose this dangerous legislation.
