Public Service Commission Hearings on Badger-Coulee Power Line Expansion excerpted from the La Crosse Tribune, December 3, 2014

Beginning next week, Wisconsin regulators will hold a series of public hearings on one of the state's largest high-voltage transmission line project to date—the Badger-Coulee project, a proposed 345-kilovolt power line between Holmen and Madison—which could cost ratepayers millions and slice through western Wisconsin.

The commissioners will determine if and where American Transmission Co. and Xcel Energy can build the line. Whether or not they are there, your comments will be transcribed and entered into the record. (At the time of this publication, it's unclear if any of the governor-appointed commisioners will be present!)

The line, if approved, could encroach on up to 556 residences,

as well as farm, forest and public lands. It is expected to cost up to \$580 million, which would be the most expensive transmission project approved since 1996. The second largest, approved in 2003, had a price tag of \$420 million.

ATC and Xcel say the line would improve system reliability, deliver cheaper power for Wisconsin consumers and provide a pipeline for wind energy from Minnesota and lowa to population centers to the east.

Opponents say the demand is not there, and the line would allow utilities to profit by trading energy while discouraging more cost-effective alternatives such as energy efficiency and solar power."
