

### Holiday Gala Guest Speaker Ben Greenberg Nature Photographer and author of *Natural Virginia*



His passion for nature photography began in the 1970s, and he has been a freelance professional photographer and artist for 40-plus years. His carefully crafted landscape photographs have won local and national awards including the International Grand Prize for the KINSA photography contest.

Ben takes great pride in creating photographic images of the highest quality in color and black and white. He uses the best of traditional and cutting edge technology, film and digital, seeking to capture photographs that provide the discriminating viewer with an image that portrays all the natural beauty of the subject.

Ben's primary subjects are the scenic vistas of mountains, landscapes, rivers, lakes and shorelines of Virginia and the nation. These locations include the University of Virginia and surrounding areas, the James River, the Blue Ridge Parkway and Shenandoah National Park, Great Smokey Mountains National Park, Tangier Island and the Eastern Shore, Southwest Virginia and the Outer Banks.

He is currently working on a book called Natural Virginia which will be distributed by UVA Press and it will be available to the public in March 2014. He says of the book "Virginia is a state of remarkable diversity from the Eastern Shore and the Chesapeake Bay to the Blue Ridge Mountains, from the highlands of Southwest Virginia to Great Falls on the Potomac River, Like other natural environments it is facing serious threats to its beauty and well-being from the byproducts of the 21st century and the state's expanding population and economy. Natural Virginia, a coffee table size book (10"x17"), celebrates that varied and breathtaking scenery with more than 100 dramatic panoramic landscape photographs from every corner of the Commonwealth. Natural Virginia is dedicated to all who take pleasure in experiencing first hand the state's scenic locations. It also actively supports dedicated state organizations committed to preserving Virginia's fragile environment for the enjoyment of our future generations.

### View from the Chair

Ahhh, those lazy, hazy, crazy days of summer—summertime, when the livin' is . . . as busy as ever for FOJG Ex Commembers, just a little different.

Summer does mean a break from organizing and showing up for monthly Executive Committee (Ex Com) meetings, general program meetings, routine committee meetings, film festivals, campaigns, yard sales, and galas - the periodic events that demand so much time, energy, and creativity from all of us. And, of course, also teach us, energize us, and make us proud.

Yet for Ex Com members, summer is also the time when your group leaders devote hours behind the scenes evaluating the organization's accomplishments during the past year and setting goals for the future. That may not sound particularly hard, but think how you'd feel rolling out of bed early on a July Saturday to face a four-hour work session on goal-setting, priorities, and budget that ends with a

formal Ex Com meeting (lunch not included). Add in all the different opinions, questions, personalities, and passions, and the thought is a little daunting, isn't it? At least, you'd want to be certain that the time and energy you spent in that boardroom made a significant difference.

By that standard, the Ex Com's work session on July 20 was an unqualified success. All nine members of the Ex Com were there. Six of them had recently participated in an in-depth training program led by the Virginia Chapter's Kate Addelson over a period of months to identify ways to strengthen our group's

leadership and internal operations. The training culminated with a detailed action plan and PowerPoint slide show, which the training team presented to the Ex Com as a whole. After some discussion the Ex Comm endorsed the plan as its first major goal for 2013—14. Items in the action plan will be incorporated into the Ex Com's task list that now heads each month's meeting agenda.

During the course of the morning - after filling newsprint sheets around the room with ideas, distilling them down to a short list of favorites, and setting priorities through a weighted voting exercise - Ex Com members adopted three other shortterm goals and began the conversation about how to accomplish them. The new goals include a survey of the membership to determine your interests and ideas for future programs, campaigns, and activities; an expanded Recycling Breakthrough! 2013–14 Contest for area school-aged students; and a new pollinators and anti-genetically modified foods advocacy campaign. (Watch for more about all three developments in the coming year and,

better yet, think about the various ways you might like to participate.)

Following that important work, the Ex Com reviewed a draft budget line by line, tweaked it, and approved it informally as revised. Because of the changes, adoption of the 2013–14 budget would have to wait until the next Ex Com meeting when the group could review and agree on a revised draft.

The Ex Com's work behind the scenes that bright summer day (and the days that led up to it, as well as those that followed it) will pay off in numerous



ways for the Falls of the James Group. For one thing, the work session opened communications among members of the Ex Com, trained us, and made us a stronger team. In addition, of course, our hope is that our specific goals will put the group's energy and resources to the best possible use, advancing leadership and organizational

effectiveness (Goal 1: internal operations), engaging current members' more fully and attracting new members (Goal 2: surveying the membership), generating publicity and educating the next generation of Sierrans and their families (Goal 3: recycling

contest), and raising awareness, enjoying and exploring theoutdoors, and protecting our fragile planet (Goal 4: pollinators/No GMO campaign).

Without question, we have accomplished a lot this summer. With your help, our work will produce positive results season after season.

#### **Baseball Stadium in Shockoe Bottom?**

Your Ex Comm and the Falls of the James Group have been following the Baseball Stadium proposal for Shockoe Bottom since the first proposal in the early 2000s. Although we have been hearing rumors this Spring that the Mayor will try to ram the proposal through, and City Council has been trying to thwart the land and money grab by creating a process for Richmond's taxpayers and citizens to vote it up or down (a referendum), it would be premature to rewrite a new position until we hear from the Mayor regarding his proposal.


Here is our 2009 position, written by Scott Burger, which is still quite valid (and it provides numerous good reasons for killing a horrible project, if you do what good Sierrans do and voice their opinions to elected officials, policy-makers and community leaders.) If and when the Mayor does make a formal proposal, we promise you an updated position statement.

Here is our statement from 2009 on this topic:

To Members of Richmond City Council, On behalf of the Sierra Club Falls of the James group, I wish to reiterate our opposition to building a baseball stadium in Shockoe Bottom.

The Sierra Club Falls of the James Group opposes the Shockoe Center baseball stadium proposal based on principles of conservation and smart growth. We preface our statement by saying we are not opposed to baseball or urban redevelopment. Rather, we wish to join the Richmond baseball discussion by imparting some basic environmental tenets that need to be recognized.

First, let us agree that Richmond deserves a world class sports stadium within its urban footprint. However, if we examine what cities all over the world are doing with new facilities, we can see that they are incorporating conservation measures and 'green' technology. The Boston Red Sox outfitted Fenway Park with solar water heating. In Kent, England, the local soccer team has put in green roofs and green



rainwater retention in addition to solar for its clubhouse. The San Francisco Giants are installing PV solar to power nearby homes and bringing in more recycling and biodegradable materials. Bern, Switzerland's soccer team features the world's largest stadium-integrated photovoltaic solar system. We all saw the lengths that China went to make its Olympic venues environmentally aware. In short, why not Richmond? The current proposal suggests that a baseball field i n itself will function as better storm-water retention area than what the current site offers. While this might, possibly, remotely, be true (with the City spending lots of money on infrastructure), we demand more green features from this and future development proposals in all parts of the City.

While some view the proposed Shockoe location as beneficial for the City, many citizens and environmentalists question the concept of plunking a massive structure in the middle of several sensitive, historic neighborhoods, a growing transportation center, and the topography of the Shockoe Valley, creek, and floodplain. When we compare the proposed site to the existing Boulevard one, there is clearly a sense of purpose that conflicts with smart growth principles. Of course, there is the immediate problem of building the stadium in a floodplain with millions of taxpayer dollars required to improve

drainage and retention. Displacing the water with a giant complex does not adequately solve the natural flooding.

The intermodal transportation center that has long been a part of the Shockoe Bottom revitalization plan should not be hindered or complicated by accommodating a baseball stadium. Both the Boulevard and Shockoe site demand more pedestrian-oriented development, but the Shockoe site's historic and natural features would be negatively impacted by a large stadium structure. We need to 'Restore the Core,' not bury it under more concrete.

In contrast, the Boulevard can still benefit greatly from baseball. As mass transit advocates, the Sierra Club believes a stadium-anchored Boulevard center could be a popular stop for the City's new bus rapid transit as well as fans commuting from the counties as they have done for generations. For these reasons, the Sierra Club strongly questions Shockoe Bottom as a location for the ball park.

Finally, the strongest environmental argument against the Shockoe proposal is that it spurns the re-usability of the existing Boulevard ballpark. Adaptive re-use is the most 'green' option there is. Concrete accounts for more than 5 percent of human-caused carbon dioxide emissions annually, mostly because cement, the active ingredient in

concrete, is made by baking limestone and clay powders under intense heat that is generally produced by the burning of fossil fuels. Making finished concrete products - by mixing cement with water, sand, and gravel - creates additional emissions because heat and steam are often used to accelerate the curing process. Destroying the Boulevard Diamond ballpark and building a whole new one in Shockoe

Bottom will greatly increase the City of Richmond's carbon footprint. Mayor Wilder, along with over 250 mayors from all over the United States, signed the U.S. Mayors Climate Protection Agreement, which seeks to reduce global warming. Certainly, polishing the existing Diamond, refurbishing it with more modern and green features is less wasteful, less detrimental when compared to creating a whole new stadium in a new location.

There are other arguments against the Shockoe stadium proposal (financial uncertainty, regionalism, open government are just a few of the issues). Many of them are being aired and heard in the local media. The Sierra Club calls for equal consideration of environmental concerns. We are confident that the public will not only recognize the true costs of this proposal if given the chance, but also join us in opposition

### So What is a Walk Score? by Andrew Payne

For more than 20 years I've called Richmond, VA, my home. The ease of walking to the Virginia Museum of Fine Arts, Carytown, my dentist's office and a wide assortment of local businesses always has been an attractive feature for me and also many of my neighbors. According to the WalkScore (TM) website, my neighborhood (The Fan) has a score of 86 out of a possible 100 points for walkability. An adjacent neighborhood, Carytown, has a score of 88, and Virginia Commonwealth University (VCU) is ranked with a score of 91-just one and half miles away from home. So what do all these numbers really mean?

One of the perks of urban living is

the reduction of driving and the ease of walking to places like restaurants, dentist offices, hair salons and almost any other type of business or service someone may need. According to Wikipedia, Walk Score is the name of the company that developed a walkability index - also called a Walk Score. This walkability index is determined by an algorithm that scores amenities based on travel distance. Any amenity further than one mile away is awarded no points. The relevant amenities are described as parks, theaters, businesses, schools and other common destinations.

Do you like more walking and less driving? How about saving gas money



and getting more exercise? Needless to say, less driving helps the environment by decreasing air pollution and our demand for oil. Those are just a few perks of having a higher Walk Score!

### September Group Canoe Trip Suggested

But their best efforts at planning and organizing trips for our group have attracted only a handful of members. For example, last year, a river canoe trip with 30 potential places drew only 4 of our members - the rest being Sierrans from other groups or friends of FoJG members. Are we getting old, are our weekends too crowded, is it too far to drive, or what?

Nevertheless, the Peacocks are trying

again, suggesting a fall canoe trip that is a little farther afield, but well worth the extra travel time (we do car pool, don't we, and get to know each other better on road trips, right?)

They have suggested Merchants Millpond State Park in NC, just over the border from VA and about a 2 hour and 15 minute drive away. People can bring their own canoe(s) or kayak(s) or rent their own canoes at the park. It would not necessarily be a guided trip; there is a canoe trail there, and people could go where they want to, or follow the Peacocks. Andrew and Shavon have been there twice, say it's very beautiful, and say you can't get lost there! People could also stay longer and camp, there

if they were so inclined.

They have suggested Saturday,

September 14th. They recommend an early start of 7am so we can be on the water no later than 10am. Participants could bring picnic lunches and we could get off the water by 2 or so. Sound like fun? Since the Peacocks are not approved Sierra club trip leaders, this would have to be more an informal outing of interested folk from the club coming along for the ride. We could help organize car pooling for those who are interested in going, or individuals could arrange to meet friends at shopping centers or park-n-ride lots to carpool or caravan...

The 760-acre millpond is more than 190 years old and has developed into complex, mature ecosystems. Towering bald cypress and tupelo gum trees, displaying growths of Spanish moss and resurrection ferns, shade the pond's dark, acidic waters. Numerous species of aquatic plants, such as the floating yellow cow lily and the submerged coontail, thrive in the pond. A red and green layer of floating duckweeds and water fern often covers the water's surface.

At the upper end of the millpond is Lassiter Swamp, an ecological wonderland containing remnants of an ancient bald cypress swamp, an eerie "enchanted forest" worthy of a fairy tale. Mistletoe has twisted and gnarled the trunks and branches of tupelo gum into fantastic shapes. Surrounding the aquatic communities is an unspoiled wilderness. Stands of American beech highlight a mixture of pine and hardwood forests.
