Sabal (aka Sinkhole) Trail Update: Is FERC a Rubber Stamp or a Regulator?

On Sept. 4, the Federal Energy Regulatory Commission (FERC) issued a draft Environmental Impact Statement (EIS) for the Sabal Trail natural gas pipeline project. The Sabal Trail project would include over 500 miles of new natural gas pipeline in Alabama, Georgia, and Florida. This \$3.5 billion project is proposed to allow Florida Power & Light and Duke Energy to build over 3,200 megawatts of new fossil fuel power plants burning fracked gas in Florida. There is no benefit to Georgia for the passage of Sabal Trail through southwest Georgia.

Much damage could result in Georgia to people and the environment as the compressor station for Georgia is proposed to be located in the city limits of Albany. These noisy, brightly lit industrial facilities are significant

sources of noise, air, and water pollution. Perhaps the most reckless part of the proposal is the siting of the pipeline along hundreds of potential sinkholes. So many potential sinkholes are identified along the pipeline that the project is now called the Sinkhole Trail by concerned citizens. There is a long list of other problems such as the health threat to the residents of Albany, the reduction of property values, the taking of private property, damage to some of Georgia's best farmland, the threat to the quail plantations and the economy of southwest Georgia, the numerous river crossings, the destruction of wetlands, and the taking of habitat of endangered species like the gopher tortoise. Citizens raised all of these flaws at hearings in Southwest Georgia last week.

All of these concerns were ignored by FERC in the draft EIS. It appears the entire process may be tainted by conflicts of interests. Merjent is the lead contractor on the EIS. The Merjent website says: "We route them, survey them, permit them, inspect them, and provide operations and maintenance support services. We know pipelines and have supported all aspects of constructing new and maintaining existing pipeline systems across North America." Merjent has been paid by Transco, the company that has proposed construction of the Sabal related Hillabee Expansion in Alabama.

Cardno-Entrix is a direct contractor for Spectra, the proposed builder of the Sabal Trail project. Cardno-Entrix provided Appendix H of the draft EIS. Cardno's work on the Keystone XL project for Trans Canada led to a story in the New York Times on October 7, 2011, which resulted in an investigation by the Inspector General to look into whether the industry was "flouting the intent of a federal law meant to ensure an impartial review of environmental analysis of major projects.

With all these financial ties between the pipeline companies and pipeline contractors, does anyone think the citizens of Georgia are getting an impartial review of the issues? Is FERC just a rubber stamp for the oil and gas pipeline industry? Click here to take action.


