First, we are bidding a fond but reluctant farewell to Chapter Director **Colleen Kiernan**, whose last day with the Georgia Chapter is April 1st. "The mountains are calling and I must go," Colleen said. She's heading to Northern California for some well-earned R&R and will return to Atlanta in May to begin her next adventure.

Since joining as Director in 2010, Colleen has led the Chapter through one of the most successful periods in our history. Victories on clean energy include Cobb EMC's withdrawal from the Plant Washington coal project, the cancellation of the proposed Longleaf coal plant after an 11-year battle, and commitments from Georgia Power to retire a quarter of its coal fleet and add over 1 gigawatt in renewables. On the transportation front, Colleen led the Chapter's successful engagement around the 2012 T-SPLOST, followed by a historic victory on transit in 2014 as Clayton County voted overwhelmingly to join MARTA.

While Colleen leaves very big shoes to fill, the Georgia Chapter has much on its plate for 2016, and **we are now actively looking for our next Director!** If you think you have what it takes to lead the state's largest grassroots environmental organization, <u>follow this link</u> to learn more. We are continually impressed with Brionté's positive attitude, poise under pressure, and ability to make our communications look pretty.

Ian Karra, Georgia Beyond Coal Organizer, is going to keep being awesome, building power and entertaining us with an endless supply of situation-appropriate gifs.

We also welcome **Erin Glynn** back to our team as a consultant! A former Georgia Beyond Coal Organizer herself, now armed with a Juris Doctor, she will be working down at the Public Service Commission on improving Georgia Power's Integrated Resource Plan so that it includes a lot less coal and a lot more renewables and efficiency.

Finally, welcome **Lornett Vestal**, who joins our office in a new position of SE Military Veterans & Outdoors Coordinator. He'll be working to develop outings programming and volunteer leaders for veterans and their families in Georgia, Tennessee, South Carolina and Florida. Support MARTA Expansion: Contact your State Senators Today!



We are winning on clean energy. Five years ago the Sierra Club launched Beyond Coal, a campaign to retire one-third of our nation's coal plants by 2020. With your help--and the help of local organizers, lawyers, and partner organizations--200 coal plants altogether are retired or slated to be retired, out of the original 523 we took aim at. Railroad companies across the nation are reporting declining coal shipments as energy companies invest in cleaner, safer technologies like wind and solar. While there is still work to be done, the next frontier in our quest for a more sustainable world is to move us beyond oil.

Transportation consumes more than 70% of the 19 million barrels of oil used daily in the U.S. and is responsible for nearly 30% of all air pollution. Most of that comes from roads congested with cars that have only one passenger, the biggest problem facing the metro Atlanta region. In the past, our leaders have focused on investing heavily in roads to solve our transportation problems while underfunding transit.

Help us put an end to this road by sending a message to your state senator in support of expanding transit!

MARTA has unveiled a vision that would expand the system northward to Alpharetta, eastward to Stonecrest, and to Emory University. Their \$8 billion proposal would be funded by the half-penny sales tax proposed in <u>Senate Bill 330</u>. If the bill passes, county commissioners in Fulton and DeKalb counties would still have to vote to put a referendum on the ballot to be approved by voters.

No amount of road building will solve our transportation problems. By instead investing in convenient transportation choices like walking, biking, and public transit, we will reduce congestion and reduce our dependence on oil. Now, as our decision makers consider the various transportation funding options before them, it is critical that they hear from you.

Please send a message to your state Senators asking them to let the voters decide on supporting MARTA's expansion!


