



As special projects Chair of the River Trail of Illinois and Vice Chair of OSRAC I wish to respond to the trail article in the last newsletter.

\*No rip-rap along the Illinois River is in the request.

\*No flooding of wetlands will take place.

\*A .91 A mitigation for the solid part of the trail will return acreage to wetlandi.e. no net loss.

\*Over 20 species of native grasses and forbs will be placed on any disturbed areas caused by construction.

\*No 1/4 A portion of wetland will be filled

in for a fishing pier.

\*Objections raised by Tom Edwards were addressed prior to the newsletter and were not endorsed by the Executive Committee of the Sierra Club.

\*Project changes were accomplished by the efforts of the park district working constructively with the various state and federal agencies, and not because Tom Edwards wrote a letter the last day of the comment period.

\*Edwards proposal of placing the trail under high tension lines on wet ground subject to flooding and ice damage speaks for itself. The other proposal of placing it on service roads not owned by the park district and that have adjoing private property also speaks for itself.

# Fire as a Management Tool in Woodlands

Numerous botanical studies indicate oak-hickory upland forests are being replaced by shade tolerant species such as sugar maple, elm, ash, and ironwood.

Oaks and hickories are moderately fire-resistant in contrast to shade tolerant species. Historically, this adaptation allowed the oaks and hickories to survive fires, while preventing fire-susceptible species such as sugar maple, elm, ash, and ironwood from invading the upland forest.

Cessation of fire following European settlement has allowed conversion of open forest to closed forest and has encouraged the replacement of oaks and hickories by the shade tolerant species. Managers of oak-hickory forests now realize that fire can be a valuable asset and used as a tool in future management practices.

# HEALING THE RIFT BETWEEN MAN AND NATURE:

Along East Peoria's commercialized Rt. 116 along the east side of Lower Peoria Lake there still remain two superb privately owned marshes, and between them a mile long strip of woodland wetland owned by the Fondulac Park District.

Otherwise the east shore to the river bluff is consumed by a 4-lane divided hwy. with 2-lane access roads on both sides, a strip of commercial development on the river side of the highway, and a 200-foot powerline easement.

The park district has plans to cut still another corridor thru the woodland for a bikeway with state & local funds.

Rather than take a little more from Nature,

why not:

-- No. 1, secure those two marshes.

-- Expand what remains of Nature along the east shore out among the clearcut premises of the commercial establishments.

-- Let the expansive, mowed roadsides re-

turn to natural vegetation.

- -- Employ the sand beach berm along the lake edge, with its windblown, gnarled trees and beaver marshes, as a unique hiking trail.
- -- Use the cleared powerline easement for a trail into the marshland.
- -- Use the access roads for a tree-shrub bordered bikeway (they only have slow, limited traffic).
- -- Catch some of the copious amounts of spring water that wells from the bottom of the bluff to create springfed ponds along the access roads (as some private property owners have done).
  - -- Let the beaver be.
- -- Help the businesses to adapt to this motif.

-- Use all this to educate the public on how man and nature can, indeed, intertwine.

I have suggested this to the Fondulac Park Dist. as one beginning step toward what all peoples must new turn their attention to -- healing the separation between man & Nature.
