#### **REFUGE NEEDS LETTERS!** by Cheryl Pauli

Letters to Governor Edgar urging him to support the developement of the proposed Emiquon National Wildlife Refuge are urgently needed. The U.S. Fish and Wildlife Service's proposal to aquire from willing sellers 11,039 acres to restore backwater habitat, shallow open marshes, bottomland/upland forests and native moist soil plants is a significant developement for the entire state. This project has 89 State and Federal threatened and endangered species within the proposed 11,039 acres. It would aid in improving water quality within the wetlands systerm, plus protect and restore natural areas along the Illinois River basin. The Emiquon National Wildlife Refuge would offer a variety of recreational activities.

Congressman Lane Evans has sent a letter to the Interior Appropriations Committee requesting the funds needed to develope this project, but strong support from the Governor is also needed. #### NATURAL AREAS



At this time state and local governments are required to meet with the Department of Conservation about projects that may affect endangered and threatened species, but they do not have to meet with them on projects that may affect sites listed on the Illinois Natural Areas Inventory. Senate Bill 482 enhances the process by requiring the individual to meet with DOC on projects that may affect sites listed on this inventory. There are several natural areas within the HOI's region listed in Illinois Natural Areas Inventory. Action Needed: Contact your State Representative and Senator and ask him to support S.B. 482. #### PEORIA DISPOSAL UPDATE by Charlene Lemoine

On April 5 the IEPA denied Peoria Disposal's (PDC) permit modification request to vertically expand their hazardous waste landfill due to PDC's failure to provide proof of local siting. The denial process took 9 months, and the permit was denied during the time when the Appellate Court's ruling held that the PDC is not the sole generator of waste treated and disposed of in their landfill. Concerns continue regarding H.B. 1163 and S.B. 276. The language in both bills would have the last person to treat hazardous waste prior to disposal become the generator and require a permit for disposal only from PDC and not the original generator. The Illinois Environmental Council (IEC) is opposing this change, and will present concerns at the upcoming hearings. + Action Needed: Continue to oppose H.B. 1163 and S.B. 276. ## HOI BOARD ACTION

The Heart of Illinois board voted to support the Peoria Park District's action to put 246 acres of Detweiller Park into the Illinois Nature Preserves. An amendment was added stating their concern for possible over-management. This area of the park is listed with the Illinois Natural Area Inventory.

The board passed a motion supporting Tom Edwards' action on the Eastport Marina project. A motion to contact National Sierra Club about this issue was passed, also.

## FUTURE RAILS-TO-TRAILS

Although H.B. 2009 has been sent to interim study you are asked to contact your state representative and request that he oppose this bill if it should be removed from interim study. This bill would require abandoned rail right-of-ways to be offered to adjacent landowners before interested park or conservation districts have an opportunity to purchase intact righ-of-ways for biking/hiking trails or wildlife habitat areas. Action Needed: Let your state representative know you oppose H.B. 2009 and would like him to do so, if it is taken out of interim study this year. (see address under Natural Areas article)

#### PEORIA DIST. 150 ADOPTS WASTE REDUCTION. POLICY by Charlene Lemoine

Peoria District 150 School Board unanimously adopted a Waste Reduction Resolution as well as a Waste Reduction and Recycling Procurement Policy. The Resolution and Policy form a comprehensive plan to involve all students, faculty, and staff. Purchasing paper and other products containing post-consumer recycled content is addressed as well as a recycling and an environmental educational plan for all District 150 Schools. HOI Sierra Club, PEACE, and Peoria County Model Community presented letters to the School Board in support of their Waste Reduction efforts.
