Strengthen the Livestock Facilities Act

HOI Sierra Club members need to put extreme pressure on our state representatives to strengthen the Livestock Facilities Act. Members living in our western counties: Fulton, Hancock, Henderson, Knox, Schuyler, Stark, Warren; your areas are targeted by big hog corporations. The current law is weak, it leaves us all vulnerable to odor, groundwater contamination, lagoon spill disasters, and it threatens the very existence of the small livestock farmer.

To give you an idea what we are up against, note the double-talk of State Representative Rich Myers (Colchester). "Tough legislation can end up helping the larger corporation . .

. the more legislation we bring down on the large livestock producer, the more we push the business into their hands." He, of course, ignores the fact that the proposed regulations are aimed specifically at the large factory type farms.

Legislators Shadid, Hawkinson, Slone, Moffitt, Leitch, and Smith have collaborated on a set of proposals that would greatly improve protection from these huge confinement operations. Give them your support. Call and write your legislators NOW!

The Endangered Species Act Reauthorization: The Good, The Bad, and the Activist

The Good: H.R. 2351, the Endangered Species Recovery Act, introduced into the U.S. House by George Miller (D-CA) will reauthorize the Endangered Species Act, strengthen it, and address current loopholes. HR 2351 will:

- 1. reward those who take the extra steps to help recover species already on the brink of extinction.
- 2. offer tax incentives to landowners that make a commitment to manage their land for the good of society.
- encourage regional planners to manage development in a way that protects greenspace while allowing economic growth.

HR 2351 improves the existing ESA by strengthening approval standards. It requires that taxpayer-funded activities must not reduce the likelihood of recovery. It also requires that land use planning be consistent with the overall recovery of resident wildlife. (Continued on Page 2)

The Bad: Senate Bill 1180, deceivingly called a reuthorization of the Endangered Species Act, would destroy the current ESA. It includes the following:

- The Federal Agencies of the U.S. Government would be exempt from avoiding any action that would jeopardize the recovery or preservation of an endangered species.
- With no public notification and no criteria, the Secretary of State may grant anyone immunity from prosecution by singing a so-called "No Take" agreement.
- Allows such federal agencies like the Army Corp of Engineers to determine that such activities like river dredging are not likely to adversely affect an endangered species.
- 4. Allow the U.S. Forest Service and other forest agencies to continue charging forward with a bad forest plan for 15 months after a species becomes threatened or endangered.
- 5. Senate Bill 1180 turns back the clock on species protection by allowing the Federal Agencies to refuse to designate critical habitat that is crucial for the survival of an endangered species on the grounds that it is "determinable." This was the state of the current Endangered Species Act 15 years ago when Congress amended the current Act to close the "not determinable" loophole that had deprived species of habitat protection.

The Activist: Since the Clinton administration and both the Democratic and Republican Leaderships in the U.S. Senate support Senate Bill 1180, its passage is a very likely possibility. Concerned citizens must mobilize now and put the pressure on their U.S. Senators to OPPOSE Senate Bill 1180. Furthermore, a renewed effort is more than ever now needed to request that our U.S. congresspersons support H.R. 2351, the bill that the Sierra Club and other environmental groups support for the reauthorization of the Endangered Species Act.

Time is running out against the Endangered Species Act. Senate Bill 1180 is expected to come up for a vote sometime in October. We must mount a massive call in to our U.S. Senators to stop this destructive bill. Please call now!

Living Downstream

"In this, the story of central Illinois . . . receives my scientific attention not because its history is so unusual but because it is so typical. . . . central Illinois is the source of my ecological roots, and my search for these roots is part of the story." - LIVING DOWNSTREAM, An Ecologist Looks at Cancer and the Environment, by Sandra Steingraber.

Ms. Steingraber goes on to say: An upstream image "comes from a fable about a village along a river. The residents who live here, according to parable, began noticing increasing numbers of drowning people caught in the river's swift current and so went to work inventing ever more elaborate technologies to resuscitate them. So preoccupied were these heroic villagers with rescue and treatment that they never thought to look upstream to see who was pushing the victims in."

Sandra Steingraber, a native of Pekin, is an acknowledged follower of Rachel Carson who first alerted citizens of the Earth about carcinogenic toxins in her book SILENT SPRING.

Twenty-five years ago a not-for-profit Earth-based creative enterprise called the Sun Foundation began, centering its activities on the land adjacent to its founding directors' Blue Heron Farm. The goal of the Sun Foundation was to provide innovative and creative leadership in the arts and sciences.

Several months ago the Sun Foundation's board and staff decided to celebrate their twenty-fifth anniversary in a unique and special way. They resolved to bring together as many groups and individuals in the central Illinois area as possible to help identify as well as implement ways for ecological awareness in our midst. Susan Steingraber's book provided the necessary research with accompanying background information to navigate through and into a possible reduction of the number of known carcinogens here in central Illinois.

What has emerged is a group calling themselves "Living Upstream Downstream", who have begun to identify what can be done to reduce these known carcinogens. Its members try first to remedy pollutants existing in their homes, with some investigating what businesses in the area can do to reduce environmental hazards and encourage healthful living conditions.

In Susan Steingraber's book the application of pesticides and/or herbicides in the production of food is one of the chief carcinogenic concerns. The Blue Heron Farm, the Sun Foundation's family farm, has been converted to sustainable organic agricultural methods for the past 7 years, using neither pesticide nor herbicide. Joe and Jeff Kennel, two brothers who farm this land, use organic strip farming, doing this more profitably and with less investment than a conventional farm. The Sun Foundation's "Living Upstream Downstream" group is sponsoring a spring workshop for all area farmers and other interested folk on Mar. 14, 1998 at the Sun Foundation in rural Marshall County at Washburn, Illinois, from 9:30a.m.- 2p.m. Everyone will have an opportunity to question and discuss the advantages of organic farming with the Kennel brothers. Attendance is free and lunch will be provided. All are invited. Please mark this date on your 1998 calendars.
