HOI-F.A.R.M. Coalition to Fight Audit Privilege Law

Heart of Illinois Sierra Club and Families Against Rural Messes (F.A.R.M.) are combining efforts to repeal or change the Illinois Audit Privilege Law. This is the infamous legislation passed in 1994 that allows polluters to audit themselves and then keep violations secret from the public, even in civil and criminal proceedings. Both groups are very concerned about the effect audit privilege will have on livestock regulations. It is also a safe haven for all polluters.

A committee made up of Jane Johnson and Leonard Gorski of F.A.R.M. and Rudy Habben and Ralph Ginn of HOI is gathering information on possible ways to attack audit privilege. In Montana a group of four conservation groups, including Audubon, have forced the EPA to withhold authority for the state to administer several federal waste and air quality programs. EPA is currently investigation whether the Montana law violates minimum federal requirements for environmental law enforcement. This type of citizen challenge may be a possibility in Illinois. Outright repeal of audit privilege is another consideration, although undoubtedly a formidable task. Whatever our course of action, a broader coalition will be needed. Support Funding for Repairs to the Folsom Dam and American River Levees in California

Your calls and letters, faxes, and/or e-mail are needed to send an urgent message to Representative Ray LaHood. Please contact his local office and Washington, D.C. office to request that he support funding for repairs to the Folsom Dam and American River levees in California. Repairs and upgrades to the Folsom Dam and American River levees will provide cost effective flood control for Sacramento, California. Action may be taken any day, and your promptness is needed. Ray LaHood holds a critical vote to determine whether the Folsom Dam and American River levee repairs will be made or over \$2.6 billion will be wasted on construction of the highly controversial Auburn Dam.

Siting for the proposed Auburn Dam will place it on an earthquake fault. The Auburn Dam will be one of the most expensive dams ever built in the United States. It will damage or destroy up to 48 miles and 10,000 acres of wild lands along the rugged and scenic American River. This area is currently eligible for Wild and Scenic River status. Canyons which would be flooded include more than 400 Gold-Rush era and Native American historic sites. The Auburn Dam proposal must be stopped, and flood control can be done through repairs and upgrades to the Folsom Dam and American River levees. Contact Rep. TMDL, 303d, and the Illinois EPA

The U.S. Environmental Protection Agency has awarded Illinois \$34 million in 1998 for projects that improve drinking water quality. Up to 15% of this amount can be used for source water protection programs that PREVENT pollution from reaching water supplies in the first place (buffer strips, restoring riparian habitat and purchase of conservation easements are examples of source water protection projects). IEPA has chosen to invest NONE of this money in source water protection. HOI wrote a letter to IEPA asking for a review of this year's decision and greater consideration for source water protection in future years.

The TMDL process and source water protection are currently the only legal tools available for dealing with agricultural runoff and other sources of pollution which arise from land use. Total Maximum Daily Load (TMDL) refers to the level of pollutants a watershed can handle. Section 303d of the U.S. Clean Water Act requires states to identify those areas that do not meet water quality standards suited for fishing, swimming and other uses. Only recently has Illinois EPA begun to address section 303d. IEPA has, in May, released a list of waters which will have TMDL cleanup plans developed. There are 330 watersheds listed and prioritized. In the HOI area those watersheds include: Illinois River, Spoon River, Farm Creek, Big Creek.

HOI will monitor IEPA's progress in implementing the TMDL process and use of the Safe Drinking Water Fund carefully in the future. This agency does not inspire a lot of confidence in their commitment to a better environment.

High Phosphorous Levels in the Fox River

Water quality samples from the middle Fox River were found to contain levels of phosphorous that were many times what is

considered reasonable by federal standards. The USEPA has set a recommended maximum phosphorous concentration for streams at 0.1mg/L and areas of the Fox River were as high as 7.6 mg/L. The Illinois EPA does not have phosphorous standards and does not check on phosphorous regarding water quality. phosphorous levels have been tied to outbreaks of toxic bacteria, algae blooms, and other problems that can be hazardous to human and animal health. The Illinois Sierra Club headquarters office in Chicago is considering further studies of phosphorous in our waterways, and we might hope the Peoria area Illinois River will be included.
