

# HOI Group Holds Press Conference Opposing Lock and Dam Expansion

At a riverside press conference August 13th, Heart of Illinois Sierra Club challenged the U.S. Army Corps of Engineers to manage the Illinois River on behalf of all citizens and taxpayers, and not just for agribusiness and the barge industry. The Corps is working to convince the public that larger locks and dams are needed on the Illinois and Mississippi Rivers. Sierra Club contends the millions of dollars for such construction are not cost effective, and that the river ecosystems will deteriorate further with the increases in barge traffic brought on by larger locks.

Speaking from a podium on the lawn behind the River Station Restaurant, Mark Beorkrem supplied data to show doubling river lock size would be a gigantic taxpayer subsidy for business. Mark is a Heart of Illinois Group member and a longtime river advocate, serving as Mississippi River Basin Alliance Navigation Policy Director. HOI member Hal Gardner was quoted extensively in a <a href="Peoria Journal Star">Peoria Journal Star</a> article, pointing out that rail transportation is the most economical and environmentally friendly means of grain hauling in the Midwest.

Jonathan Ela, Midwest Office, Sierra Club, phoned Heart of Illinois Group to hold the press conference to coincide with a river tour for members of the Corn Growers Association. The Army Corps of Engineers provided two barges for the free Corn Growers tour, and the Corn Growers and

press conference, from page 1 members of the Peoria area business community were told the positive impacts doubling lock and dam sizes would have.

This environmental battle has just started to boil, as the Army Corps is expected to hold meetings to promote their expansion requests this fall. The Corps has already spent \$50 million in studies calculated toward justifying doubling lock and dam sizes on the Illinois and Mississippi.

#### "The Sierra Club gets a free ride on two barges" What?

If the above headline was all you read in the Peoria Journal Star on August 13 you could certainly get the impression that the Sierra Club received a free ride on the same two barges that the Army Corps provided free of charge to the Illinois Corn Growers. The teaser on page one for the article also reinforced the same impression, "Illinois Corn Growers helps Heart of Illinois Sierra Club with river tour." However, the article below the headline stated just the opposite - the Sierra Club opposes the taxpayer subsidized river tour of the Illinois Corn Growers and we did not participate in a free tour of the river. The Journal Star issued a correction the next day.

# Help Stop the Auburn Dam!

#### Ask Congress to Support Repairs for the Folsom Dam and Sacramento Levees

The fight to protect the American River north of Sacramento, California, from an exorbitant billion dollar dam has gone on for nearly three decades. The dam will drown fifty miles of scenic and historic canyon lands, which provide outdoor recreation for a half a million people each year.

In 1992 and in 1996 Congress turned down bills for Auburn dam construction, because of its unacceptable cost, the environmental damage it would do, and the fact that the dam site is directly above an earthquake fault zone.

California Representative John Doolittle wants construction money for his district and is determined to make every effort to get legislation passed. Citing flood control issues, Doolittle wants 35,000 acres of federal lands along the American River to be given to the state of California to facilitate construction of the Auburn dam. Doolittle has opposed repairs of the Folsom Dam and area levees, which are cost effective and environmentally sound ways to handle flood control concerns.

Please write to Illinois Senators Durbin and Mosley-Braun to let them know that you oppose any funding related to construction of the Auburn Dam. Let them know that you support repair of the Folsom Dam and Sacramento area levees, and that you wish to see the American River saved for its wild, scenic, and historic values.

Tucker Act Shuffle Relief Act	+	-			H.R. 992 is a "takings" bill that would increase litigation by inviting new challenges to environmental, health and safety protections already approved by Congress, and invite forum shopping by industries in search of responsive courts. (NO) - Passed the House.
Small Business Paperwork Reduction Act		-			H.R. 3310 would seriously undermine public health, safety and environmental protection in the name of paperwork reduction. It would broadly waive civil penalties for first-time violations of vital reporting and recordkeeping requirements. (NO) - Passed the House.
Forest Recovery and Protection Act of 1998		-			H.R.2515 would expand salvage logging by allowing it in roadless areas, riparian areas, and even old growth forests without any curbs on the abuses that have occurred in the past. It severly limits public participation in the management of our national forests. (NO) - <b>Defeated</b>
Clean Water and Superfund Site Funding			+	+	Amendment to the Budget Resolution to restore funding to reduce polluted runoff, improve drinking water and wastewater treatment infrastructure, and to increase Superfund Site cleanup funds. (YES) - Defeated
Percentage Depletion Allowance Repeal			+	+	Amendment to the Budget Resolution to repeal the percentage depletion allowance for mining on public lands. These subsidies encourage mining operations that would otherwise be uneconomical, and that often leave badly scarred landscapes and polluted rivers and lakes. (YES) - Tabled
Defense of the Environment Act		-			Amendment to H.R. 3534 (Mandates Information Act) that would place new safeguards requiring an open debate and an independent vote on the House floor on legislative efforts to weaken or rollback America's environmental protections. (YES) - <b>Defeated</b>
Mandates Information Act		-			H.R. 3534 creates new opportunities for Members of Congress to kill important health and safety protections without directly voting against them. It establishes new procedural hurdles against considering bills that impose certain costs on the private sector. (NO) - Passed the House
Sugar Subsidy		-			An amendment to the Fiscal Year 1999 Agricultural Appropriations Bill to modestly reduce the sugar subsidy for beet and sugarcane growers. Sugarcane fields have contributed substantially to polluted runoff and interrupted water flows that are helping to destroy the Everglades. (YES) - <b>Defeated</b>
Reduced Funding for Wildlife Services	+	-			Amendment to the Agriculture Appropriations bill to cut \$10 million from the operations budget of Wildlife Services. Wildlife Services wastes money by engaging in excessive predator control, using steel-jawed leghold traps, poisons, and aerial gunning to kill predators. (YES) - Passed
Reduced Funding for Wildlife Services (Revote)		-			A revote on the amendment to cut funding for Wildlife Services (one day after the original vote). (Yes) - <b>Defeated</b>
Senate Takings Bill			+	+	S. 2271 would change existing rules to give developers an advantage over local governments in lawsuits challenging land use laws. Developers could bypass local zoning appeals and state courts by filing takings claims against local governments directly in federal court. (NO) - Defeated
Energy Efficiency & Conservation Programs		+			Amendment to H.R. 4193, the Fiscal Year 1999 Interior Appropriations bill, to increase funding for energy efficiency and conservation programs: \$16 million for weatherization assistance, \$4 million for state energy conservation grants and \$5 million for transportation programs. (YES) - Defeated
Land and Water Conservation Fund	+	-			Amendment to H.R. 4193 to provide \$30 million for the state-side program of the Land and Water Conservation Fund. The money would provide matching grants to states and localities for conservation projects, open space protection, and parks and recreation. (YES) - Defeated
Logging Roads in the Tongass	+				Amendment to H.R. 4193 to prohibit funds from being used to build new logging roads in the Tongass National Forest. It would rectify the Tongass' omission from the Forest Service's moratorium on road building in roadless areas. (YES) - Defeated
Logging Road In Chugach National Forest		+			Amendment to H.R. 4193 to strike a provision mandating construction of a logging road in Alaska's Chugach National Forest which would adversely affect the largest wetlands complex on the Pacific Coast. (YES) - Defeated
Interior Columbia Basin Ecosystem Mgmt. Plan		-			Amendment to H.R. 4193 to strike the bill's provisions which would end the Interior Columbia Basin Ecosystem Management Plan. ICBEMP is an attempt to devise a new environmental management strategy on a large-scale, ecosystem level for the Pacific Northwest. (YES) - Defeated
K-V Fund for Forest Service Overhead	+	+			Amendment to H.R. 4193 to strike a provision allowing up to 25% of the Knutson-Vandenberg (K-V) Fund to be used for Forest Service overhead. K-V was originally intended to pay direct expenses for replanting and post-logging restoration of timber sale areas. (YES) - Passed
PCB, Mercury, Pesticides, and Clean Air		-			Amendment to H.R. 4194, the EPA funding bill, to strike provisions that would delay PCB cleanup, delay federal action to protect children from pesticides; delay the cleanup of mercury from power plants; and interfere with EPA's efforts to clean the air in national parks. (YES) - <b>Defeated</b>
EPA Global Warming Gag Rule		-			Amendment to H.R. 4194, the EPA funding bill, to strike provisions in the bill that would in effect prohibit the EPA from conducting educational outreach or informational seminars pertaining to global warming. (YES) - Passed


