This is a program that promotes the planting of trees, shrubs, and grasses to improve water quality. The Buffer Initiative facilitates a voluntary and flexible process enabling landowners to preserve their land through stream side buffer plantings, stream bank stabilization, constructed wetlands, and planting around livestock facilities. Recent state legislation directs Illinois State agencies to work with Trees Forever in establishing an Illinois Buffer Initiative. *All are welcome! Refreshments served after the meeting.*





Madison Park catalpas, win. Big Hollow white oaks, loss. There are many more such instances, but they are largely unknown or forgotten by you and me. With sufficient public outcry, we save a few individual or small stand of trees. More often trees are felled before an objection can be raised. The net loss of our trees and the canopy cover they provide may be hard to perceive, yet it is occurring at a painfully fast pace in our area. The primary cause is commercial and residential development. What is it that we are losing? Apart from their aesthetic appeal, trees and forests lower energy consumption, reduce air pollution, preserve topsoil, protect watersheds, and provide wildlife habitat.

The current Peoria Landscaping Ordinance does little to protect trees. It is designed to reduce the





Peoria to Chicago Highway "Corridor A" Raises Ire

Please write and/or phone Representative Ray LaHood (309-671-7027), 100 NE Monroe, Peoria, IL 61602, and Eric Therkildsen, Illinois Department of Transportation, 401 Main, Peoria, IL 61602 (309-671-3333) to let them know your opposition to the proposed Corridor A Peoria to Chicago highway.

The southern part of this proposed route will run north from Illinois Route 6, in between Route 29 and the wooded bluff to the west. This route has multitudes of negative environmental impacts, in addition to being very poorly located as a true metro Peoria-Pekin-Morton route to Chicago. The proposed Corridor A will run very close to such jewels in the area park system as Singing Woods and Camp Wokanda. The Peoria Park District Audubon Preserve, which is a seasonal wetland north of the Caterpillar Mossville Plant, will be severely impacted. Increased water run-off and added silt to the area creeks and Illinois River are major concerns. More information is available at the No Way Corridor A website www.nowayca.org and you can learn more about the issue at upcoming meetings. A Citizen's Group opposed to the proposed Corridor B, which runs approximately along Route 116 east of the river has also been formed. Corridor C is a proposed route running approximately along Route 24 to the east.

Yes, those little twigs and shrubs scattered around the parking lot of the neighborhood mega-superstore are there for your enjoyment because the City said so. As appreciative of these tiny offerings we might be, it is time to ask for more. Peoria needs a Tree Preservation Ordinance.

HOI Sierrans have been working with the Peoria Urban Forestry Board (PUFAB) to develop a tree preservation ordinance. We wish to have an ordinance that protects our biggest and oldest trees as well as preserves and enhances the city's total tree canopy cover. Developers should be given substantial incentives to save existing trees and substantial fines for reneging on a site plan to saving those trees. The city needs a comprehensive tree inventory in order to manage its resources. These and many more elements are needed to create a robust and effective tree ordinance.

PUFAB will be taking to the city council, perhaps in September, a draft version of a tree preservation ordinance, along with a request to have City staff prepare the formal ordinance. Let's put an end to campaigns to save individual trees (maybe). We can win the war if the city has the tools and resources to manage its urban forest. You might mention some of this to your council representative.

Integrated Pest Management

Have you ever wanted to help reduce the use of dangerous chemicals in your local school? Here is your chance, in a fairly easy, highly structured fashion with little time requirements. How can you say no?

A new state law requires all public schools to begin Integrated Pest Management (IPM) this fall. IPM eliminates routine chemical pesticide spraying and instead relies on simple building maintenance, frequent pest surveys and as a last resort, site specific spraying. IPM is a proven, reliable cost-effective method that will reduce chemical exposure to children and adults in the school buildings. It is the law.

YOU CAN HELP your school implement this program and make a difference. The Living Downstream committee of the Sun Foundation has resource materials, sample letters to school administrators, and local activists who will help you get the new law put into action in your school. They will explain the process, talk to pesticide contractors and school boards if necessary, review the monitoring programs and make short presentations to school faculty. YOUR JOB will be to choose a school district, make contact with the people listed below and then meet with them to determine how to best approach the school administration. Each school district is different, and the largest, Peoria Public Schools, is probably the most difficult to implement. So join the effort and make a difference!

Petition on Emiquon Property and Thompson Lake Area

A petition regarding The Nature Conservancy purchase of the Thompson Lake Area near Dickson Mounds will be available at the September Heart of Illinois Sierra Club meeting, and copies can be obtained by phoning 309-688-0950. conservationists were heartened when The Nature Conservancy announced earlier this summer that they would be purchasing Thompson Lake for habitat restoration. For years, the U.S. Fish and Wildlife Service has been working on adding acres to their Emiquon Refuge, which will restore hundreds of acres of wetlands along the western side of the Illinois River. The Thompson Lake purchase is the key to the restoration project. However, an unfortunate dispute exists between The Nature Conservancy and the U.S. Fish and Wildlife Service. The Nature Conservancy has announced it will reconnect the area to the Illinois River. The U.S. Fish and Wildlife Service and long-time area conservationists believe Illinois River water will pollute the habitat and that other management steps are needed. Many individuals also hope that The Nature Conservancy will sell their entire purchase to the U.S. Fish and Wildlife Service to complete the Emiquon Refuge.
