HOI Monitoring Water Runoff from Two CAFO's

In March of this year, the Heart of Illinois Sierra Club started a second water monitoring project. We had completed the Illinois River project in the summer of 2002. The new project will include testing water runoff from two CAFO'S (concentrated animal feeding operations). Both CAFO's are large hog farms, one in Knox County (The Highlands) and the other in Woodford County (Old Prairie Pork). Collection sites were selected in February and early March

and collection of water samples was initiated in late March. Our first samples will be tested for fecal coliform. If early results indicate that other tests are needed, they can be added. Additional tests under consideration are for nitrates, phosphates, and dissolved oxygen. Water samples will be collected on a monthly basis as well as after each significant rainfall. Testing of the water samples will be commercially contracted to Peoria Disposal Company in Peoria. Our goal is to collect scientific data on the quality of the watershed runoff from the two CAFO's.

There have been numerous incidents of stream and river contamination from CAFO's in Illinois in recent years. Two serious incidents occurred in Central Illinois within the past two years. The High-

lands applied excessive waste to their fields in June of 2002, resulting in contamination and a fish kill in French Creek. In 2001, Peoria County located Inwood Dairy had a waste lagoon overflow into a tributary of Kickapoo Creek, causing contamination and a fish kill.

We have two project teams in place. The Woodford County team is represented by John Imhoff, Herb Guth, Rich and Margo Tennis, and Steve Jauch. All live in the area of Old Prairie Pork. The Knox County team is represented by Karen Hudson, Abby Letzter, and Lucy Havolic. Lucy and Abby are students at Knox College in Galesburg and Karen lives on a farm near Elmwood. Funding for the project has been provided by Global Resource Action Center for the Environment (G.R.A.C.E). Joe Laszlo, conservation chair of HOI, is the Monitoring Project Coordinator.

Your Letters and Calls Needed Now on State Issues!

Support Senate Bill 1379; The Safe and Clean Communities Act

This legislation will strengthen Illinois' enforcement of existing safeguards against contamination of our air, land, and water. If a company applies to the Illinois EPA for a permit to discharge new pollution into our air, water or land, the EPA needs to review the applicant's prior records. Companies with a history of violating pollution laws could be denied a permit for further discharges. Other provisions of the bill make environmental pollution fines equal more than the economic benefit that the polluter gained by cutting corners and violating the environmental laws, and it prevents state contracts with repeated violators of environmental laws. Illinois Senator John Cullerton developed this bill with Attorney General Lisa Madigan

Oppose Senate Bills 1521 & 1804; Oppose House Bills 2816 and 2273 These bills promote ATV, dirt-bikes, and 4-wheeler use.

Senate Bill 1521 and House Bill 2816 remove a longstanding prohibition against using funds from the Off Highway Vehicle Trust Fund to build ATV facilities on land owned by the Illinois Department of Natural Resources. Currently, these funds are used for ATV facilities on private land. High noise levels, disruption of wildlife, off-trail and trail damage, and safety threats to riders are major concerns. ATV engines have noise levels that can be heard from up to 7,000 feet away to over 11,500 feet, which is over two miles.

Senate Bill 1804 and House Bill 2273 would limit enforcement of safety laws regarding ATV use. Illegal ATV riders have caused serious damage at Cahokia Mounds, Illinois Nature Preserve lands, levees and other locations. These bills would limit fund expenditures on law enforcement against illegal ATV riders. Public land managers already do not have adequate funds for monitoring ATV use.

Support House Bill 422; The Illinois Wetlands Protection Act

H.B. 422 will allow state protections for wetlands that the federal government is no longer protecting. Federal protections for critical isolated wetlands were vastly limited in 2001 and Illinois has no state-level program in place for protecting these areas. This bill also enables Illinois counties to protect their wetlands if the county so chooses and puts in place a program that is as protective as the state's. Illinois has lost over 85% of its wetlands. Wetlands are essential for filtering pollutants out of our water supplies; protecting areas from flood damage; providing wildlife habitat and migrating bird areas; and absorbing rainwater.

Support Senate Bill 1060; The EPA-NPDES Discharge Fee Act

This bill will establish an application fee for water pollution permits in Illinois. The Illinois Environmental Protection Agency (EPA) issues NPDES (National Pollution Discharge Elimination System) permits to discharge industrial wastewater treated sewage and other forms of pollution into Illinois' rivers lakes and streams. At least 39 other states (including all of our neighbor states) charge a fee for water pollution permits. Illinois does not. You have to pay a fee for licenses and other state services but currently Illinois businesses pay nothing to apply for water pollution permits. Illinois taxpayers support the costs of processing and monitoring approximately 800 permit applications each year. Permit fees established by this bill will help develop restoration plans for the state's most polluted waters and fund clean-up programs. The fees will also provide an incentive for the state's largest polluters to reduce water pollution and remove toxic chemicals from discharges into our rivers.

Support Conservation and Land Acquisition

Please write to your Illinois Senator and Representative and ask them to support funding for Conservation Land Acquisition. Let them know that Illinois needs a new long-term program to protect open space for our families and for our future. The Illinois' Natural Areas Protection Program will expire this June, and after that time our state will not have any significant source of funding for the acquisition of threatened natural areas. It is essential that Illinois has a solidly funded program for acquiring lands for natural areas.

A Friend Lost

The environmental community lost a friend on the warm spring afternoon of March's ultimate day. Cassie Dunbar, wife of Ron Dunbar, mother of six children, ages 7-19, was shot and killed in her home by an intruder high on crack cocaine. "Cassie was an environmentalist. Her life centered around the environment," said her father, Daniel Jones. She was a member of Ducks Unlimited, Pheasants Forever, and Bat Conservation International. She and Ron were co-chair of the Illinois River Sweep out of Chillicothe in 2001 and 2002, and she was a working activist in No Way Corridor A, a grassroots group opposing the north route of the Peoria-Chicago freeway. Ron Dunbar, her surviving husband, was a member of HOI's water monitoring team that completed a year long study of the Illinois River in 2002.

The confessed killer is Jayson Schertz, a 28 year old drifter, who happened to be driving by the rural Dunbar house in search of drug money. He saw Cassie working in the yard, pulled in the driveway and asked for "gas money." Schertz followed her into the house, when she agreed to give him \$20, and shot her three times. The first shot hit her in the arm, she picked up a fireplace poker and struck him in the back. He shot her twice more, killing her. He was in custody within two days. Police discovered that he had taken Cassie's checkbook, written a check to himself for \$100 and cashed it at her bank in Chillicothe. Schertz has a long history of arrests for burglary and drug use.

This was a random killing, a tragedy that will deprive six children of a mother, a husband of a wife, a mother and father of a daughter, two women of a sister, and countless others of a friend.
