## The Lies They Spin

Government in

the lie game.

America, at every

level, has learned

When did it become acceptable for the media to label the old fashioned, baldfaced lie an overstatement...exaggeration...hyperbole...spin... misspeak...prevarication?" The latter is a strong word, but no one knows what it means, so there's no harm in using it. Government in America, at every level, has learned the lie game. Say what is needed to fit your agenda, and if caught in untruthfulness trust the media to use standard euphemisms. The me-

dia's unwillingness to call a lie a lie is noted by only a few in the audience.

The War in Iraq has provoked the most egregious of these gloss-overs, but governments at the state and local level are not im-

mune to "embellishment". This pattern has, of course, spilled-over to environmental issues. Christine Whitman, exdirector of the Environmental Protection Agency (EPA), said that relaxing clean air requirements will provide manufactures, utilities, and oil refineries with new flexibility and decrease pollution. President Bush proposed new rules that would allow increased timber harvest on public lands to "prevent forest fires." The same Bush ordered the EPA to delete concerns about health and environmental changes in its long awaited report on global warming. James Connaughton, chairman of the White House's Council of Environmental Quality, said the changes were ordered because the EPA report "overstated" causes of climate change and the report needed to be condensed to make it more usable by the public. On the 4th of July, at Warren Dunes State Park and nearby Lake Michigan beaches, seven swimmers drowned in killer rip-tides. Michigan Department of Natural Resources officials say that the red warning flags were out that day (a red flag meaning dangerous conditions exist and no swimming is permitted), although their view from Lansing, 130 miles away, is disputed by on-the-beach eye witnesses, who saw yellow flags.

Are the above examples of government lying? Of course they are. Does any clear thinking, objective mind believe that in all of the briefings the President attended from October 2002 to February 2003, no

one mentioned that the yellowcake uranium documents were forged? Impossible.

During the 15th stage of the 2003 Tour de France, Lance Armstrong fell when his bicycle's handlebar caught on a pressing spectator's handbag. His closest pursuer, Jan Ullrich avoided the crash and immediately slowed to wait for Armstrong to catch up. A similar incident involving the same two riders occurred in the 2001 race. Ullrich crashed during a downhill ride and Armstrong slowed until Ullrich was back on his bike. An example of sportsmanship at its finest and regrettably rare. Both athletes displayed integrity and respect for each other, and their sport. Oh! that government officials, and the media would choose that same integrity and respect.

## Wetlands: Call Your State Senator

We all get a lots of appeals to call/write our political representatives and this is another, but a very **IMPORTANT** one. Many Sierrans worked extraordinarily hard to gain a victory in the Illinois House of Representatives to get an Illinois Wetlands Protection Act passed that would extend protection to isolated wetlands. The next hurdle is the Illinois Senate. It will consider HB 422 during the November veto session.

The necessity of this effort was perpetrated by the U.S. Supreme court in 2001, in an all too familiar 5-4 decision, when it ruled the Federal Clean Water Act would no longer protect wetlands that were not connected to navigable water. In Illinois, this meant that 60% of our remaining wetlands (only 10% of original wetlands survived the 19th and 20th centuries) lost all federal protection.

This effort is probably the most important environmental effort, at the state level, of the past ten years. **PLEASE call or write:**

## Governor Helps Protect State Parks from ATVs and Dirt Bikes

On August 18th Governor Rod Blagojevich used his amendatory veto authority to propose changes in two bills passed by the Illinois General Assembly. Blagojevich vetoed allowing the use of state funds to build tracks for dirt bikes and four-wheelers in state parks. Funds can be used to build special all-terrain vehicle facilities outside of the state park system. The Governor also proposed changing the amount of funds from 15% to 30% annually in the Off-Highway Vehicle Trails Fund that can be used to enforce existing laws against unsafe off-road vehicle use. Illegal use of ATVs and dirt bikes cause major damage to many park area in Illinois, including Cahokia Mounds, in the Shawnee National Forest, and Illinois Nature Preserve areas. ## Trail Funding Being Axed By Bush and Republicans

If anyone remembers President Bush's Fitness Initiative, you can put it in the ranks with "No Child Left Behind" for a glitzy press op that has no substance in adding Federal funds to critical needs for our country. Please apply the word "lie" if you wish because we are talking about insulting, misleading, and blatantly abusing the public good .

In spite of overwhelming evidence of the lack of physical fitness of Americans and the huge percentage of citizens that are obese, not to mention just fat, Congress is on the way to cutting funds for trails and related rail-trail projects. Federal funding before Bush II helped build hundreds of bike and pedestrian trails since the early 1990s. Quoting from the 8/20/02 Runner's World magazine, "It's hard to imagine anything the government has done, or could do, that more effectively promotes health and fitness than providing a 'fitness infrastructure' of trails for the public. And yet this major source of funding has been put at risk, and unless there's a serious public outcry when Congress reconvenes, it may disappear."

Lead by Oklahoma Republican Ernest Istook, Jr., who is head of the Transportation and Treasury Subcommittee of the House Appropriations Committee, funds for Transportation Enhancements which include trail projects in the Department of Transportation's 2004 budget will be transfigured. Istook's committee has already added \$4.8 billion in highway spending above what the White House requested for next year. Does more highways and no trails make sense for a nation of fat adults and kids?

Write to Rep. Ernest Istook and to our Illinois Rep. Ray LaHood and to President Bush to demand that Federal funding for trails and rail-trail projects be maintained. Let them know that American needs public trails and remind them that this is one of the best ways President Bush can follow-through with his "President's Fitness Initiative".



## Sierra Club Helps Prepare "Patch Pouches"®

Heart of Illinois Sierra Club Conservation Chair Joe Laszlo and Heart of Illinois Planned Parenthood Director Joyce Harant are shown preparing "Patch Pouches" for distribution. A press conference was held July 17<sup>th</sup> at the Peoria Riverfront to introduce the project to the public. Patch Pouches are being supplied at area Planned Parenthood offices and some local pharmacies for women who use birth control patches. Discarded patches contain significant amounts of hormones, which can get into the water supply more readily if they are flushed down toilets. Used birth control patches should be placed in the Patch Pouches and returned to Planned Parenthood for proper disposal. The goal of the project is to keep birth control patches from being flushed into the water system or put in standard garbage. High hormone levels in surface water have been shown to negatively impact fish and other wildlife.
