# Appeal Filed Regarding Illinois Pollution Control **Board Decision for Peoria** Disposal Company Waste

At the January 21st, Heart of Illinois Sierra group meeting, the group voted to proceed with an appeal of the Illinois Pollution Control Board (IPCB) decision approving the Peoria Disposal Company (PDC) request to delist Electric Arc Furnace Dust waste (EAFD). As Sierra members, we are "one club" and court cases are filed under "Sierra Club" and not a specific local group. HOI obtained national Sierra club approval to proceed with the appeal. The appeal is being

# A Moment Too Late

The election and inauguration are finished, but before we move on, some reflection is good for the public memory. In the four months prior to the day Barack Obama became our President, George Bush rushed through regulations and policies that, if left in place, will have alarming consequences for the environment. On election day, November 4, the Bush administration announced a plan to open up 160,000 acres of Utah's Redrock Wilderness to oil and gas drilling. Some of this public land is adjacent to Arches and Canyonlands National Parks. In October Bush announced yet another plan to strip wolves of their endangered species protection and turn their management over to the states. A year ago Bush did essentially the same thing but was blocked by a court injunction, after 110 wolves were killed by state agents and hunters. In December Bush implemented a rule that frees federal agencies from having to consult independent biologists before approving any construction or extraction that could lead to the extinction of birds, fish, mammals, or other endangered species. This would put the fate of many species, that are on the brink, into the hands of industry biased departments like the Corps of Engineers, and The Forestry Service. Also, the Bush Interior Department eased rules on mountaintop mining companies which will allow them to dump waste into rivers and streams, and the Environmental Protection Agency relaxed restrictions on water and air pollution from factory farms (CAFOs).

Some of these transgressions can be stopped or changed by the Obama administration but some will be difficult to counter. New rules will have to be put in place, some of which will require Congressional approval, a process that is always slow and often an invitation for pork barrel additions. It is likely that a few of the new Bush rules will disappear only if environmental groups challenge them in

The upside is that President Obama is committed to a strong environmental agenda. The first time I had heard of him was in the spring of 2004, when the Illinois Chapter of Sierra Club endorsed him in the democratic primary for the U.S. Senate. He has a daunting array of important issues confronting him and environmental concerns will be in line behind a sinking economy. Nevertheless, Mr. Obama has pledged to support new energy policies, including energy sources other than fossil fuels, and to reducing global warming gases. A recent report by the National Oceanic and Atmospheric Administration states that irreversible damage from climate change has already occurred. The report defines "irreversible" as change that would remain 1,000 years if humans stopped adding carbon dioxide to the atmosphere immediately. Spokesperson Susan Solomon says, "Climate change is slow but it is unstoppable." The report concludes that if carbon dioxide levels peak at 450-600 parts per million the result would be decreases in dry-season rainfall that are comparable to the North American Dust (See **Too Late**, page 2)

done in conjunction with Peoria Families Against Toxic Waste (PFATW). Attorney David Wentworth, of the Peoria law firm Hasselberg, Grebe, Snodgrass and Birdsall, is handling the appeal for Sierra and PFATW. EAFD waste is a federally listed hazardous waste which must be treated and landfilled in a licensed hazardous waste landfill.

The IPCB decision allows PDC to use a new treatment process on the EAFD and send it to municipal waste landfills. This will enable PDC to keep from reaching capacity at their hazardous waste landfill at Peoria, while they continue taking in EAFD waste, which is their largest waste entity. An estimated 95,000 cubic yards a year will be diverted from the hazardous waste landfill and shipped to a municipal waste landfill. Donations are needed to help with expenses for this effort. # Industry Coal Strip Mine Destroying the Last Remnants of Historic Chandler Woods

Concerned citizens in Macomb requested a hearing regarding the Illinois Department of Natural Resources Office of Mines and Minerals (OMM) fifth renewal of the Industry coal strip mine permit Number 16. Industry is a small town about nine miles south of Macomb, however the actual strip mine is located closer to Colchester to the west. Mine permits are renewed for five years at a time. Permit 16 covered 2,750.8 acres in 1991. Much of the strip mined area was forest. A mine document appeared to indicate that 766 acres of forest would be restored in Permit 16, but it is difficult to see where this has been done. The Industry Mine is actually a conglomeration of multiple mine permits, approved since the 1980s. There have been numerous boundary revisions and changes to the permits. Industry mine permit Number 357 includes a massive coal haul road crossing at Grindstone Creek. This permit is being contested in court. The U.S. Fish and Wildlife Service recommended denial of the permit, however, OMM approved it in 2003. Indiana Bats were documented in the permit area. There was also a large heron rookery in a section of Grindstone Creek. A court decision to revoke Permit 357 would mean all the forest and creek destruction for the haul road is for naught. Sadly, what is left of the great Chandler Woods of McDonough County is continuing to be destroyed for strip mining. Illinois Sierra has funds for volunteers to be trained to do water monitoring. Volunteers are needed for monitoring from public roads in the mine area. For more information phone 309-688-0950.



A view of Grindstone Creek, south of Macomb, McDonough County, which has a historic heron roost. Indiana Bats, a federally endangered species, were documented to be using the creek area and a bat roost tree was found with 46 bats flying out when disturbed. The steep bank and thick woods are part of what was once the thousands of acres of Chandler Woods, the largest contiguous woodland left in the county, before Freeman Coal Company, now Springfield Coal LLC, began strip mining the area in the 1980s. A new section of the strip mine will continue destroying hundreds of acres of forest. A mammoth haul road is being constructed over Grindstone Creek. Greg Arnett, engineer for Capital Resources Development Company who filed for the proposed Banner Mine, and is now North Canton LLC, with the proposed North Canton mine, is the engineer for all of these coal strip mines. # IDNR Planning to Schedule Hearings For North Canton Strip Mine Permit

Congratulations to members of Canton Area Citizens for the Environment, who have been getting many letters to the editor in area newspapers to inform people of problems regarding the proposed North Canton coal strip mine. Citizens from around Canton and members of HOI are waiting for the Illinois Department of Natural Resources (IDNR) to set a date for an Administrative Review hearing of the North Canton strip mine permit. The hearing is to review issues regarding the mine impacts and other matters in which citizens

contend the IDNR has failed legal requirements in approving the permit. A hearing officer chosen by IDNR will be in charge of the review and will decide on the issues after evidence is presented by all concerned parties.

Members of HOI and Banner area citizens participated in the same process during an Administrative Review of the Banner strip mine permit, which took 15 days spread out over 6 months. The Banner review is not yet finished, as attorneys for each side have additional filings for the case.
