2014 A Year of Firsts! New Initiatives for Clean Air, Energy, Water and Habitat Protection

Some new initiatives highlight the last year and we have some amazing "Firsts" for 2014. This is just a sampling of events and efforts by Heart of Illinois Sierra Group. We need your help and continued support for our work. Here is a short list of some amazing "Firsts" that HOI accomplished in the last year:

Clean Air - HOI volunteers were part of the first legal challenge on air pollution from the Dynegy Edwards power plant. A delegation of HOI volunteers spoke in Springfield at the Illinois Pollution Control Board hearing on power plant coal ash regulations.

**Clean Energy** - Central Illinois Healthy Community Alliance (CIHCA) HOI volunteers were part of first and on-going labor and environmental forums chaired by Senator Dave Koehler and Rep. Jehan Gordon-Booth. The HOI Group raised unpaid bond issues resulting in the Industry coal strip permit 16 renewal being denied by IDNR. In February, the HOI Group hosted the Beehive Art Cooperative's dramatic art presentation on the true costs of coal.

Clean Water - At a federal EPA hearing, HOI volunteers supported protection of the Mahomet Aquifer from Peoria Disposal Company's chemical waste dump at

Nearly 100 Peoria area residents attended the documentary film "Triple Divide" at Illinois Central College October 28th, which was sponsored by Global Village, Peoria Families Against Toxic Waste, Illinois Central College student environmental group and HOI Sierra. CI-HCA, and other groups participated in tabling at the event. The movie detailed air and water pollution from fracking in Pennsylvania and told the stories of numerous families whose water, health and lives were ruined by nearby fracking.

LaSalle County resident Rick Coleman spoke as part of a panel after the film. He talked about the huge expansion of sand mines in LaSalle County and how the dust, noise, and land destruction are changing the very nature of the area. He is fighting to protect his farm and water resources. Many of his neighbors have lost hundreds of thousands of dollars in property values and many have moved away. There are ongoing risks to the local groundwater, area health, potential harm to Starved Rock State Park east canyons, and to the Illinois River. Much of LaSalle County is in the HOI Group area.

Typical fracking wells can use over 4 million gallons of fresh water per day. Fracking can use over 10,000 tons of the highest quality silica sand per well. This special sand is found in northern Illinois, Wisconsin, Minnesota, and Michigan. Sand mining expansion is part of the environmental harm from the fracking boom. The huge quarry type pits dug to remove the sand remain after mining and are part of the land devastation from fracking.

Clinton. Volunteers displayed the impact of toxic coal ash in our water on Earth Day and at the Peoria Clean Water Celebration.

**Habitat Protection** - The Peoria Riverfront Museum and the HOI Sierra Group hosted "Monarch Butterflies and other Pollinators Day" May 24th at the Riverfront Museum. Table displays from the HOI Group and other organizations offered close looks at honeybee keeping, moths, monarchs and other butterflies, insects, hummingbirds and native bees.

HOI volunteers participated in a reduced roadside mowing program in Peoria County for enhancing native plants.



Banner flood plain lands viewed from what is left of the historic Prairie Lane Road off of the Banner Dike Road.




#### Bob Jorgensen
