Property Owner On or Near a Northern Pass Site? Read On...

Northern Pass was introduced to New Hampshire at a press event in Franklin in October of 2010. Going into our sixth year of public discussion, NH Sierra Club is encouraging New Hampshire residents and landowners to participate in the Northern Pass application process at the NH Site Evaluation Committee (SEC). Landowners in particular, have an important role in the discussion and they have property rights that must be defended. NH Sierra Club opposes Northern Pass for a number of reasons (read more here) but we are not a landowner.

The Public Utilities Commission is also reviewing a request from Eversource seeking permission to "rent" the land easements with existing power lines to its subsidiary Northern Pass who will then be paid by Canada to build the 80-120 foot towers for the international transmission proposal without changing the current terms of the land easements on people's property. First and foremost, NH

Sierra Club does not believe Eversource has the right to rent out your property without your expressed permission. Secondly, NH Sierra Club does believe we need the destructive project's power period.

Please call the NH Sierra Club office if you would like to intervene in these venues. The deadline is Feb 5 for the SEC Northern Pass Application, so please call (603) 224-8222 as soon as possible. We can discuss the issue and assist you.

Proposed Bobcat Hunting and Trapping Season

The NH Fish and Game Commission recently voted to open a hunting and trapping bobcat season with a lottery for 50 permits for NH residents. The draft rulemaking proposal is now open for public comment. The state will host a public hearing on February 1, and will accept comments until February 10.
