

Technology: Solar Photovoltaic


Price History of Silicon PV Cells (2018 \$US per Watt)



Corporate Social Responsibility Surveys

- More than half of global consumers would pay more for products and services from companies committed to positive social and environmental impact.
- Two thirds said they would prefer to work for a socially responsible company.
- 81% of millennials expected their preferred companies to make public declarations of corporate citizenship.

From SRI to ESG

- Socially Responsible Investing
 - Based on ethical and moral criteria
 - Mostly negative screens, such as not investing in alcohol, tobacco, firearms, nuclear power, etc.
- Environmental, Social, Governance Investing
 - Based on the assumption that ESG factors have financial relevance
 - No companies omitted from consideration
 - Companies are scored according to their accomplishments in key areas

Financial returns alone are not satisfactory



 - Carbon-risk rating

Active and/or Passive Management

<u>Active</u>

- Professional managers
- Use expectations of performance
- Choose timing and weighting



<u>Passive</u>

- Rules that don't change
- Rules determine
 - which companies
 - how much
- Mirror performance of an index




Fixed Income – Green Bonds

- Fund projects that have positive environmental or climate benefits
- First Green Bonds were issued in 2007 by the European Investment Bank
- Through 2013, Green Bonds primarily issued by development banks, such as the World Bank and African and Asian development banks.
- Corporates, banks, and municipalities are increasingly issuing Green Bonds.




The Green Bond Market

Investing in Green Bonds

- Mutual funds & ETFs based on indexes such as
 - S&P Green Bond Select Index
 - Bloomberg MSCI Barclays Green Bond Index
 - ChinaBond China Green Bond Index
- Actively managed mutual funds
 - Select specific securities within the global green bond market based on fundamental analysis
 - Create financial returns and sustainable outcomes



ESG Equity Investing - Passive

- Mutual funds and ETFs based on ESG indexes, such as by:
 - Geographic Markets



- iSTOXX® North America ESG Select 30 Index
- Dow Jones Sustainability Europe Index
- Company Size



- MSCI USA Small Cap Extended ESG Focus Index
- Industry
 - S&P Global Clean Energy Index
 - S&P Global Water Index



Most major fund families now have ESG funds



Examples: Actively Managed ESG Objectives

 No businesses detrimental to the UN SDGs



- Invest in the highest-rated companies for gender diversity on boards and in executive management
- Low carbon risk
- Companies provide good workplaces for employees



Screen for compliance with religious teachings



Evaluating Funds on ESG Parameters

- A. Look at goals and methods stated in prospectuses of ESG Funds
- B. Composite of company scores within the fund; e.g. Morningstar
 - Morningstar Sustainability Ratings: 1 to 5 Globes
 - Portfolio ESG Score











- Portfolio Controversy Score
- Morningstar Portfolio Carbon Risk Score
- Morningstar Low Carbon Designation



Returns on ESG Investing

 The Forum for Sustainable and Responsible Investment



- "The evidence is clear that sustainable and responsible investors do not have to pay more to align their investments with their values, or to avoid companies with poor environmental, social or governance practices."
- Morningstar



- Examined 25 studies
- No performance penalty due to sustainable investing.

Analysis of ESG and Company Values

- Researchers at Oxford analyzed nearly 200 studies, reports and articles on sustainability and found that at the firm level:
 - Sound sustainability standards lowers companies' cost of capital.
 - Solid ESG practices result in better operational performance.
 - Stock price performance is positively influenced by good sustainability practices.

An ESG Investing Option – Get Local

Community Development Funds

- Federal Funds + Private Sector Capital
- Four types of Community Development Fund Institutions (CDFI):
 - banks,
 - credit unions,
 - loan funds, and
 - venture capital funds
- Invest in Community Development Loan Funds
