

And today, there are serious concerns about the future of bees with colony collapse disorder affecting their survival. Beekeeper and educator Kim Fraser will be the guest speaker to discuss bees, beekeeping and the issues beekeepers face.

Kim Fraser is a native Virginian and public school educator for over 20 years. She has been raising and training a myriad of animals to include dogs, cats, horses, rabbits, guinea pigs, chinchillas, and of course bees for over 40 years. Kim has a background in animal husbandry and a bachelor's degree in biology. She has been involved in beekeeping since 2004 and is one of the founding members of the Rappahannock Beekeepers Association, an affiliation of the Virginia State Beekeepers Association. # Keep the Ban on Uranium Mining Update-Call Gov. McDonnell Now!

In 2012 recognizing that mining uranium would put Virginia's health, heritage, and economy at risk, a powerful coalition made up of over 60 government entities, public health organizations, regional chambers of commerce, small businesses, farmers, doctors, churches, and more than 10,000 citizens (growing to 18,000 in 2013) had taken a firm stance in support of the ban, preventing bills to overturn the ban from gaining traction in the General Assembly in 2013.

The bill did not get out of committee in 2013 but the advocates for lifting the ban have been pushing the governor to begin the process of drafting and promulgating regulations under the Administrative Process Act. But according to the governor's Uranium Working Group Report, it explains that if a bill to lift the moratorium is passed by the legislature and signed into law, "then and only then could the agencies begin the process of drafting and promulgating regulations under the Administrative Process Act."

Virginia has no regulations for uranium mining, and, with less than 1% of the state's general fund revenues dedicated to environmental programs, Virginia is ill-prepared to sufficiently oversee the industry.

In the Aug. 13, 2013 Danville Register and Bee, an editorial quotes part of Gov. McDonnell's speech that week. "If it can be mined and milled safely, I think we ought to do it, and if it can't, I think it shouldn't. I've done a lot of reading of the reports, and I think it's more likely than not that it can be done safely. Ultimately, that decision was up to the General Assembly. The study commission felt that it could, but it did not draw the support during the session. It's taken us 32 years just to get to today from the last time it was considered."

The VA Chapter Sierra Club and your local Rappahannock Group encourage individuals who have not done so, to call Gov. McDonnell urging him to honor the will of the people who have spoken through their elected representatives to keep the ban on uranium mining. His phone number is (804) 786-2211.
