IDNR Proposes Further Administrative Rules for Illinois Hydraulic Fracturing Regulatory Act

The Illinois Department of Natural Resources (IDNR), proposed further administrative rules to regulate fracking on Friday, November 15th, to follow up on Governor Quinn passing the Illinois Hydraulic Fracturing Regulatory Act, or Public Act 098-022, last June.

Per Public Act 098-022, registration already opened on Sept. 15, 2013 to those wanting to apply for a permit to drill, although no one registered before IDNR's proposed rules announcement. Applications will not be accepted, and IDNR will not issue permits for hydraulic fracturing, until after public hearings on the new administrative rules, and their approval by the Illinois General Assembly's Joint Committee on Administrative Rules (JCAR).

Public hearings are already scheduled in Chicago on November 26th and Rend Lake on December 3rd (see addresses on Page 2). Various environmental groups are already circulating petitions to ask for more hearings in southern Illinois at a time that is not during the winter holidays. These must be turned in within 14 days of the proposed administrative rule announcement, or November 29th, the day after Thanksgiving, when many offices may be closed.

Per the JCAR rule making process, a 45 day comment period occurs before JCAR approves administrative rules; however IDNR director Marc Miller has publicly stated that this 45 day period will be extended to 50 days, after the New Year's Day holiday. Note, the IDNR website says that public comments will only be accepted through Friday, January 3, 2014. Sometimes the state agency proposing the rules must announce a Second Notice for modified administrative rules after accommodating public hearing and other comments, which then opens another comment period. However, if this happens, we will let you know in another action alert.

Presently, you are encouraged to attend and comment at the hearings and make comments online, although you must follow protocol for commenting, (see websites on Page 2 for further directions). After the Sierra Club has reviewed the proposed (Continued on Page 2)

administrative rules, we will send out an email action alert with suggestions for how to word your comments as they must pertain to specific deficient sections of the administrative rules. If the petitions prompt scheduling of any more hearings, an email action alert will inform you of the location and time. Therefore, read the Public Act 098-022 and the IDNR's proposed administrative rules at the websites indicated below, and prepare to submit your written public comments soon to the Joint Committee during their comment period. **Email Barb McKassan**, babitaji@aol.com, to be placed on her Action Alert email list, or to ask about signing a petition for more hearings. Your action here is important since southern Illinois' input to the making of the regulations appears to be outweighed by people and groups from outside our region, or who are aligned with industry interests.

SHAWNEE GROUP OUTINGS PROGRAM **NEEDS YOU!!!**



Keep the Mississippi River Healthy and Safe

An ill-advised Army Corps of Engineers project, New Madrid Floodway Levee, is threatening the health of the Mississippi River and the nearby communities. The Army Corp wants to build a barrier which would sever the River and its floodplain putting 50,000 acres of quality wetlands and habitat at risk.

This rare, dynamic-river and floodplain connection creates wetlands essential for river fisheries and waterfowl. Even the U.S Fish and Wildlife rates the importance of the existing river and floodplain connection as irreplaceable and opposes the project. Furthermore the levee will increase flood risk in a tri-state area of southern Missouri, Illinois and western Kentucky.

We need your help in stopping this harmful project. Tell the Army_Corps that in order to protect rare quality wetlands and protect nearby communities the New Madrid Floodway Levee must not go forward. Read further information at the websites below. Then use the suggested message header and content below in your letter or email to Joshua Koontz at the US Army Corps of Engineers, personalizing it further.

In your email or letter put the following Message Header: Reject the New Madrid Floodway Project

Message, copy the following unchangeable paragraphs (then add additional personal points):

As a concerned citizen, I ask that you do not go forward with the New Madrid Floodway Project because of its negative effects on vital wetlands and surrounding communities.

According to the U.S. Fish and Wildlife Service, the project "will result in significant losses of regionally and nationally important fish and wildlife resources which cannot be adequately mitigated." The environmental damage is so extensive that the Corps of Engineers cannot possibly replace the fish and wildlife habitat, the wetlands and floodplain areas which would be destroyed or altered by this project.

The project also increases flood risk by closing off a designated floodway. This puts lower lying areas, especially those across the river in Illinois and Kentucky, at risk.

Despite periodic high water in the floodway, agriculture thrives in the area. The Corps admits the levee will only provide additional benefits to existing farmers by enabling more intensive agriculture. This does not begin to outweigh the significant environmental damage and increased flood risk of the project.

Coast Guard Proposes Ohio River Barges to Carry Frack Waste Water - Comment by Nov. 29th

On Wednesday, October 30th, the US Coast Guard issued a proposed policy, "Carriage of Conditionally Permitted Shale Gas Extraction Waste Water in Bulk," wherein the public has 30 days to comment (c.f., http://www.regulations.gov/#!docketDetail;D=USCG-2013-0915). If approved, fracking waste water will be shipped by barge down the Ohio River to be stored, reprocessed or disposed of in Ohio, Texas and Louisiana. The risk of an accident and spill of hazardous materials into the water system that would flow past Paducah, Metropolis, Olmsted, Cairo, and the Cache River Watershed, is at question. The policy indicates that waste water is to first be tested in a state-certified laboratory for radioactivity, pH, bromides and other hazardous materials before shipping, and the barges are to be tested for accumulated radioactivity. Each barge would transport about 10,000 barrels of waste water. Nix 66!

IDOT Corridor 66 development planning continues for a link between Interstate 24 in Paducah, Kentucky and Interstate 55 in Missouri, potentially across southernmost Illinois' Cache River watershed, historical Trail of Tears, and Shawnee National Forest region. As we know, the Cache River watershed is of international importance for its great ecological diversity, while the Trail of Tears has historical cultural symbolism and sites, and the Shawnee wildlife and geology comprise our home. The project boundary includes Paducah (Kentucky), Cairo (Illinois), Cape Girardeau (Missouri), Jonesboro (Illinois), and Vienna (Illinois). All of this could be spliced in two by a large interstate highway, as Citizens for Southernmost Illinois note and petition against.

A Community Advisory Group (CAG) meeting for stakeholders recently occurred Thursday, November 7, 2013 at Shawnee Community College, while the first public meeting occurred on July 24, 2013. Documents for the first summer meeting are available Here. Per plan, data collection was to occur during 2013. From this input, plus engineering and environmental studies, the Project Study Group will develop a formal purpose for the project in 2014, develop and evaluate alternatives in 2015, and then determine the preferred alternative.

The Illinois Department of Transportation (IDOT) and the Federal Highway Administration are the lead agencies for preparation of the environmental studies. The Little Egypt Joint Venture team consisting of partners Horner & Shifrin, Inc. and Bernardin, Lochmueller and Associates, Inc. leads the 66 Corridor (Continued on Page 7)

Study for IDOT. The Little Egypt Joint Venture consultant team is further supported by the following sub-consulting firms: 2IM Group, LLC, ABNA Engineering, Inc., EFK Moen, LLC, Homer L Chastain & Associates, LLC, Kaskaskia Engineering Group, LLC, Parsons Transportation Group, Inc., and Shawnee Survey & Consulting, Inc. Better representation of environmental concerns is at issue, as well as that of further economic diversion or by-pass to Paducah or Cape Girardeau.

The CAG stakeholders will be limited to approximately 30 people. Community members that show interest in the project that are not included in the CAG roster might be added, ensuring they will receive public meeting invitations, newsletters, and project updates. To maintain stakeholder representation, the CAG membership may evolve as the study progresses. The CAG is to provide input on the problem statement, purpose and need, and on the corridors to be studied further. Watch local newspapers, radio and television stations for further announcements. The 66 Corridor Project might hold additional meetings with local organizations and stakeholders if they submit a request using the comment form on their project website.



Protecting Shawnee National Forest involves frequent communication with the Forest Service, research on issues, and educating others about those issues. Pipelines: Flanagan, Eastern Gulf Crude Access Project,...the Likes of Keystone in Illinois.

The Flanagan South Pipeline and repurposing of the Trunkline pipeline are projects about which you may not have heard much, compared to the Keystone Pipeline that is to carry tar-sand oil across the Plains from Canada to Texas. However, Eastern Gulf Crude Access Pipeline Project runs right through the Shawnee, and residents were already contacted by Eastern Gulf Crude Access, LLC to attend a Q&A open house last June 20th in Salem, Illinois. Open Season to solicit shipper commitments began June 5th and closed September 30, 2013. The old Trunkline Gas Company pipeline that runs between Illinois and the Louisiana Gulf is to be repurposed, with a new addition through Wayne, Clay and Marion Counties to Patoka, Illinois, just to the east of Lake Carlyle. The Patoka hub links to the Keystone Pipeline, for transport of crude oil, as will the Flanagan line starting near Chicago and running to Oklahoma, as depicted in the maps above. Enbridge Energy Company, Inc., through its affiliate Enbridge Pipelines (FSP) L.L.C., is constructing the Flanagan pipeline to carry crude from Canada or the Bakken oil fields in the Dakotas. Therefore, residents with easement and eminent domain issues, and other southern Illinoisans concerned with the preservation of the Shawnee National Forest or Cache River wetlands in Massac, Johnson, and Williamson Counties, will want to track the Eastern Gulf project. The Flanagan poses risks to the Mississippi and other land in its region either from its construction or potential spills.

The Federal Energy Regulatory Commission (FERC) regulates practices of oil pipeline companies, service and access conditions of shippers, and petroleum transportation rates. FERC does not have jurisdiction over construction or maintenance of production wells, oil pipelines, refineries, or storage facilities. (Continued on Page 9)

Construction activities are under the authority of the Illinois Commerce Commission (ICC), to which Eastern Gulf must file an application for certificate authority to construct and operate a crude oil pipeline, and to take private property by eminent domain. The Environmental Protection Agency has jurisdiction over oil spills. Safety of oil project operations is regulated, monitored and enforced by the Department of Transportation, Pipeline Hazardous Materials and Safety Administration.

Renewable Portfolio Standard (RPS) Fix

Illinois' Renewable Portfolio Standard (RPS) has been a huge success, and will result in 25% of our power coming from renewable sources by 2025. Implemented in 2007, the RPS has generated more than 20,000 jobs, saved \$177 million in wholesale electricity costs and reduced carbon emissions by 5,481,327 tons.

To keep Illinois' momentum toward clean energy going strong, we need to update the RPS to reflect changing market conditions. We can fix the RPS with a very simple change that makes clean energy targets apply equally to all power suppliers - ComEd, Ameren, and the many competitive suppliers now serving most of our homes and businesses. SB0103 is pending, and Illinois legislators can still be contacted to support the bill via letter, email or online petition.

SB0103: "Amends the Illinois Power Agency Act. Provides that, for periods beginning on and after June 1, 2014, the Agency's procurement plans shall include procurement of renewable energy credits in amounts projected to be sufficient to meet certain renewable energy resources portfolio standards. Requires the Agency to use the Illinois Power Agency Renewable Energy Resources Fund, until depleted, to procure renewable energy credits for specified purposes, and terminates the Fund upon depletion of all its funds. Provides that the Planning and Procurement Bureau shall develop procurement plans and conduct competitive procurement processes for the procurement of renewable energy credits with respect to the kilowatthour usage of delivery services non-eligible retail customers in such electric utilities' service areas. Makes changes with regard to the renewable portfolio standard. Amends the Public (Continued on Page 10)

Utilities Act. Provides that charges for delivery services shall also include the recovery of the electric utility's costs of renewable energy credits and excluded renewable energy resources contract costs. Requires certain electric utilities to procure renewable energy credits with respect to the kilowatthour usage of delivery services non-eligible retail customers in the electric utility's service area. Provides that the obligations of alternative retail electric suppliers and electric utilities operating outside their service territories to procure renewable energy resources, make alternative compliance payments, and file annual reports, and the obligations of the Commission to determine and post alternative compliance payment rates, shall terminate effective May 31, 2014."

Sample letter, following the wording of the alternative online Illinois Chapter Sierra Club petition:

Subject: Update the Renewable Portfolio Standard

Dear [State Senator or State Representative],

I urge you to take action this fall to update Illinois Renewable Portfolio Standard, to keep Illinois on track to a clean energy future.

In 2007, Illinois established a goal to procure 25% of our power from renewable sources by 2025. Since the RPS was implemented, we have generated more than 20,000 jobs, saved \$177 million in wholesale electricity costs and made the air we breathe cleaner.

Two important changes are needed to keep moving forward with clean energy in Illinois. Please support legislation that would:

- Update the RPS to reflect today's competitive power market, to incentivize all power suppliers to invest in Illinois.
- Allow the Illinois Power Agency to finally invest Renewable Energy Resource Fund dollars in Illinois projects. Suppliers have been paying into the fund for years, and it's time to spend those dollars on projects that will benefit our communities.

I urge you to support any proposal that would make these important updates. Let's continue to create jobs, save consumers money and make the air we breathe cleaner.


