**Solarize: Community-Based Solar Bulk-Buys**

The EPA's <u>Clean Power Plan</u> prompts a transition to renewable energy, although mitigating upfront cost to homeowners, businesses, municipalities and power suppliers pulls one into the complex choices of incentives. Community bulk buy projects are one type of incentive, with project models that predate the Clean Power Plan, including those in <u>Portland</u>, Seattle, Boston and Chicago. Recent examples include Champaign-Urbana, Bloomington, and small towns like Godfrey, IL.

During 2009 to 2011, Portland, Oregon's community-based Solarize Southeast and subsequent Solarize Portland projects set a precedent for renewable energy projects utilizing community bulk buy discounts for supplies and less contractor marketing cost, in addition to grants, tax credits, and net metering. Market price was reduced 30%, while green jobs increased. What then was an \$18,000 to \$27,000 3 kw system became \$2,000 to \$3,000 after subtracting all incentives, although some of this was realized in tax credits such that upfront cost was in the middle. A succession of neighborhood solarize projects followed, each with slightly different foci (e.g., local jobs, lower price, best value); however, the common elements included competitive contractor(s)/partnership bid, community-led outreach/education, and limited time offer. The limited time offer prompted additional solar installations by contractors not selected by the project, decreasing the issue of favoritism. Going into the project as a group sped up the process since the decision-making steps were done by the project as a whole versus each and every buyer. The buyer is guided through a process of awareness, education, enrollment, site assessment, decision, and installation in about 3 to 6 months. Partners in the projects included a trusted local nonprofit, a technical advisor (provides template for project design and RFP for contractors, helps evaluate bidders with project organizer), a project organizer (e.g., city), and a solar industry organization. Some of the neighborhood projects' RFP's and MOU's specified use of local or small business contractors, apprentices from local training programs, and locally manufactured supplies (defined as from within the state, region or United States).

Soon after, in 2011 and 2012, Northwest Sustainable Energy for Economic Development (Northwest SEED) began a similar neighborhood solar program in Seattle, Washington, which expanded to additional neighborhoods and parts of the state. Some of these Solarize projects were contractor lead, not including the partnership with a local nonprofit, but offering bulk buy discounts, and often using locally manufactured supplies. Between 2010 and 2012, Vermont Public Interest Research Group formed VPIRG Energy to prompt group solar PV and solar hot water buys. Existing VPIRG members facilitated interest through house parties. Eventually a new SunCommon company was formed that offered solar leasing with no money down. A variety of projects around the country narrow their scope to some of this project's elements.

The 2011 <u>Solarize Mass</u> was a similar pilot project in the greater Boston, Massachusetts area, featuring four "Green Communities," and the project now continues until the present, spreading to western Massachusetts and Cape Cod. Bulk buys lowered pricing tiers in both ownership and leasing options. They realized that pre-made marketing toolkits and the project model should have instead been geared to dynamically meet each community's specific qualities and needs.

Using a federal <u>SunShot</u> grant and bulk buy program in 2011, <u>Solar Chicago</u> offered residential solar installation at about half the cost to city and greater Chicago residents. The RFP selected a couple contractors to do the installations. Subsequently, <u>Chicago attempted</u> to further increase solar installations by improving the permitting process and using Illinois' <u>Solar Renewable Energy Credit</u> (<u>SREC</u>) program for further incentives.

<u>Solar Urbana-Champaign</u> enabled 81 residences and businesses to benefit from a solar bulk buy, a project facilitated between the City of Urbana, <u>Midwest Renewable Energy Association (MREA)</u> and the Environmental Law & Policy Center. MREA provides technical input to communities to help them plan their solar programs and RFPs, providing state <u>specific toolkits</u> to help navigate these procedures and the legal considerations. The project was modeled similar to the Portland example, and also benefited from promotional support from the <u>U.S. Department of Energy SunShot Initiative</u>. A similar <u>Solar Bloomington-Normal</u> project was recently developed after the Urbana-Champaign example. Nearby Bloomington, Indiana also had a recent Solar Bloomington <u>RFP</u> out to contract bidding, not only for residential and business bulk buy installations, but including the municipal City Hall and Police Headquarters buildings as well.

While most of these examples have been in large urban locations, the neighborhood scope of the projects lends well to small towns such as <u>Godfrey</u>, <u>IL</u>, which suggests possibilities for other rural southern Illinois communities. <u>Solarize Godfrey</u> is a partnership of the Godfrey Climate Protection and Energy Efficiency Committee, a solar installer, and <u>Piasa Palisades</u> Group of the Sierra Club (a Sierra Club <u>Cool Cities</u> program example). <u>Godfrey</u>, <u>IL</u> offers its own local cash incentive, one of three Illinois communities to do so, in addition to the bulk-buy discount, 30% federal income tax credits, and <u>Solar Renewable Energy Credit</u> (<u>SREC</u>). While SREC's are generally something obtained through an aggregator that purchases an allotment of the Illinois renewable energy credits, the homeowner or small business might eventually realize about a 20% net reduction of the solar installation cost.

Bulk-buys are variously structured, some offering a fixed rate, descending rate with donation to organization after a set goal, or later rebates based on extent of project enrollees. For those without upfront means to pay, municipal, bank or credit union loans are available for solar installation with liens on the property, some designed to bridge time gap between upfront payment to contractor and later tax credits. Home equity loans are another option. The community bulk-buy projects, as well as solar installers, may offer educational events concerning cash incentives/tax credits/financing, net metering, and installation. Solar ambassadors or champions, who already have solar, may show and discuss their choices to those considering solar.

Shawnee Group Sierra Club has been exploring potential community solar bulk-buy projects for our region.





# Our Water, Our Rights, Our Climate and Native Americans Are Under Attack: ACT NOW TO STOP THE DAKOTA ACCESS PIPELINE!!

The standoff in North Dakota between hundreds of Native American tribes and hundreds of police has been ignored or glossed over by the mainstream media, but is all over the <u>internet</u> because people understand that this is a pivotal moment in the efforts to protect our environment and our rights. <u>Energy Transfer Partners</u>, major banks, and other corporations such as <u>Enbridge</u>, have used their clout to fast track permits to build the Dakota Access Pipeline (DAPL) from the Bakken fracked oil fields through five states from North Dakota to Patoka, Illinois. In North Dakota, the pipeline was re-routed to avoid endangering the land and water of Bismark, ND, and moved downstream to the treaty lands of the <u>Standing Rock Sioux</u> tribe, threatening their water supply and their sacred lands.

<u>Democracy Now</u> and other <u>alternative media</u> sources have filmed and interviewed many of the Native Americans at DAPL, revealing the violence of the police and DAPL security against the peaceful and prayerful water protectors. Vicious dogs, tear gas, mace, rubber bullets, noise machines, bright lights, and low-flying aircraft have been used against the protestors, suppressing their rights of free speech and assembly. Journalists have been threatened and jailed, in efforts to suppress the rights of free speech and free press.

The DAPL would pass through five states, starting at the Bakken fracked oil fields in North Dakota, through central Illinois and ending up at Patoka, Illinois, there to connect to other pipelines leading to refineries in the south. DAPL and ETCO pipelines are described in an earlier June – August 2015 Shawnee Trails newsletter. The protestors' cause is our cause: their water is threatened and our water from the Mississippi River and other rivers are threatened. Everyone is threatened by continued investment in pipelines that carry dirty, climate destroying fossil fuels. We need to be spending our energy, money and efforts investing in renewable energy, energy efficiency and ways to make our environment and communities more resilient to the changing climate.

Pipelines leak and explode all the time, and the Bakken oil is extra volatile. There are 2 serious pipeline incidents or leaks every 3 days, and human incompetence and negligence contribute to the problem. Over one million gallons of tar sands spilled into the Kalamazoo River in Michigan, when workers for that Enbridge pipeline waited over 17 hours to respond to their pipeline rupture. An official <u>Leak Detection Study</u> found that

the average pipeline "has a 57% probability of experiencing a major leak with consequences over the \$1 million dollar range, in a ten year period." (Keifner & Associates study for PHMSA, p. 240)



We must stand with Standing Rock! You can take many actions - please do as much as you can!

- 1. **Call President Obama** at 202-456-1111: Urge him to halt the construction of the Dakota Access Pipeline.
- 2. **Donate to the Legal Defense Fund** of the Native Americans who are putting their bodies on the line to stop construction of the DAPL online at: <<u>sacredstonecamp.org</u> >
- 3. **Write to the Army Corps of Engineers** and urge them to withdraw the "Nationwide 12" permits that were issued hastily and without proper consultation with the affected tribes at the Facebook page they have set up for public comments on the DAPL: <<u>ow.ly/8TtG305RNYH</u>> or call 202-761-8700. Or contact the U.S. ACoE directly: <a href="http://www.usace.army.mil/Contact/">http://www.usace.army.mil/Contact/</a>
- 4. **Sign the petition to the U.S. Dept. of Justice** urging them to step in to stop the militarized assault by the police and the corporate security forces against the people at the Sacred Stone Camp at <aclu.org/standingrockTW>. Or contact the DOJ directly: https://www.justice.gov/crt/contact-office
- 5. **Sign the Sierra Club petition** urging Obama to direct the Army Corps of Engineers to repeal the Nationwide 12 fast-track permit for the DAPL, and to investigate the militaristic police actions against the peaceful protestors: <a href="mailto:addup.org/campaigns">addup.org/campaigns</a>> and click on the Dakota Access Button
- 6. **Call the Whitehouse** at 303-816-3559 and urge Obama to investigate potential rights violations at Sacred Stone Camp and urge him to reject the Dakota Access Pipeline once and for all.
- 7. Share videos and alerts with your friends and relatives on Facebook, Twitter and Email.




# Volunteers Needed to Help Protect the Shawnee National Forest


