# St. Louis Goes for 100% Clean Energy

Climate breakdown is a global problem but it's finding local solutions. The governments in Washington DC and Jefferson City don't care, so city governments are picking up the slack. In 2017 the St. Louis Board of Aldermen resolved to make the city run on 100% clean energy for electricity (wind, solar and efficiency) by 2035. St. Louis is not the only city in the region to pledge to go 100% renewable University Maplewood, and Dellwood are others — but it is the biggest, and it's where the Sierra Club is concentrating its efforts. If you live in one of our innumerable suburbs and would like to get your town moving in direction, we'll support you!

St. Louis plans to have city operations running on clean energy by 2025 and the whole city — all its neighborhoods and businesses — by 2035. That's a tall order, and it will take the cooperation of one of the coal-heaviest utilities in the nation, Ameren Missouri. The key is demand. We demand action and Ameren meets the demand. One big motivator is corporate demand. When companies like AB InBev, Wal-Mart, Amazon, Apple and Google start demanding renewable electricity, utilities can hardly say no. They respond with "green tariff" programs. They provide wind energy and let companies subscribe to it.

Ameren has a green tariff called

Renewable Choice. An offering of 400 megawatts (MW) of new wind, yet to be built, was fully subscribed in no time. Ameren allowed cities as well as companies to subscribe, so St. Louis put in its non-binding expression of interest. The wind farms and contracts will follow. A combination of energy efficiency programs, rooftop solar and green-tariff wind will get government running on clean energy. Jobs and justice are key components of St. Louis' 100% clean energy drive. Wind farms are remote, but efficiency programs and solar panels get right down into our neighborhoods. The fastest growing job in Missouri is solar installer, and equipping buildings with energy-efficient lighting, appliances, and insulation promises even more iobs.

Putting solar panels on your house is great, but not everyone can do it. Your house may not have good solar exposure, or you may be a renter or a condo owner or can't afford the upfront cost. The answer is community solar, installations that serve multiple customers. Where the utility is a monopoly like Ameren, this must be provided by it.

# Remembering Sierra Club leader Jerry Sugarman

This August our area lost a passionate, hard working environmental advocate when Jerry Sugerman passed away. Jerry was a long time Sierra member and defender of rivers. Jerry is best known for his fearless and successful efforts to stop the Meramec Dam, which was already under construction when he and others upped their opposition efforts. A cumulative effort of many volunteers, a Sierra Club lawsuit, and an eventual public referendum in 1978 defeated the dam. Jerry was at the core that effort. Jerry contributed the development of Missouri Sierra Club. As an avid canoeist, hiker and nature lover he added much to the chapter's early outings and public lands program. Jerry flew to San Francisco in December 1971 to deliver the application for the development of a Missouri chapter. Our chapter was then established in 1972. Jerry is survived by his wife, Darlene Davies-Sugerman, who is also a friend to many Sierrans. As you float the Meramec, think of Jerry's dedication. He set an inspiring example for us all.

# A New Start at County Government, A New Chance for Energy Efficiency

Even folks who pay little attention to local government would have found it hard to miss the big changes in St Louis County Government in this year. County Executive Steve Stenger, along with a few of his close associates, pled guilty to various versions of corruption. We now have a new County Executive, Sam Page and several new County Council members. Two of whom, Kelli Dunaway and Rita Heard-Days, we supported in an August special election. These, and other changes, bode well for more efficient and transparent county government. Improving energy efficiency standards in our residential building codes is one item we hope can move forward. Over three years ago, the Sierra Club, and other allies, campaigned for improved St Louis County building codes. The county was then in the process of updating its outdated 2009 codes. But the designated county building committee recommended a fractured set of codes, some of which were actually less efficient. Nationwide, buildings are responsible for 40% of our energy use. This is a huge part of our CO2 liability. Energy efficiency is essential to combating climate change. As mundane as building codes may sound, it is our responsibility to keep those standards high.

A well-attended February 2017 public hearing clearly illustrated public interest in up-to-date energy efficient homes. St Louis County homes should not be second or third rate. With this controversy and the other chaos, confusion and malfeasance afoot in county government at the time, the code change was never voted on by the full County Council.

Now with a new county government landscape, we are optimistic about developing good building code recommendations and a favorable County Council vote. But it still won't be easy. Our code is now 10 years behind. Some of the backward forces in the county are still at play.

# Thanks to all who helped pass CLEAN MO Amendment One, Now Support VOTE 2020

Clean Missouri, Amendment 1, won decisively in Nov 2018. It garnered support of over 60% of voters and over 70% of Missouri counties. Clean Missouri established а process to gerrymandering of state districts, severely limited lobbyist gifts, lengthened the time legislator's retirement and when he or she can become a lobbyist, and it broaden coverage of the sunshine law to state legislators. Thanks to all who supported Clean Missouri, its passage is a huge success.

Unfortunately, this amount of transparency and good government was just too much for some politicians. The 2019 Missouri legislative session included several resolutions and a lot of hot air expended on myths about how Missouri voters were duped in supporting Clean Missouri. Fortunately, no legislation passed in 2019 to directly challenge Clean Missouri. We don't know what 2020 will bring.



To help protect and expand voter's rights further, another initiative petition, called VOTE 2020, has already been submitted to Secretary of State. But, at this writing, controversy over ballot language has resulted in a law suit and delay in signature gathering.

# 100% Clean Energy, Continued

Ameren has dipped its toe into this market with a program to build a 1 MW solar farm near St. Louis Lambert airport. Customers could sign up for blocks of solar electricity up to one-half of their household's average usage. Like green tariff, the it was auickly subscribed, even at a higher price than the usual residential rate. We as individuals need to demand more. If Ameren builds at a larger scale like 10 or 20 MW, they should be able to charge less. There's no excuse for making for renewable pav more electricity in this day and age. Notice that St. Louis' resolution only applies to electricity, not transportation. But what if we make transportation electric? Electric vehicles (EVs) are the trending thing. They have the huge advantage of eliminating the tailpipe pollution that we all breathe every day. Ameren will need no urging here; they're salivating at the thought of this big new market. The trick will be to get them to charge EVs on renewable electricity. We can't settle for less. As you can see, there are many ways to meet the climate challenge and roles for everyone to play — city governments, businesses and citizens. The Sierra Club is a player in this game, and we invite you to pitch in.
