

AG Healey Says No Need for More Pipelines | Take Action on Gas Leaks + Much More!



Message from the Chapter Chair

Dear Members and Supporters,



I am very thankful that we have an attorney general such as Maura Healey. She not only agreed to examine the taken-for-granted assumption of some that Massachusetts needs more gas pipelines, but commissioned a study to look at alternatives to a fracked-gas-soaked future for Massachusetts (more below). Those alternatives include options that are better for our health, our safety, our future place on the planet, and our economy: renewables, energy efficiency and conservation, and demand management.

One cautionary note: As the study assumed that the gas would be used here in Massachusetts, the conclusion was that our prices may go down with expanded pipeline capacity. Since the real purpose of the pipelines is to export fracked gas, our prices will instead go up, as we compete in the world market where prices are much higher. As stated by the US Congressional Research Service: A significant rise in U.S. natural gas exports would likely put upwards pressure on domestic prices. --Cathy Ann Buckley

ACTION: Tell Governor Baker that we do not want to pay for unnecessary, dangerous, toxic, expensive new pipelines.

Attorney General says NO NEED for More Pipelines in Mass



Attorney General Maura Healey's recently released analysis of the energy landscape of the Commonwealth confirmed what we knew - Massachusetts can meet even the "worst case scenario" of energy needs WITHOUT adding any new pipeline infrastructure or increased natural gas capacity. This study accounts for the impending closure of the Pilgrim Nuclear Power Plant and our upcoming departure from dirty coal.

Investments in renewable energy provide local jobs in a clean industry, independence from potentially volatile commodity markets, and improved air quality. The natural gas

industry is dedicating huge resources to promote new pipelines designed for decades of use, and prone to leaks. New pipelines commit us to decades of pollution. Given the urgency of climate change, it is imperative that we develop a long-term energy plan based on facts, not on a disinformation campaign.

ACTION: We do not need new pipeline capacity for Massachusetts. Call your legislators and urge them to oppose any bill that will allow further development of fossil fuel infrastructure.

Solar Bill Stalled



The Massachusetts House recently voted 150-2 for a bill that would limit solar energy growth in Massachusetts. (Thanks to those two - Representatives Provost (D-Somerville) and Hecht (D-Watertown)). Our solar industry is one of the most robust in the country, thanks in large part to the net metering program that allows residential and commercial solar customers to "sell back" their excess energy. That very successful program is almost at its current net metering "cap." When the cap is reached, projects are stalled. Solar means clean energy and also jobs - nearly 15,000 in Mass. alone. The stall in raising the cap has effectively stopped over 100 MW of solar projects, which

translates to over \$350 million in new revenue and over 1,500 new Massachusetts jobs.

House Bill 3854 would raise the cap only minimally (possibly reaching it in a few months), and reduce the rate that producers receive for their excess energy production. This will only further undermine the state's solar industry. A joint committee for negotiation are now working on a final bill to be presented to lawmakers in January.

ACTION: We need to protect community solar, eliminate the cap on net metering, and not reduce net metering credits. Call your legislators and ask them to vote only for a strong solar bill!

Every Gas Leak is a Threat



On November 17th, we joined with our friends fighting to #FixTheLeaks at the State House Joint Legislative Committee hearing on natural gas pipelines. Energy Chair Ed Woll testified with Joel Wool (Clean Water Action), Caitlin Peale (Conservation Law Foundation), and Audrey Schulman (Home Energy Efficiency Team) in support of legislation to protect our wallets, our health and our safety by requiring utilities to fix the state's more than 25,000 natural gas leaks. The Gas Consumer Cost Protection bill, H.2870, bars utilities from passing the cost of leaked gas onto consumers. The Road Repair bill, H.2871, requires repair of all gas leaks when a road opens for construction.

With one of the nation's oldest systems, Massachusetts' cast iron and steel pipes are especially leak prone. They pollute our air with over eight billion cubic feet of natural gas (\$100 million worth) every year. Methane, the main component of natural gas, is 86 times more potent as a greenhouse gas than carbon dioxide. Methane also kills trees, leaks into homes and worsens allergies and asthma.

And we pay for the lost, undelivered gas because gas utilities are legally allowed to recover their costs through rates charged to consumers. The value of this wasted resource can more than pay for the utilities' own cost estimate to repair leaks. That is enough of an economic incentive to fix them now.

ACTION: Utilities must begin fixing all 25,000 gas leaks in Massachusetts immediately. Call your legislators and ask them to vote in support of H.2870 and H.2871!


Enlist Your Local Elected Officials to Shut Down the Gas Leaks



Elected officials of 14 cities and towns, representing 20 percent of the state's voters, have passed resolutions supporting House Bill 2870 and House Bill 2871 seeking to close natural gas leaks throughout Massachusetts. This effort has been led by the Sierra Club, Mothers Out Front, Clean Water Action, HEET, 350MA and others. Please ask your elected officials to pass resolutions to support these bills as citizens have done in Arlington, Bedford, Boston, Brookline, Cambridge, Concord, Framingham, Lexington, Newton, Northampton, Pittsfield, Somerville, Swampscott and Waltham.

Heroes of the Ocean - Leaders in Preventing Plastic Pollution



Massachusetts Sierra Club, together with Women Working for Oceans and the New England Aquarium, honored local residents leading the charge to ban single-use plastic bags, bottles, and polystyrene packaging across the Commonwealth. Recognition was given to 21 towns that have passed 27 separate plastic packaging bans. There are 16 bans on plastic bags covering 7 percent of the state's population. The remaining bans: eight for polystyrene, two for bottled water, and one on non-biodegradable packaging (includes both polystyrene and plastic bags).

We are excited at this good progress and will continue to support local communities in passing similar legislation. Towns honored included Amherst, Barnstable, Brookline, Cambridge, Concord, Falmouth, Great Barrington, Harwich, Manchester-by-the-Sea, Marblehead, Nantucket, Newburyport, Newton, Northampton, Pittsfield, Provincetown, Somerville, South Hadley, Truro, Wellfleet, and Williamstown. Local bans also support proposed statewide legislation.

Farewell James McCaffrey



After 25 years with the Sierra Club - the first 22 of them as Massachusetts Chapter Director - James "Jay" McCaffrey is heading toward new adventures. For the last three years, James has served as the Senior Campaign Director for the New England Beyond Coal Campaign, helping to chart a coal-free future for our region.

Working with our partners, James helped Massachusetts get on track to phase out coal by 2017, and at least one former coal site is being repurposed for solar. In New Hampshire, new legislation requires the utility to sell its coal-generating assets,

ultimately leading to retirement, as the two remaining coal plants now have to compete with newer, more economical, and cleaner generating sources.

While serving as our Chapter Director, James spearheaded efforts to protect Massachusetts public lands, expand areas on state-owned lands that are off-limits from timber harvesting, create better public transportation opportunities for all Massachusetts residents, and helped block one of the largest proposed fill of wetlands in the Commonwealth. James also helped lead efforts to increase protections for the endangered Northern Right Whale, and the creation of the strongest biomass regulations in the nation to help ensure that New England's forests and habitats are not devastated and burned to create energy.

James has been an invaluable asset to our work protecting that which does not have a voice. We will miss Jay greatly and wish him the very best in his future endeavors!
