A BILL FOR

- 1 An Act providing for a healthy soils and watersheds initiative,
- 2 and including effective date provisions.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 161A.3, Code 2020, is amended by adding
- 2 the following new subsections:
- 3 NEW SUBSECTION. 9A. "Healthy soils practice" means the same
- 4 as defined in section 161H.1.
- 5 NEW SUBSECTION. 12A. "Soil health" means the same as
- 6 defined in section 161H.1.
- 7 NEW SUBSECTION. 12B. "Soil health assessment" means the
- 8 same as defined in section 161H.1.
- 9 NEW SUBSECTION. 15. "Watershed health" means the same as
- 10 defined in section 161H.1.
- 11 Sec. 2. Section 161A.4, subsection 2, paragraph q, Code
- 12 2020, is amended to read as follows:
- 13 g. To assist each soil and water conservation district in
- 14 developing a district soil and water resource conservation plan
- 15 as provided under section 161A.7. The plan shall be developed
- 16 according to rules adopted by the division to preserve and
- 17 protect the public interest in the soil and water resources
- 18 of this state for future generations and for this purpose to
- 19 encourage, promote, facilitate, and where such public interest
- 20 requires, to mandate the conservation and proper control of
- 21 and use of the soil and water resources of this state, by
- 22 measures including but not limited to the control of floods,
- 23 the control of erosion by water or by wind, the improvement of
- 24 soil health and quantity of healthy soil, the improvement of
- 25 watershed health, the preservation of the quality of water for
- 26 its optimum use for agricultural, irrigation, recreational,
- 27 industrial, and domestic purposes, all of which shall be
- 28 presumed to be conducive to the public health, convenience, and
- 29 welfare, both present and future.
- 30 Sec. 3. Section 161A.4, subsection 2, Code 2020, is amended
- 31 by adding the following new paragraph:
- 32 NEW PARAGRAPH. j. To assist landowners or occupiers of land
- 33 in developing soil health assessments.
- 34 Sec. 4. Section 161A.4, subsection 4, paragraph a,
- 35 subparagraph (1), Code 2020, is amended to read as follows:

- 1 (1) Six of the members shall be persons engaged in actual 2 farming operations, one of whom at least two of whom shall have 3 experience using healthy soils practices. One of the members 4 shall be a resident of each of six geographic regions in the 5 state, including northwest, southwest, north central, south 6 central, northeast, and southeast Iowa, and no more than one of 7 whom shall be a resident of any one county. The boundaries of 8 the geographic regions shall be established by rule. Sec. 5. Section 161A.7, subsection 1, paragraphs f, h, and 10 m, Code 2020, are amended to read as follows: To make available on such terms as it shall prescribe, 12 to landowners or occupiers within the district, agricultural 13 and engineering machinery and equipment, fertilizer, lime, and 14 such other material or equipment as will assist such landowners 15 or occupiers to carry on operations upon their lands for the 16 conservation of soil resources and for; the improvement of soil 17 health and quantity of healthy soil; the prevention and control

 26 performances, and avoidances which are necessary or desirable
 27 for the effectuation of such plans, including the specification
 28 of engineering operations, methods of cultivation, the
 29 growing of vegetation, cropping programs, tillage practices,
 30 and changes in use of land; and to publish such plans and
 31 information and bring them to the attention of owners and
 32 occupiers of lands within the district.

- 8 2020, are amended to read as follows:
- 9 (a) Assessing the condition of soil and surface water in
- 10 the district, including an evaluation of the type, amount, and
- 11 quality of soil and water,; soil health; watershed health; the
- 12 threat of soil erosion and erosion, floodwater, and sediment
- 13 damages,; and necessary preventative, and control measures.
- 14 (b) Developing methods to maintain or improve soil health
- 15 and water condition watershed health.
- 16 Sec. 7. Section 161A.42, subsection 9, paragraph b, Code
- 17 2020, is amended to read as follows:
- 18 b. "Temporary soil and water conservation practices" means
- 19 planting of annual or biennial crops, use of strip-cropping,
- 20 cover-cropping, contour planting, or minimum or mulch or
- 21 no tillage, healthy soils practices, and any agriculture,
- 22 silviculture, aquaculture, permaculture, or other cultural
- 23 practices approved by the committee.
- Sec. 8. Section 161A.53, Code 2020, is amended to read as
- 25 follows:
- 26 161A.53 Cooperation with other agencies.
- 27 Soil and water conservation districts may enter into
- 28 agreements with the federal government or an agency of the
- 29 federal government, as provided by state law, or with the state
- 30 of Iowa or an agency of the state, any other soil and water
- 31 conservation district, or any other political subdivision of
- 32 this state, for cooperation in preventing, controlling, or
- 33 attempting to prevent or control soil erosion, or improving or
- 34 attempting to improve soil health or performing soil health
- 35 assessments. Soil and water conservation districts may accept,

- 1 as provided by state law, money disbursed for soil erosion
- 2 control, soil health improvement, or soil health assessment
- 3 purposes by the federal government or an agency of the federal
- 4 government, and expend the money for the purposes for which it
- 5 was received.
- 6 Sec. 9. NEW SECTION. 161H.1 Definitions.
- 7 l. "Department" means the department of agriculture and land 8 stewardship.
- 9 2. "Division" means the division of soil conservation and 10 water quality created within the department pursuant to section 11 159.5.
- 12 3. "Fund" means the healthy soils and watersheds initiative 13 fund created pursuant to section 161H.2.
- 4. "Healthy soils practice" means an agricultural practice
- 15 that improves the health of soil, including but not limited to
- 16 consideration of depth of topsoil horizons, water infiltration
- 17 rate, water holding capacity, organic matter content, nutrient
- 18 content, bulk density, biological activity, biological and
- 19 microbiological diversity, and minimizing of bare ground.
- 20 5. "Initiative" means the healthy soils and watersheds
- 21 initiative created in section 161H.3.
- 22 6. "Soil health" means the overall composition and fertility
- 23 of soil, including the amount of organic matter in and
- 24 water-holding capacity of the soil; and the continued capacity
- 25 of soil to function as a vital living ecosystem that sustains
- 26 plants, animals, and humans, and that supports the production
- 27 of diverse food, fiber, and other agricultural crops.
- 7. "Soil health assessment" means a suite of soil-health
- 29 indicator measures, including but not limited to soil organic
- 30 matter, soil structure, infiltration and bulk density, water
- 31 holding capacity, microbial biomass, and soil respiration.
- 32 8. "Watershed health" means the continued capacity of
- 33 surface water and groundwater sources to function as a vital
- 34 living ecosystem that is resilient to drought and storm events
- 35 and that sustains plants, animals, and humans.

- 1 Sec. 10. <u>NEW SECTION</u>. **161H.2** Healthy soils and watersheds 2 initiative fund.
- 3 1. A healthy soils and watersheds initiative fund is created
- 4 in the state treasury under the control of the department.
- 5 2. The fund is composed of moneys appropriated by the
- 6 general assembly to the fund and moneys available to and
- 7 obtained or accepted by the department from the United States,
- 8 the state, or any other source for placement in the fund.
- 9 3. Moneys in the fund are appropriated to the division
- 10 and shall be used exclusively by the division to support the
- 11 healthy soils and watersheds initiative created in section
- 12 161H.3, and shall not require further special authorization by
- 13 the general assembly.
- 14 4. a. The moneys in the fund are not subject to
- 15 section 8.33 and shall not be transferred, used, obligated,
- 16 appropriated, or otherwise encumbered except as provided in
- 17 this section.
- 18 b. Notwithstanding section 12C.7, subsection 2, interest or
- 19 earnings on moneys in the fund shall be credited to the fund.
- 20 Sec. 11. NEW SECTION. 161H.3 Healthy soils and watersheds
- 21 initiative.
- 22 l. A healthy soils and watersheds initiative is created in
- 23 the department to be administered by the division.
- 24 2. The initiative is a voluntary program to assist in
- 25 furthering the purposes of preserving, optimizing, and
- 26 improving soil health, watershed health, biodiversity, and
- 27 wildlife habitat in the state.
- 28 3. The division shall administer the initiative to
- 29 the extent that funding is available. The division shall
- 30 administer the initiative in consultation and coordination
- 31 with the department of natural resources and soil and water
- 32 conservation districts.
- 33 4. In administering the initiative, the division shall
- 34 support activities that enhance soil health and watershed
- 35 health by doing any of the following:

- 1 a. (1) Controlling soil erosion and sedimentation,
- 2 including by keeping soil covered or minimizing soil
- 3 disturbance and external inputs. The division shall support
- 4 conservation tillage or no-till, cover-cropping, planned
- 5 grazing, integrated crop-livestock systems, integrated pest
- 6 management, nutrient best management practices, and those
- 7 practices described in the most recent field office technical
- 8 guide published by the United States department of agriculture.
- 9 (2) Increasing the quantity of healthy soils.
- 10 (3) Maximizing the presence of living roots.
- 11 b. Improving water quality and reliable water availability,
- 12 including by supporting activities that do any of the
- 13 following:
- 14 (1) Manage nitrogen and phosphorus applied to fields
- 15 to minimize nutrient runoff and reduce downstream nutrient
- 16 loading.
- 17 (2) Avoid, control, and trap nutrient runoff, while
- 18 maintaining agricultural productivity.
- 19 (3) Manage water runoff and drainage water for improved
- 20 local and downstream water quality.
- 21 (4) Improve water infiltration rates and water holding
- 22 capacities of soils for improved stormwater management and
- 23 flood control, drought resilience, and groundwater supply.
- 24 c. Integrating animals into land and water management,
- 25 including for use by grazing animals, birds, beneficial
- 26 insects, or keystone species such as earthworms.
- 27 5. The division shall by rule establish criteria for
- 28 persons to participate in the initiative. A participant may
- 29 include any person determined by the division who will further
- 30 the purposes of the initiative as described in subsection 2,
- 31 including but not limited to any of the following:
- 32 a. A person holding a legal or equitable interest in land
- 33 that is used for farming, regardless of whether the land is
- 34 located within a city.
- 35 b. An entity structured and operated on a cooperative

- 1 basis pursuant to 26 U.S.C. §1381(a), if the entity meets the
- 2 definitional requirements of a cooperative association as
- 3 provided in 12 U.S.C. §1141j(a) or an association as provided
- 4 in 7 U.S.C. §291.
- 5 6. The division may support an activity by providing
- 6 financial incentives in the form of a grant, loan, or on a
- 7 cost-share basis.
- 8 7. The initiative may be used to establish soil and water
- 9 conservation practices as provided in chapter 161A, the
- 10 development of soil health assessments, and efforts to further
- 11 the education, training, employment, income, productivity, or
- 12 retention of persons working or aspiring to work in occupations
- 13 associated with healthy soils practices.
- 14 8. In awarding financial incentives, the division shall
- 15 provide a preference to an individual belonging to a socially
- 16 disadvantaged farmer or rancher as defined in 7 U.S.C.
- 17 §2279(a).
- 18 Sec. 12. NEW SECTION. 161H.4 Report.
- 19 By January 10 of each year, the division shall prepare
- 20 and submit a report to the governor and general assembly
- 21 regarding receipts and expenditures of the fund. The report
- 22 shall include information regarding the initiative, including
- 23 demonstrated progress in furthering its purposes.
- 24 Sec. 13. EFFECTIVE DATE. This Act, being deemed of
- 25 immediate importance, takes effect upon enactment.
- 26 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 29 This bill creates a healthy soils and watersheds initiative
- 30 (initiative) administered by the division of soil conservation
- 31 and water quality (division) created within the department
- 32 of agriculture and land stewardship. The purposes of the
- 33 initiative include preserving, optimizing, and improving soil
- 34 health, watershed health, biodiversity, and wildlife habitat.
- 35 Soil health refers to the overall composition of soil, its

- 1 water-holding capacity, and its capacity to function as a vital
- 2 living ecosystem. Watershed health refers to the capacity of
- 3 surface water and groundwater sources to function as a vital
- 4 living ecosystem.
- 5 The division is required, to the extent that funding is
- 6 available, to support measures that further the purposes of
- 7 the initiative, including controlling soil erosion, improving
- 8 water quality and reliable water availability, and integrating
- 9 animals into land and water management practices. The bill
- 10 authorizes the division to support activities by use of
- 11 financial incentives in the form of a grant, loan, or on a
- 12 cost-share basis. Financial incentives may be used to assist
- 13 in the development of soil health assessments, and to further
- 14 efforts of persons interested in occupations associated with
- 15 healthy soils practices. Activities are supported by a healthy
- 16 soils and watersheds initiative fund. The division is required
- 17 to prepare an annual report for submission to the governor and
- 18 general assembly.
- 19 The bill amends a number of provisions in Code chapter 161A,
- 20 providing soil and water conservation practices and erosion
- 21 control practices administered by the division, the state soil
- 22 conservation and water quality committee, and commissioners of
- 23 soil and water conservation districts. The bill requires that
- 24 at least two members of the committee have experience using
- 25 healthy soils practices.
- 26 The bill takes effect upon enactment.
