U.S Senate:



Mark Kelly (i)

Senator Kelly is a strong advocate for action on the climate crisis, environmental justice, and clean air and water. Congressional District 1 Jevin Hodge

Congressional District 4

Grijalva led efforts to protect public lands around Grand Canyon from uranium mining. 2022 Ballot Measure Recommendations

Vote NO on Prop. 128 – Prop. 128 is a proposed constitutional amendment referred to the ballot by the Legislature. If passed, it would mean that if any portion of a ballot measure is found unlawful, the Legislature can change, repeal, defund, etc. the entire measure. This would blow a hole in the Voter Protection Act and allow the Legislature to get around the will of the voters.

Vote NO on Prop. 129 - Prop. 129 is a proposed constitutional amendment referred to the ballot by the Legislature. If passed, it would make it much more difficult to pass a comprehensive ballot measure as it narrows what can be included in them. This would also make it more costly as it would require multiple measures to accomplish reform. Finally, this would give those opposing citizen initiatives another way to kick measures off the ballot for technical reasons.

Vote NO on Prop. 132 - Prop. 132 is a proposed constitutional amendment referred to the ballot by the Legislature. It would require a supermajority of 60% to pass any ballot measure that includes a tax, which would tie the hands of voters relative to advancing any taxes or fees to fund schools, conservation, and other important issues.

Vote YES on Prop. 211 – Prop. 211 is a citizen initiative that would change statutes to require disclosure of the source of larger campaign donations (\$5,000 plus), if the statewide campaign has spent \$50,000 or more or for other campaigns \$25,000 or more. This will bring some much needed sunshine to campaign spending.

Vote NO on Prop. 309 - Prop. 309 is a proposed statutory measure referred to the ballot by the Legislature. It requires mail-in ballot voters to complete an additional affidavit providing an identification number and date of birth. It opens the possibility of linking ballots to individuals and how they vote, violating their privacy. It makes it harder to vote in person. Currently, voters must show a photo ID or two other proofs of identity. Voters would need a valid, unexpired photo ID to receive a ballot. No other proof of identity would be allowed.

October 11: Deadline to register to vote

October 28: Last day to request early ballot

November 8: General Election Day
