RE: Agenda item 7.G. Request Adoption of the Resolution in Support of Environmental Literacy and Sustainability Education and Climate Action

The Sierra Club Loma Prieta Chapter, Silicon Valley Youth Climate Action and co-signed organizations and individuals urge the Santa Clara County Office of Education (SCCOE) Board to adopt this resolution supporting environmental literacy, sustainability education and climate action.

Life on Earth faces the existential threats of declining biodiversity and accelerating climate change. As SCCOE and its other partners act on this resolution, we ask that they ensure that students graduate with an understanding of ecosystems, greenhouse gas reduction strategies, and nature-based resiliency and adaptation efforts.
