2. Natural Places Legislative Advocacy Plans for 2023 Legislative Session starting Jan. 11:

- 30x30 (SC Natural Places Priority bill- Sponsors: Senate Elfreth, House Stein); other priority bills include EMPOWER, Community Solar, Clean Trucks, and Zeo Waste.
 - Protect 30% of Maryland Lands by 2030, 40% by 2040, with \$10M Land Trust Rapid Response Revolving Loan Fund; and possible Green Space Equity Component or may be separate bill, A new Maryland Stewardship Fund (to increase stewardship of current lands facing invasive species and/or climate change issues).
 - Possible work on Forest Conservation Act
- Green Infrastructure
 - Prevent stormwater damage through funding for rain gardens, green roofs, rain barrels, retention ponds, etc.
 - Protect Streams by controlling stormwater where it occurs
- Environmentalist representation on Wildlife Advisory Commission on hunting issues
- Work on unpassed bills from last session.
- Climate Resilience through fixing impervious surfaces in jurisdictions
- Bird-Friendly Sustainable Buildings (working with Safe Skies to reintroduce with friendlier legislators now)
- Incentives for nurseries for native plants and Native Plant Month

- c. Prevent Future Pandemics through Wildlife Trade Restrictions. The changes in balance of power in the US and state legislatures are favorable for environmental justice legislation. As Covid-19 and other zoonotic infections continue to threaten humans and wildlife, scientists predict the next pandemic will occur within a decade. But there's something we can do. Over the past 40 years, most major infectious disease outbreaks, including SARS, Ebola, avian flu and HIV, jumped from wildlife to people. But the problem isn't wildlife. The problem is wildlife trade and exploitation, which create the perfect breeding grounds for pathogen emergence. That's why the Center for Biological Diversity has urged the Biden administration to ban trade in wild birds and mammals, which poses the greatest threat of the emergence of new disease. During this time, our group reviews and considers legislation to support or sometimes oppose. Legislation of interest includes: forest conservation, bills affecting the Chesapeake Bay, pesticide use, health of streams and waterways, bills affecting wildlife, bills promoting urban farming and more.
