

HANNAH FURGUIELE, Chapter Chair, 2023:

We're going to be busy in 2023! The state has a new Carbon Plan and is finalizing its Clean Transportation Plan, and the U.S. Forest Service has released its final management plan for the Pisgah and Nantahala national forests. Other environmental harms and the communities most vulnerable to them - will also, undoubtedly, demand our attention.

Thank you for letting me share this quest with you, and for the opportunity to be your guide. I'm happy to know that, in 2023 and for years to come, Sierrans like you and me will stand in strength and unity to assure that the planet we inhabit is a beautiful, safe place for all living things.

AT THE LEGISLATURE:

Now that the General Assembly is in the thick of its 2023-24 session, we're prepared to champion good environmental bills that protect our air and water, and that advance our state's clean energy goals. We're also on the lookout for bad proposals that would undermine the environmental rule-making process, block local governments from taking their own measures to fight climate change, or use grid security as an excuse to perpetuate our reliance on fossil fuels. We'll also have on our hit list any bills that undermine the state's newly approved carbon planning process or that weaken our ability to regulate toxins, build out new clean transportation infrastructure, or advance social justice. Though we miss our longtime government relations director, Cassie Gavin, who joined the N.C. Sustainable Energy Association this fall, State Director Cynthia Satterfield is working with lobbyist and legislative veteran Laura DeVivo and our allied groups to stay as vigilant as ever.

ON THE FRONT BURNER

One light bulb at a time. One EV at a time. One solar panel, one wind turbine.

It seems as though we're only inching toward the clean energy future that Sierrans dream of - one that will help us clear our air, strengthen our economy, provide for our families, protect our vulnerable neighbors and combat climate change. But we're getting there, with YOUR support! Be sure to keep an eye on our monthly e-newsletter, social media and website for updates on the following issues.

CI FAN TRANSPORTATION PLAN

Chapter and national Club staff have engaged in an extensive stakeholder process and provided independent modeling and analysis on North Carolina's electric vehicle charging infrastructure needs, all to help our state's Department of Transportation (NCDOT) and other agencies develop a Clean Transportation Plan to reduce carbon emissions from vehicles.

HAPPENING NOW: NCDOT released the draft plan and held public information sessions in early March. We've been urging our members to speak out and weigh in online during the public comment period ending March 15 to make sure North Carolina fulfills its promise to become the "Green Roads State." The final plan, mandated under Executive Order 246, will be delivered to Governor Cooper in early April.

N.C. CARBON PLAN

The Sierra Club was deeply involved as regulators and Duke Energy worked out a state Carbon Plan last year. Regrettably, the final plan released in December lacks the urgency needed to address climate change and its disparate impacts on North Carolina's most vulnerable citizens. It also leans too heavily on speculative technologies like small modular nuclear instead of proven renewables and storage. Bottom line: It falls short of targets set by state leaders to reduce carbon dioxide emissions from electricity generation to 70% below 2005 levels by 2030 and achieve "net zero" emissions by 2050.

HAPPENING NOW: We'll continue to push Duke Energy to shift away from dirty fossil fuels, increase investments in proven solar and wind power, and engage impacted communities in their planning. A months-long stakeholder process to update the Carbon Plan will begin anew in September and you can be sure you will hear from us about opportunities to weigh in.

OFFSHORE WIND

We have long fought offshore drilling and supported the development of wind energy off North Carolina's coast, a move that not only will improve our environment, but holds major potential for economic growth and job creation to benefit all North Carolinians.

HAPPENING NOW: As part of the Offshore Wind for North Carolina coalition of business, energy, and environmental advocates, the Chapter will continue working to protect wildlife and ensure environmental justice as two offshore wind energy leases, Carolina Long Bay and Kitty Hawk, are developed.
