
May 19-21 (Fri-Sun): OUTING Mississippi Palisades State Park, Savanna, IL 61704.

16327A **IL Rt. 84** (815-273-2731) Hiking and Walk-In Camping are options.

Two Walk-In, Primitive Campsites (A & B) have been reserved for Friday and Saturday nights. A backcountry Camp C may also still be available. A toilet (within 1000 feet) and water are located between Sites A and B and between Sites B and C. The campsites (via backpack probably most convenient) have a listed maximum of 4 people each and a tenting pad. Each campsite has a Fire Pit. Campers and hikers will be responsible for their own food, water, and snacks. A camp stove can be used to boil water for freeze-dried foods and beverages. Camping for both nights or for either night are options. Park Office, campground access, and North Trails are via the North Park Entrance. The South Park Entrance connects internally and provides access to the rugged South Trails. Hiking and camping logistics will develop after RSVP reservations are received. 15 miles of trails await. Evening gatherings for everyone around one fire pit at the selected campsite may also be organized. (Pack in a camp stool or chair??!)







Another take on the state of newspaper journalism:

A "BRUTAL, **FEARFUL" TIME FOR JOURNALISM**

Ad dollars are drying up and so are newsrooms.

The above headline was in Mother Jones, March – April, 2023. The article pointed out that advertisers brought us local newspapers and TV's; underwrote the alternative weeklies; sent reporters to your local city council meetings or state Capitol; and brought us fat magazines with deeply reported stories. "But, as anyone who's picked up their skinny hometown newspaper lately can tell, that's over. The vast majority of advertising has moved to tech platforms..." "Sure, mattresses and wool sneakers are still keeping podcasts afloat, and sponsored viral content has been good for digital-native publishers like BuzzFeed and Vice. But everyone knows that relying on advertising to pay for the news is ultimately a house of cards. The math just doesn't work.... for investigating reporting --- or simply covering local politics for that matter..." ... "Layoffs in the news business were up 20 percent as of December, with more coming..." Lots of examples were then listed. "Even National Public Radio has announced a near total hiring freeze and paused its internship program because of a downturn in corporate sponsorships."

A reporter, due to politics impacting her truthful reporting, left New York City and took a job in Alaska offered to her by a former boss. The local <u>Dubuque Telegraph Herald</u> carries an Agribusiness column, "Farm and Food" by Alan Guebert. (farmandfood.com) His column appears regularly each Sunday on page 10, Section C, it seems. The Iowa Chapter of the Sierra Club had Alan as the featured speaker at a recent Annual Meeting. He speaks the truth! An example was his column on February 19, 2023. (How many people, one wonders, sees his journalism that appears weekly in dozens of publications.) This column took on Iowa's U.S. Senator, Joni Ernst.

The headline read, "Biggest foreign owner of 'ag land' in U.S. not who you might think."



Guebert farm and Food column (Continued).

After downplaying Ernst's Chinese invasion "hysteria," Guebert pointed out after other detail that "... five of America's strongest allies --- Canada, Italy, the United Kingdom, Germany and the Netherlands --- own 62%, or 62 times more than China, of all foreign-owned U.S. 'ag land." Texas, Maine and Colorado are the states with the largest amounts of foreign owned "ag land." And, it is called "ag land", NOT "farm land" because "Foreign owners seem twice as interested in the natural resources already on the land – principally timber and pasture – than any potential crop, like corn or soybeans." Guebert concluded with:


