Community Forum November 10

On Thursday November 10 Anderson Marsh Interpretive Association board member Henry Bornstein will join us to provide a progress report on the reforestation program underway at the Park. A collaboration between State Parks, the City of Clearlake, and AMIA, the project will result in 100 or more native Valley Oak (*Quercus lobata*) saplings being planted and cared for until established. The oak restoration project is financed by fees paid to the City of Clearlake under its Native Tree Protection Ordinance, which requires developers who cut down native oaks either to replant trees of the same species or pay a fee to fund replanting elsewhere.

Although the meeting is free and open to the public as always, registration is required: everyone who signs up will receive confirmation and Zoom connection details, and a followup email a day or so before the event. Breaking news on Molok Luyuk

On October 17 Congressman John Garamendi and Senator Alex Padilla asked President Biden to use his authority under the Antiquities Act to add the land now known as "Walker Ridge" to the adjacent Berryessa Snow Mountain National Monument and to rename the area Molok Luyuk, meaning "Condor Ridge" in the Patwin language.

"The sacred lands within and around the Berryessa Snow Mountain National Monument are central to thousands of years of indigenous origin stories," said Senator Padilla. "... It is our duty to protect the abundant natural resources and the rich history of Molok Luyuk for today's children and for future generations."

Members of the Molok Luyuk coalition expanded on the reasons why protecting this area is so important: "Many of the plant and animal species within Molok Luvuk traditionally important to the lifeways of the Patwin people, and we consider their protection and stewardship to be part of our sacred responsibility to the land," said the Yocha Dehe Wintun Nation Tribal Council. Molok Luyuk "was home to California Condors as well as Bald Eagles, Golden Eagles, and Peregrine Falcons, and provides wildlife corridors and vital habitat for other culturally important species. The recent reintroduction of the California Condor to the north of Molok Luyuk gives hope that condors will once again soar (con't)
