Among the sources of revenue for the state treasury: Income taxes Corporate taxes Sin taxes (Tobacco taxes, booze taxes, gambling taxes) Sales taxes Fees of all shapes and sizes Criminal penalties Federal money Lawsuit settlements Inheritance taxes Use taxes Insurance premium taxes Property taxes

#### Iowa Government Positions Responsible for Handling Public Money

The following state and local government positions are responsible for depositing public money in banking institutions:

- 1. treasurer of state
- 2. county officer, including county treasurer
- 3. county public hospital officer
- 4. merged area hospital officer
- 5. memorial hospital treasurer
- 6. city treasurer
- 7. other city financial officer
- 8. school treasurer
- 9. school secretary
- 10. township clerk
