Community Choice Aggregation By Sam Lambert

Community Choice Aggregation is a program that allows municipalities to purchase electricity in bulk on behalf of residents and businesses within their community. Many municipalities will take this opportunity to purchase a larger stake of renewable energy, thus decreasing their reliance on fossil fuel powered electricity and providing a stable price point for consumers.

The process to implement a Community Choice Aggregation plan has several steps, each with their own challenges. However, the <u>Department of Public Utilities will be</u> accepting comments on a proposed expedited review process through October 6, 2023.

Electric Buses & Fleet

If you want to improve the health of students, lower pollution, and upgrade old school buses, the Federal and State Governments have large amount of grant funding available to municipalities.



There is over \$5 billion dollars allocated to replacing old diesel school buses with newer clean technologies through Federal programs: Clean School Bus Program (CSB) and Diesel Emissions Reduction ACT (DERA). These include fully electric buses, engine retrofits, and new more efficient diesel buses! There is also money

allocated by the MassCEC State Accelerating Clean Transportation School Bus program (ACTBUS) to provide technical planning and deployment support.

- Funding is open for DERA! The application is due December 1st, but get started now as the application may take some time. Manage your grant application and gather further information here.
- Funding is closed for ACT and CSB, but you can create grant accounts with the various organizations and prepare to apply when funding reopens.

There are also number of financial resources available for the purchase of electric vehicles or to build charging stations through MassEVIP and MOR-EV. There are no deadlines and the applications are online!

Stretch Code & Fossil Free Buildings

As part of targeting net zero emissions by 2050, Massachusetts is offering options to promote sustainability in the building sector. These programs will benefit the environment, lower construction costs, reduce utility bills, and eliminate dangerous household pollutants.

Massachusetts is currently offering three building energy codes: the Base Code, the Stretch Code, and the Specialized Code. **The Specialized Code** is a municipal opt-in code that ensures new construction and major renovations are consistent with achieving net-zero emissions by 2050. This code can be adopted by any cities and towns in Massachusetts through a vote, either by a city council or at a Town Meeting.

Additionally, the **Municipal Fossil Fuel Free Building Demonstration Program**, a program that promotes the construction of green buildings, allows a select number of municipalities to ban fossil fuels in new construction and major renovations.

Bill H.3227, under consideration this year, would allow any interested communities to participate in the program, allowing for more equitable access to the health, economic, and sustainability benefits associated with green buildings. **Community support for H.3227 will therefore help promote a better future for both our planet and our local communities.**
