

Adventure Coast Outing
Oct. 25 to Janet Butterfield Brooks WPA



Explore a hidden gem with Adventure Coast Group's Outings Leader Eugene Kelly on Wednesday, October 25th. The Janet Butterfield Brooks Wildlife and Environmental Area (WEA) is owned and managed by the Florida Fish and Wildlife Conservation Commission (FWC) and is only opened for public visitation by prior arrangement, so this is a rare opportunity. The outing will be co-led by Hana Brinkley, our host from FWC.

Gene will introduce you to the mosaic of upland habitats present on the 319-acre property. Special emphasis will be placed on the 118 acres of "sandhill" habitat, which is distinguished by a canopy of mature longleaf pines and an extremely diverse groundcover. October is the best time of the year to observe sandhill's annual explosion of wildflowers. FWC's management of the property includes regular applications of prescribed fire, and the most recent "burn" is expected to generate an especially spectacular display of wildflowers this fall. Other habitats we will encounter include pine flatwoods and hardwood hammocks. Collectively, these habitat areas support populations of gopher tortoise, fox squirrels, kestrels, and many other species. Bring your binocular to better enjoy the many migratory bird species that could be present during our visit.

The outing will consist of a hike that is moderate in length and difficulty, covering about 2 miles of mostly sandy and uneven trail. Wear appropriate footwear, and be sure to bring a water bottle and and snacks. Reservations are required and will be limited to 20 participants. We will start the outing at 9:00 am, so please plan to arrive 10 or 15 minutes early for "sign in" and to receive an overview about "JBB". The outing will conclude by noon.

There is no street address for JBB, so we suggest using the address for the private residence located immediately across the street from the entrance gate (15478 Baily Hill Road, Brooksville, FL) to find the location, which is approximately 0.3 miles west of Citrus Way on Baily Hill Road.

Weekiwachee Preserve: Sierra Club Adventure Coast appeals to SWFWMD Governing Board



After extensive local involvement and stakeholder input to both Hernando County and the Southwest Florida Water Management District (District) local staff, and after careful deliberation, on September 19th, Sierra Club Adventure Coast Group reached out to the Governing Board of the District regarding Hernando County's proposal to lease and develop a 350-acre parcel of land within the Weekiwachee Preserve.

The current negotiations appear to pre-ordain an eventual sale of the 350 acres to the county as "surplus" so their plan to develop an artificial beach and swimming area can move forward. The legal authority to designate the land as "surplus" rests with the Governing Board and requires a determination that the lands "are no longer needed for conservation purposes." We believe the high conservation value of this land precludes such a determination, and that its value for conservation has only increased after 25+ years of quality management by the District. The Adventure Coast Group strongly opposes any plan that would eventually open the door for the county to purchase the land and then develop an artificial beach and swim area.

FDEP Rule Hearing on Consumptive Use Permits Save our precious springs!



As springs lovers, we know over-pumping is a serious threat to the future of our springs. The water use permitting system should protect our springs from harm. On August 28th over a hundred springs activists from across Central and North Florida stood together in Gainesville to urge the Florida Department of Environmental Protection (FDEP) to follow the law and protect our springs.

A 2016 law directed FDEP to "adopt uniform rules for issuing permits which prevent groundwater withdrawals that are harmful" to Outstanding Florida Springs. But for seven years, FDEP has flagrantly disregarded the law and refused to propose statutory rules to do so despite an FDEP finding that Florida will run out of water by 2040 at current rates of withdrawal.

In 2022, after more than six years of delay, FDEP finally proposed a draft rule. However, it was essentially the same as the rules already adopted for all water bodies in 2014 and was withdrawn after opposition from Florida Springs Council, Sierra Club FL and Senator David Simmons, co-sponsor and author of the 2016 law. Now, FDEP is back with another proposed rule, equally as weak but the Our speakers were clear that the springs need our help now. The hard part is setting limits to the growing need for more water by more developments and agricultural uses. We need conservation strategies and limits set now. Florida Springs Council has proposed a rule that we all support.



Adventure Coast Group speakers included Chair DeeVon Quirolo, member Robin Orlandi, and League of Woman Voter's Natural Resources Chair Maxine Connor. Michael McGrath spoke on behalf of Sierra

Club Florida. Adventure Coast and Florida Sierra Club also submitted written comments. **So did over 850 Springs Advocates** who sent emails through the Florida Springs Council's advocacy system. **Thank you!**

The public comment period closed September 20th. We have left FDEP without a doubt that we will never accept less than what our beloved springs deserve and require. Let's do it again and again until our springs are protected for future generations! Stay tuned for more opportunities to "show up" for your favorite springs, rivers, streams, and coastal waters. Being there makes all the difference!

Wilton Simpson Technical College Native Plants Demonstration Project



The Sierra Club Adventure Coast Group and the Hernando Chapter of the Florida Native Plant Society, in cooperation with the Hernando County School District and Hernando County, are planning the Wilton Simpson Technical College Native Plants Demonstration Project. The goal is to incorporate installation of native plants and educational signage into the landscaping for the new college to be located at the Brooksville Airport on Spring Hill Drive. The land has been cleared and fill brought in to raise it to the 100-year flood level. Hernando County Project Manager Eric Van De Boogaard plans to complete construction by August 2024.

The Hernando Chapter of the Native Plant Society has recommended that the native plants include a mix of tree, shrub and groundcover species to impart a range of colors and textures, and located where the lighting and exposure will be conducive to healthy growth and longevity. The use of perennial species is included to minimize maintenance and maximize plant longevity. They would be clustered to focus and/or replaced with species that support native pollinators and are capable of reseeding. The parking lot islands have not yet been studied, but shade trees whose roots won't compromise the islands are preferred candidates.

Two areas on campus and 16 parking islands in the parking lot are being considered for installation of native plants and signage. We recommend durable outdoor informational signage describing native plants, identifying key species represented and the benefits of landscaping with natives, with a credit line for the partners involved.

The contract for this project on county-owned land will be issued through the county engineering firm of Coastal Engineering. A qualified contractor experienced in native plant landscaping has been recommended, along with professional outdoor signage companies. We want to collaborate on the graphic design and recommend selecting a knowledgeable local graphic designer.

We are honored that this is a priority project for the school district. This demonstration project will result
