Hi all!

The Arizona Legislature is not off to a very good start. This last week they advanced bills to weaken the Douglas Active Management Area (AMA) and allow more groundwater pumping and this coming week, they will be considering a plethora of bills to create loopholes for development relative to assured water supply determinations. Our water laws are already as leaky as an old bucket. Now they want to create more holes in them. Please don't forget to sign in against some of them -- see the information below.


The Governor delivered her State of the State address on Monday to kick off the legislative session. There was limited mention of environmental protection, but she did emphasize water and said she would do something if the Legislature does not act on groundwater issues. The

border rhetoric in the speech was not great. You can watch the speech here.

The Governor also came out with her <u>proposed budget</u> today. We are still reviewing it, but it appears to provide some funding again for the Water Quality Fee Fund to help address water quality issues via the Arizona Department of Environmental Quality, and limited funding for the Water Augmentation Fund, which is good, although we would rather see that zeroed out and have these dollars go to conservation. The budget provides no funding for the State Parks Heritage Fund and the Arizona Trail, unfortunately. There is funding for addressing our state implementation plans on air quality, which is a good thing too. You can review a <u>summary of the executive's budget here</u>.

- SB1010 vehicle mileage; tracking; tax; prohibition (Hoffman: Wadsack, Chaplik, et al) prohibits the state, a city, town, county or political subdivision of the state from considering or establishing any reduction goals or targets for vehicle miles traveled in developing any transportation or land-use planning or selecting transportation or transit projects. This is a repeat of a bill from last year that died in the House. It preempts cities from doing more to clean up the air and reduce climate emissions. **OPPOSE**
- SB1011 general plan; transportation; independent study (Hoffman: Wadsack, Heap, et al) prohibits cities from reducing system capacity for vehicles, meaning they could not take out a lane and provide a bike lane and pedestrian access. It also removes the bicycle element for general plans for larger cities and takes out provisions relating to multi-modal transportation from the growth element of a general plan. **OPPOSE**
- SB1012 transportation system performance; ADOT(Hoffman: Wadsack, Heap, et al) de-emphasizes congestion management and promotes mobility as performance standards and includes specific provisions for how these and other factors are considered. OPPOSE
- SCR1002 prohibit tax; monitoring; vehicle mileage(Hoffman: Kern, Petersen, et al) refers to the ballot a proposed constitutional amendment to prohibit fees based on vehicle miles traveled, an alternative to gas tax or other fees to pay for roads.

House Natural Resources, Energy, and Water Committee at 2:00 PM in House Hearing Room (HHR) 1

- HB2002 power plants; transmission lines; definition (Griffin) excludes switchyards and substations from review by the AZ Power Plant and Transmission Line Siting Committee. This is one of the few entities that considers environmental factors relative to siting. We're concerned that they are adding even more exemptions to siting after exempting some lines in 2023. **OPPOSE**
- HB2003 replacement lines; structures; commission hearings (Griffin) allows utilities to replace structures on a transmission line without pursuing new or amended certificate of environmental compatibility. This could mean replacing a low voltage pole with a much higher one and with significantly more impact. OPPOSE
- HB2004 utilities; electronic filings; corporation commission (Griffin) allows a utility to submit an application for a certificate of environmental compatibility for a power plant, transmission line, etc. in an electronic format. This would save a lot of paper!
 SUPPORT
- HB2017 assured water supply; commingling (Griffin) requires the AZ Department of Water Resources to consider any water a developer brings for an assured water supply. This would allow more development in areas where development is clearly not sustainable. It is effectively creating another loophole. **OPPOSE**
- HB2019 groundwater model; public inspection; challenge (Griffin) requires that groundwater modeling be made available to the public and requires that ADWR

provide a way to challenge it. This is more backlash against ADWR for having the audacity to say there is not enough water to sustain development in certain areas. I believe we will oppose this too.

- HB2028 groundwater model; unpledged storage credits (Griffin) requires ADWR to assume that unpledged long-term storage credits are available for use in a groundwater model and relative to evaluating whether or not there is an assured water supply. This is another way to allow for unsustainable development in areas that really do not have an assured water supply. **OPPOSE**
- HB2029 groundwater model; unpledged effluent (Griffin) requires the ADWR Director to assume, for purposes of groundwater modeling, that unpledged effluent will be used to replace the groundwater demand in the basin. This is similar to the bill above.
 OPPOSE
- <u>HB2056 appropriation; on-farm efficiency fund</u> (Dunn) appropriates \$30 million for this water efficiency program. Unfortunately the program requires that they continue to grow the same crop. We would like to see this be available for those who grow a crop that is less water intensive and for which they reduce their water use. **MONITOR**
- <u>HB2057 appropriation; long-term water augmentation fund</u> (Dunn) appropriates an additional \$143,800,000 to the water augmentation fund, which is for augmentation projects outside Arizona. **OPPOSE**

- Sunset Review of the Arizona Department of Administration
- HB2100 administrative completeness review; licensing (Griffin) includes provisions that deem a license application administratively complete if an agency issues a written notice of deficiencies during the review time frame. Provisions that deem things complete that may not be seem like a bad idea to me. We are still reviewing this.

- SB1005 public monies; ideology training; prohibition(Hoffman: Wadsack, Chaplik, et al) prohibits public entities from requiring or spending public monies on a diversity, equity and inclusion (DEI) program. OPPOSE
- SB1013 government investments; products; fiduciaries; plans (Hoffman: Wadsack, Heap, et al) prohibits the state treasurer from considering any social or environmental factors when investing state dollars. **OPPOSE**
- SB1014 business; discrimination prohibition; social criteria (Hoffman: Wadsack, Chaplik, et al) prohibits a financial institution, insurer or credit reporting agency from considering political affiliation, or social credit, environmental, social, or governmental score or similar values-based or impact criteria in their decisions. This would include not being able to divest from fossil fuels. OPPOSE
