About the time you receive this report, the Chapter will be choosing a new chair, allowing me to balance my role on the executive committee with other responsibilities. Our former Conservation Program Director, Erin Carey, is serving as acting Chapter Director as we seek to fill the position permanently.

Outside our Chapter, much more dramatic shifts are under way. Our planet is changing in alarming ways - 2023 brought a summer of the most extreme weather on record. Wildfires, historic heat, and storms gave us a glimpse of what climate change has in store. In the United States, our politics bring a different kind of heat as we wade into the fray of a divisive, decisive election season – a battle for the future at every level of government.

In the face of all this, there is one essential truth: **Together, North Carolina's Sierrans will always stand as passionate advocates** for protecting our land, air, and water; our families and communities; and the unspoiled natural places so many living things call home.

I know that you, like me, have many important demands on your time. But we can each give something: handing out endorsement cards at polling places, calling or writing to elected leaders, making a donation, leading a hike, and so much more.

We're strongest when we stand together. Please join me with renewed energy as we "explore, enjoy and protect" North Carolina's environment in 2024!

## WE SPEAK TRUTH TO POWER

If you paid attention to our elected leaders and candidates in 2023, you might have had the urge to cover your eyes and ears.

### Don't do that.

We're entering one of the most consequential election years in our collective memory. Sierrans must be informed and engaged to hold our local, state and federal leaders accountable for their words and actions. What they're doing now, and what they plan to do after the election, will have repercussions for our environment and our communities long after their terms are over.

At the N.C. General Assembly, 2023 saw a textbook demonstration of poor leadership and self-service. Power struggles gave way only to the forced passage of bills that imperil our wetlands and communities, fast-track a disastrous pipeline project, block local governments from enacting environmentally sound ordinances, and pose many other threats to our planet and our people.

As a parting shot, legislative leaders dropped another set of gerrymandered state and congressional district maps that seek to further suppress marginalized communities and cement power for those who have demonstrated that they do not deserve it.

At the federal level, Congress also focused on partisan power battles, spending far more time on show-pony investigations, budget brinksmanship, and "bloc" parties to stymie chamber leaders than on passing meaningful laws.



In 2024, we must act. From our towns and cities to our statehouse to the U.S. Capitol, North Carolina's Sierrans can stand with all Club members and allies to elect candidates who pledge to put our people and our planet first - and leave their self-promotional chaos at home.

Our shared voice matters: In 2023 local elections, the N.C. Sierra Club endorsed 34 candidates, all but one of whom won.

This year, let's demand honest answers about what they'll do to stall climate change, protect vulnerable people from polluters, and maintain the health of our air, water and land. Let's loudly and persistently hold them accountable for their actions in the chambers and in the back rooms.

True leaders put aside their egos, personal interests, and biases to govern on behalf of all those they represent. As Sierrans, we and our allies will make sure they do just that in 2024.

# ON THE FRONT BURNER

## NATIONAL FOREST & PUBLIC LANDS PROTECTION

We joined a coalition of conservation groups taking legal steps to push the U.S. Forest Service to fix glaring flaws in the Pisgah-Nantahala national forests management plan. We also supported lobbying efforts to permanently protect 18,000 acres of the Great Craggy Mountains as the Craggy National Scenic Area.

HAPPENING NOW: In December, the USFS proposed amending all of its 128 forest management plans to limit logging in existing old growth areas - something we and allies have been fighting for in North Carolina. We'll continue to work with USFS officials and allies to improve and clarify the proposal. We'll also keep pushing for protection for the Great Craggy Mountains.



## SAYING FAREWELL TO 'FOREVER CHEMICALS'

North Carolina has been a focal point in the fight over toxic "forever chemicals," which Chemours has dumped into the Cape Fear River and spewed into the air from its Fayetteville plant. This fall, nearly 600 Sierra Club members and supporters signed a petition opposing an EPA plan to let Chemours import PFAS waste from Europe to North Carolina for disposal.

HAPPENING NOW: We shared our petition with EPA chief Michael Regan, a North Carolina native who has prioritized the fight against existing and emerging PFAS contamination threats. At the end of November, he reversed the agency's permission for Chemours' plan. The Chapter will continue working with allied groups to develop statewide strategies, and educate the public and each other on PFAS concerns.

### **KEEPING IT WILD**

The Chapter and our allies spoke up on behalf of protecting wildlife on land and offshore. At our urging, more than 2,000 people sent comments opposing the U.S. Fish & Wildlife Service's proposal to use Lake Mattamuskeet, a National Wildlife Refuge in Hyde County, as a testing ground for a bird-toxic algaecide. The Chapter signed on to technical comments urging federal agencies to protect habitat for green sea turtles, and to set tighter standards for oceanic seismic surveys near calving grounds of the critically endangered right whale.

HAPPENING NOW: We await word from USFWS on its final plan for Lake Mattamuskeet. The algaecide testing plan was prompted by a budget allocation from the N.C. General Assembly, which we'll monitor during this year's "short session" for bills that threaten wildlife and the environment. The Chapter has joined a coalition of East Coast groups that seek to protect the right whale, and is working to make sure offshore wind development is as safe for wildlife as it is necessary for our clean energy future.

## CAFOS: FRESH EYES ON A FOUL PROBLEM

Our work to fight hazards from factory-scale animal farms got fresh perspective and energy this year. Four students from UNC-Pembroke and Duke and Shaw universities teamed up to study the social and environmental impact of confined animal feeding operations (CAFOS), including a field trip to eastern N.C. factory hog facilities. The Chapter continued to fight for better protections for people, animals, and the environment, signing onto technical comments on the N.C. Department of Environmental Quality's draft general swine permit, and publicizing public comment opportunities.

HAPPENING NOW: We're monitoring the CAFO general permit process and are ready to push back on weak policy when the final draft is released. Our summer fellows' work will help the Chapter elevate the CAFO issue to a national campaign priority for the Sierra Club. This status would bring more money and staffing to a critical fight that pits corporate greed and corruption against the health and wellbeing of our land, water and people.
