Introduction

Oklahoma's Constitution allows our Legislature to meet every year from noon on the first Monday in February through 5 p.m. on the last Friday of May. And that's almost always what happens, even though legislators never get through all the bills they consider even in that time. The 2026 Legislature, officially the Second Regular Session of the 60th Oklahoma Legislature, will surely be remembered for getting out of town early in record time. While they could have worked until May 29, they were gone and on the campaign trail on May 15.



Needless to say, many important issues, both environmental and otherwise, were left unaddressed since the Legislature has a reputation for procrastination. A last-ditch effort to protect our remaining scenic waterways from dam builders and out-of-state water grabbers (SB 133) was left unconsidered. A measure to promote re-use of abandoned oil and gas wells made it through the House but the Senate left town before they got to it.

Of course they had plenty of time to continue their futile efforts to prop up the fossil fuel industry a little longer. A truly horrible idea to give the industry immunity from accountability for its contributions to the harmful effects of climate change was passed and signed by Gov. Stitt. SB 1439 leaves everyday Oklahomans with no recourse to hold one of our state's largest industries accountable for its actions.

But it wasn't all bad news this year. Legislators took the first tentative steps (some of the first in the country!) to reign in data centers and their impacts to the electrical grid and utility rates (HB 2992) as well as water consumption (SB 259). Also voted down or left behind were measures to greatly extend black bear hunting season (HB 4128) and to establish a state nuclear energy office (HB 3175).

These and other pressing issues are sure to be back in future legislative sessions. And Sierra Club will be back too, advocating and keeping an eye on all the shenanigans. We invite you to join us. Scorecard Methodology

During the 2026 Oklahoma Legislative Session, roughly 500 of the 2,600 new bills made it to the Governor’s desk. 367 of these were signed into law, and legislators overturned four vetos.

Before the start of Session, the Oklahoma Sierra Club Legislative Committee identified roughly 50 high priority environmental bills relating to water, oil & gas, renewable energy, and data centers. From committee votes to floor votes, your response to the Action Alerts put out by the Legislative Committee reminded legislators that Oklahomans care about protecting the land, air, and water in this state.

The 2026 Scorecard is calculated based on Sierra Club priority bills that received a vote on the house or senate floors. Each legislator earned a percentage based on how many of these votes aligned with Sierra Club stances. The following tables show how legislators voted on the priority bills, along with their resulting scores. DNV stands for “did not vote” and indicates a missed vote or abstention. Bills that passed are bolded. Legislator names are in alphabetical order.

Some legislators also received an additional score for their votes in committee. This is represented in the column labeled CS for “committee score”. Committee members earned +1 for every vote aligning with Sierra Club stances and -1 for every vote against these stances. Legislators who did not serve on any of the committees that heard Sierra Club priority bills were not assigned a committee score. Committee votes can be found beginning on page 21.

Priority Bills

HB2976 (Rep. Gise (R) & Sen. Logan (R)) **Stance: Support, Failed**

Requires the Department of Environmental Quality to establish limits for the amount of aluminum allowed in the state's surface waters. Once established, the DEQ must apply the limits to all Oklahoma Pollutant Discharge Elimination System permits where aluminum may be discharged. The permits must establish effluent limits that account for the permittee's conditions, and require permittees to monitor and report aluminum levels to evaluate compliance.

HB2992 (Rep. Boles (R) & Sen. Green (R)) **Stance: Support, Signed into Law**

Data Center Ratepayer Protection Act. Requires governing bodies responsible for reviewing electric supplier rates to ensure that residential, commercial, and industrial are protected from paying unjust rates resulting directly from service to large load customers. Additionally, applicable governing bodies must ensure that all rates are fair, just, and reasonable and that costs and revenues are assigned and allocated among customers using cost causation principles.

HB3173 (Rep. Archer (R) & Sen. Jech (R)) **Stance: Support, Failed**

Creates the Well Repurposing Act. The measure allows the Oklahoma Corporation Commission or the Department of Environmental Quality to authorize the conversion of abandoned wells into wells that support energy storage or geothermal energy development. The measure requires a new written surface damage agreement with the surface owner prior to any well repurposing. The Commission may establish fees and require financial assurance for such conversion. A repurposed well that is actively being used is not considered abandoned. However, any converted well that has ceased storage operations for 12 months must be plugged.

SB259 (Sen. Howard (R) & Rep. Newton (R)) **Stance: Support, Signed into Law**

Updates processes for investigation and enforcement of groundwater misuse by permit holders. Includes added restrictions for data centers facilities seeking groundwater permits such that any data center drawing from groundwater sources must use a closed-loop system that re-circulates water rather than an open-air evaporative system.

SB1280 (Sen. Bergstrom (R) & Rep. Kendrix (R)) **Stance: Support, Signed into Law**

Extends the sunset dates of excise tax rates on oil and gas production and the apportionment of revenues derived there from.

Priority Bills

HB3175 (Rep. Archer (R) & Sen. Dossett (D)) **Stance: Oppose, Failed**

Creates the Advanced Nuclear Energy Office which is responsible for promoting the development of advanced nuclear reactors and identifying financial and regulatory barriers to nuclear generation, among other things. The Office, in coordination with the Oklahoma Corporation Commission, must identify regulations for nuclear energy generation, and submit a report to the Governor and legislative leaders by Dec. 1, 2027.

HB4128 (Rep. Fetgatter (R) & Sen. Kern (R)) **Stance: Oppose, Failed**

Extends the Black Bear Archery Hunting Season from Sept. 15 to Jan. 15 (122 days). Current Black Bear Archery Season is from Oct. 1 through the 3rd Sunday in October. The Oklahoma Department of Wildlife Conservation may, through their rule-making authority, prescribe a yearly total harvest limit for black bears; however, such yearly total harvest limit shall not be set at less than two hundred black bears harvested per year.

SB1439 (Sen. Daniels (R) & Rep. Moore (R)) **Stance: Oppose, Signed into Law**

Creates the Energy Security and Independence Act. The measure prohibits causes of action against producers, manufacturers, fractionators, refiners, storage operators, pipeline operators of fossil fuels when the product functions as designed. Covered civil liability actions relating to climate change and greenhouse gas emissions are prohibited from being brought to any court in the state.

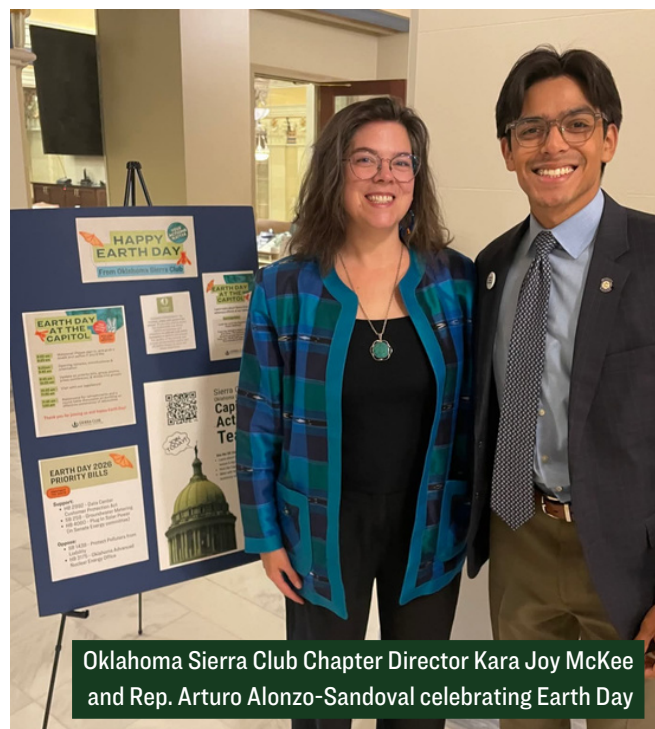
